# Hannah Hullah John Lewis Partnership

Having qualified in 2001, Hannah joined the John Lewis Partnership in 2011 as Head of Legal, Employment, following five years as an employment lawyer at Marks and Spencer plc. In September 2018 she was appointed Director, Legal and is responsible for running a team of 16 lawyers and paralegals across multiple disciplines including company commercial, regulatory, property and employment. The team advises across the breadth of the John Lewis Partnership, including both its trading divisions, Waitrose & Partners and John Lewis & Partners. The Partnership is the UK's largest employee owned business. It's 83,000 Partners own 51 John Lewis shops across the UK, 349 Waitrose supermarkets, an online and catalogue business (www.johnlewis.com), a production unit and a farm. The business has annual gross sales of over £11.5bn.

#### Spiro Noussis Former Joint-CEO Rockcastle

Spiro Noussis is an experienced property professional who has founded, managed and developed commercial real estate businesses for over 15 years. As Chief Executive Officer of Rockcastle Global Real Estate Company Ltd he executed the merger with New Europe Property Investments Plc (NEPI) in July 2017 and the new company, renamed NEPI Rockcastle plc, is now the largest retail landlord in Central and Eastern Europe (CEE) with a portfolio of dominant retail centres exceeding €5bn in value. He was directly responsible for building the direct property business of Rockcastle which included the acquisition/development of retail centres in Poland, Czech Republic and Hungary worth €2bn and establishing the operational headquarters in Warsaw, Poland. Following the merger Spiro became Co-CEO to ensure a smooth handover and remained an Executive Director of the company until the 31 December 2018.





# Liad Barzilai Atrium Real Estate

Mr. Liad Barzilai was appointed Group Chief Executive Officer at Atrium European Real Estate Limited effective February 23, 2017. He served as Group Deputy Chief Executive Officer from December 21, 2016. Until that time he would hold the position of Group Head of Acquisitions at the Company, which he obtained on September 11, 2013, He was promoted as Atrium's Head of Acquisitions in September 2011, since when he has been responsible for the Company's pipeline of potential acquisition opportunities, most recently overseeing the Company's acquisition of Galeria Dominikan' ska, in Poland in June 2013. Liad has a B.A. in Business Economics & Management from Guilford Glazer School of Business & Management, Ben-Gurion University and a MBA from Reccanati Business School, Tel Aviv University.
