

# Highways, roads and bridges

## America

**Sea-to-Sky highway:** Advising the Government of British Columbia to design, build, finance, operate and maintain highway improvement project, drafting project documents, Concession Agreement and legal schedules (approx. CA\$600 million).

# Rail and urban transit

## America

This is the largest and most complex infrastructure project undertaken in Canada in at least fifty years.

When completed, the Green Line will comprise of 28 stations and extend 46 km (29 mi) and will be Calgary's largest infrastructure project to date.

**Santiago Metro:** Advising China Railway Tunnel Group on the contract with Metro (the subway) for the construction of the extension of line 3; and advising them on the tender process for the construction of Line 7 in Chile.

**Metro de Bogotá:** Advising a consortium on the tender process of the Bogota Metro, a US\$4.5 billion project, as well as providing legal advice on multiple aspects of the project concession agreement.

## Europe

**Four new metro lines of the "Grand Paris Express":** Advising Ile de France Mobilités (the French transport authority) on the award of concessions relating to the operation of four new metro lines of the "Grand Paris Express" under an O&M contract. It is the first time that such contracts will be awarded, after a call for tenders ending the public operator's monopoly.

**PPP agreement for railway depot:** Advising Stadler on a 20-year PPP agreement for the design, construction and operation of a maintenance depot for railway vehicles in Sochaczew, including the provision of maintenance services. This is one of the largest PPP projects in Poland.

**The first rail PPP in Kazakhstan:** Advising Almaty City Akimat / EBRD on the design, development, construction, commissioning, financing, operation and maintenance of the infrastructure, rolling stock and services for the Almaty LRT, the first rail PPP in the country.

**Production of Electric Locomotives in Kazakhstan:** Advising Eurasian Development Bank as Kazakhstan, French and English law counsel in relation to the financing of an investment project.

**The biggest urban transport project in Europe:** Advising MTR Corporation (Crossrail) Limited on the £1.4 billion concession to operate Crossrail. This is the biggest urban transport project in Europe and will transform rail transport in London, increasing capacity by 10%, supporting regeneration and cutting journey times across the city.

**Track renewals and maintenance works:** Advising Transport for London (TfL) on its £250m delivery partner contract for its program of track renewals and maintenance works. This framework is a new approach for TfL to its track renewal and maintenance programme.

This is the first Metro Express light rail public transport system currently being constructed and the largest project of that scale ever undertaken in Mauritius.

**Dubai metro:** Advising JT Metro JV, a consortium of international construction contractors, on the construction of civil works on the Dubai Metro, then the first in the Gulf and a flagship project for the Government.

**Gold Coast Rapid Transit (GCRT) project:** Advising Gold Coast City Council on the construction of a new 13 km light rail system in Queensland, a project involving over AU\$900 million of Commonwealth, State and Local Government funding.



**Belgrade's Nikola Tesla Airport:** Advising winning sponsors VINCI Airports on the 25-year PPP concession in respect of Belgrade's Nikola Tesla Airport in Serbia, an investment of €920 million and the largest PPP transaction ever carried out in Serbia (IJGlobal European Airports Deal of the Year 2018, EMEA Finance Best Transport Infrastructure Deal 2019).

**Aeroporto Friuli Venezia Giulia:** Assisting a public company with an "institutionalized PPP" involving the selection of the private investor, the first tender launched in the airport sector in Italy following the new public procurement code, and on the second privatization program.

**Tekirdağ Port, Turkey:** Advising EBRD on investments with respect to the port, following privatization, to finance the acquisition of the operation rights of Port under a 36-year concession from the Turkish Privatization Authority and modernization/expansion of the Port.

**Luton Airport:** Advising on construction and utilities procurement issues related to aspects of its current expansion. The expansion is linked to the new Mass Passenger Transit System (MPTS) connecting the Luton Parkway Rail station and the airport which is being developed by London Luton Airport Limited.

**New Mexico State University Campus Transformation Initiative:** Advising the successful proponent on the structuring and implementation of a concession to plan, manage, operate and maintain the development of NMSU's campus at Las Cruces, New Mexico.

**PPP for schools in Peru:** Advising IFC and the Government of Peru in connection with the structuring and implementation of a public-private partnership for the design, construction, financing and maintenance of up to 41 schools in Lima, Cuzco and elsewhere in Peru.

**Intergenerational center in French Guiana:** Advising Agence Française de Développement on a €12 million financing granted to the SCI Le Toucan 973 for the construction and operation of an intergenerational center in French Guiana. This represents the first project financed in France under the EU's "Juncker Plan".

## Europe

**Four Tuscan hospitals:** Advising Astaldi SpA on the concession for construction and management of four Tuscan hospitals (Massa, Prato, Lucca and Pistoia), the first ever multi-asset PPP ever realized in Italy and the largest PPP acquisition in the health care sector in recent years.

**Dialysis healthcare PPP:** Advising the Government of Kyrgyzstan, KfW Development Bank and IFC on a multi-site dialysis healthcare PPP in Kyrgyzstan to provide dialysis treatments across the country – the first such PPP project in the country.

**Warsaw's National Stadium:** Advising the Ministries of Investment and Development, and Sport and Tourism to develop the common grounds adjacent to Warsaw's National Stadium, the largest PPP project in Poland.

**Saclay University PPP:** Advising on the 29-year, availability-based PPP DBFM contract of the University's Biology-Pharmacy-Chemistry center, including buildings (total area of approximately 85,000 sqm), as well as the construction of outdoor areas, next to Paris. This is the most important PPP concluded by a University in the past decade.

**Turkish Healthcare PPPs:** Advising clinical support services provider on Ankara Bilkent Integrated Health Campus PPP (the largest healthcare complex in Europe, 2015 PFI Awards Turkish Deal of the Year / Project Finance Magazine 2016 Healthcare Deal of the Year) and Mersin Integrated Health Campus PPP projects.

**Sustainable University building:** Advising University Witten/Herdecke, Germany's oldest private university on a DBFO contract to develop Germany's most sustainable University building.

**District Court in Nowy Sącz:** Advising state-owned bank Bank Gospodarstwa Krajowego on Poland's first PPP investment project financing, which involved the design, construction, property management and maintenance services of the head office of the District Court in Nowy Sącz.

**Paris courthouse:** Advising the lenders to the Bouygues-led consortium on a partnership contract for the financing, design, construction and maintenance of the future Paris courthouse, an investment of €750 million. This is the second-largest PPP building construction project in France after the French "Pentagon Project".

**Four hospital PFI/PPP projects:** Advising John Laing Social Infrastructure/Equion on the funding and project documents for four hospital PFI/PPP projects in the UK.

**Norfolk and Norwich Hospital PPP project:** Advising Semperian on its acquisition of 3i Infrastructure's investment in the Norfolk and Norwich Hospital PPP Project.

**100 local sports social centers:** Advising Morocco's Ministry of Youth and Sports in the structuring of a PPP for the financing, implementation, maintenance and operation of more than 100 local sports social centers.


