In 1990, he completed a master's degree in Business Law at the Institute of Business Studies of Montevideo.

By the time Fernando was in his early 30s, he became advisor to Banco Holandes Unido (later ABN AMRO Bank) and ING Bank in Uruguay – where he acted as director for many years. His dedicated services and unconditional commitments to those banks caught the attention of Banco Santander, where Fernando served as legal counsel for more than 30 years. He was subsequently appointed as Executive Director, Vice President, President and Non-Executive Director. In addition to his work for financial institutions, Fernando also advised large multinational corporations across a variety of sectors, providing meaningful counsel, always valued for his natural and uncommon talent, professionalism and dedication.

His distinguished career as a lawyer was complemented by a decade of work in academia including a post as Professor of Public International Law at the Law School of the University of the Republic in Uruguay. Fernando was also a Member of the ICC Court of Arbitration, a member of the ICSID roster of arbitrators - nominated by the Government of Uruguay and continues to serve as counsel and acting arbitrator of the Arbitration Conciliation Centre of the National Chamber of Commerce and Services in Uruguay. Fernando has been ranked as an outstanding lawyer in his areas of practice by the world's leading magazines and directories, year after year.

Fernando Jiménez de Aréchaga is a very respected member of the international law community. He has been invited as speaker to elite Universities such as Harvard (First Symposium of Building the Financial System of the 21st Century, Harvard Law School, 2008) and Yale (Course of Corporate Governance, Yale Business School, 2016).
