Africa rising?

The prevailing narrative about Africa, is one of strong, sustainable growth. Energy is at the heart of this, both from the perspective of generating revenue from oil and gas production, and delivering power to fuel the economies. The Economist's 2013 report, "Africa Rising - A hopeful continent" also captured this narrative. However, recently there has been a counter-swing in the debate – is Africa indeed "rising", or does it remain a continent with unlocked potential that investors have yet to find the keys to open up?

This panel session will look at local perspectives on key issues such as beneficiation, indigenisation, land rights and associated infrastructure developments, and consider how an understanding of these drivers can open up investment opportunities.

### Transatlantic perspectives on energy market reform: challenges and opportunities for investors

A panel discussion on recent developments and emerging trends in EU and US policies to support new generation capacity. As governments and regulators on both sides of the Atlantic struggle to balance competing priorities, investors in EU and US power projects have to navigate a fast-changing landscape of state-sponsored incentives and market rules for new generation capacity. For example, locational capacity markets can incentivise bankable new generation where and when needed and help maintain existing plants when energy market revenues alone are insufficient, but they can also give rise to volatility and boom-bust cycles.
