The scheme has been recognised by Revo, formerly known as the British Council of Shopping Centres, as one of the top-10 town centre partnership regeneration projects in the UK. Construction is due to start in early 2017 with completion of the residential elements expected in summer 2020.

Brendon Walsh, Director of Regeneration, Economic Development and Environment at London Borough of Hounslow, said, "We are delighted that the Secretary of State has accepted our case for site assembly to deliver the High Street Quarter project. This is a crucial scheme for the Council and for the future of the town centre. We have worked hard in partnership with Barratt London and Wilson Bowden Developments to realise the opportunity for a step-change in vibrancy and overall environmental quality.
