IMPLEMENTATION AND LAW

Government Emergency Ordinance ('GEO') no. 202/2008 sets out a general framework for the implementation of international and EU sanctions in Romania. GEO no. 202/2008 provides procedures for granting exceptions to sanctions regimes and ways to challenge the decisions of national authorities on international sanctions (Articles 8-10). It also lists the competent authorities for hearing certain sanctions-related matters and requests (Article 12). Furthermore, GEO no. 202/2008 establishes administrative penalties for violations of international sanctions regimes (Article 26).

While Romania implements UN sanctions, it does not have an autonomous sanctions regime. Accordingly, the sanctions targets list in Romania refers only to the EU and UN lists. There are no other nationally managed sanctions lists.

POWERS AND PROVISIONS

Charged with implementing the various types of sanctions in Romania are those authorities that already hold the respective law-enforcement powers under existing legislation. In particular, the competence to block funds or economic resources held, owned by, or under the control of designated individuals or entities resides with the Ministry of Public Finances of Romania, through its National Tax Administration. The National Tax Administration is also the central authority managing frozen accounts.

Any person wishing to obtain a derogation from the application of any type of international sanctions may, pursuant to GEO no. 202/2008, address such a request in writing to the relevant Romanian competent authority, enclosing all relevant and supporting documents. The competent authority will decide whether to grant the derogation or not upon consultation with the Ministry of Foreign Affairs, which will give its opinion on the consistency of the request with international law.

The Ministry of Foreign Affairs renders and transmits its opinion to the competent authority no later than five working days after receipt of the request from the competent authority. The decision to grant or reject the request for derogation from the application of international sanctions is communicated in writing within 15 days of the receipt of the request.

ENFORCEMENT AND PENALTIES

Breaching sanctions provisions constitutes an offence punishable by a fine of approximately $\in 2,200$ to $\in 6,500$ and the confiscation of property used or resulting from the breach.

If a person belonging to the staff of an authority or public institution committed the breach, in addition to the fine, specific penalties can also be applied.

Enforcement in practice

No public information exists on Romania's enforcement practice.

OUTREACH

Regulatory authorities do not generally conduct outreach on sanctions compliance for potentially affected industry sectors or the public.

POLITICAL FACTORS

No public information is available regarding the political factors in Romania pertaining to sanctions.
