Overview

Anthony Ullman is a partner in Dentons' New York office. - Representation of investor in securities suit alleging, *inter alia*, violation of Sections 10(b) and 29(b) of the Securities Exchange Act.
- Representation of food products manufacturer in ICC arbitration concerning defective design of major equipment.
- Representation of foreign entity in *ad hoc* international arbitration alleging breach of agreement for overseas representation of US franchisor.
- Successfully represented foreign refinery in international arbitration involving claims of breach of contract as well as fraud.
- Representation of Official Committee of Retirees in Detroit bankruptcy.
- Representation of defendants accused of infringing multiple patents in US District Court; obtained summary judgment of non-infringement for majority of products at issue.

- Won the dismissal of claims brought in Minnesota Federal District Court alleging breach of contract, fraud and fraudulent conveyance against an overseas issuer of notes.
- Won summary judgment, subsequently affirmed on appeal, in New Jersey state court on claims alleging breach of contract and tortious interference arising out of an asset acquisition.
- Successfully represented an offshore pipeline construction company in a dispute relating to the construction of a 50-mile pipeline in the Gulf of Mexico.
- Obtained an arbitration award completely in client's favor in a dispute concerning a 20-year operation and maintenance contract for a cogeneration facility.
- Successfully represented a managed care company in a suit challenging the client's change in the method by which it paid its network physicians; won summary judgment, which was affirmed on appeal.
