# Global

---

**Overnight, confirmed coronavirus cases rose to 63,660,757 in 216 countries and territories, with 1,475,691 deaths.**

- The head of the International Federation of Red Cross and Red Crescent Societies warned that a “*pandemic of mistrust*” could hamper **vaccine** administration.
- A new study of autopsies on COVID-19 victims showed that the virus may spread to the brain via the nose, potentially accounting for the virus’ **neurological symptoms**.
- The COVID-19 pandemic has fueled a 40 percent increase in the number of people needing **humanitarian assistance** around the globe, according to the UN.
- The outlook for the **global economy** is improving despite a second wave of coronavirus outbreaks in many countries as vaccines emerge and a Chinese-led recovery takes hold, the OECD reported.

# COVID-19 Vaccine

---

## Moderna will seek emergency regulatory approval from the US FDA and the European Medicines Agency within days.

- Moderna applied for **US emergency authorization** for its COVID-19 vaccine after full results from a late-stage study showed it was 94.1 percent effective with no serious safety concerns. The FDA's advisory committee will meet to discuss the request on December 17.
- Moderna said it was on track to have about **20 million doses** of its vaccine ready to ship in the US by the end of 2020, enough to inoculate 10 million people. Moderna expects its vaccine to be shipped to distribution points across the US by the government's **Operation Warp Speed** program and drug distributor McKesson Corp.
- **Britain's Medicines and Healthcare products Regulatory Agency** is expected to approve the vaccine within two weeks.
- Moderna also said it would seek conditional approval from the **European Medicines Agency** and continue to talk with other regulators doing similar rolling reviews.
- European regulators have pushed back formal assessments of the Pfizer/BioNTech vaccine to December 29, and Moderna vaccine to January 12, delaying **distribution of the vaccines in EU countries** to next year.
- **Germany** aims to have the first vulnerable people and caregivers vaccinated against the coronavirus in January with the Biontech/Pfizer vaccine, distributed at **special vaccination centers** with ultra-cold storage capabilities.

# Markets

---

**World shares edged up to just below record peaks on Tuesday after robust China data boosted expectations of a recovery from the COVID-19 downturn and as drugmakers seek fast approval for their vaccines and authorities look set to keep stimulus support.**

- Riding a wave of vaccine optimism, **US stocks** closed Monday with their biggest monthly gains since April.
- **Bitcoin** surged to a valuation above \$19,000, topping its previous 2017 record. Tesla will join the S&P 500 in a single tranche.
- **Oil** fell slightly after OPEC+ postponed talks to December 3.

# Business

---

## Environmental activists took Royal Dutch Shell to court, demanding the energy firm drastically reduces the production of oil and gas to limit its effects on climate change.

- **Zoom's** revenue rose four-fold in fiscal Q3, and projects solid Q4 revenue.
- **GM** abandoned its plans to take a stake in hydrogen truck startup **Nikola**, prompting shares to fall 27 percent.
- **ExxonMobil** cut spending plans and will write off up to \$20 billion in assets in Q4 as the company continues to review the pandemic's impact on oil markets.
- **Facebook** will buy **Kustomer**, a startup focused on customer-service platforms and valued at \$1 billion.
- **Universal Studios Japan** will open its new "Super Nintendo World" theme park in February after significant delays from the pandemic.
- **JPMorgan** may freeze the salaries of employees with higher titles while increasing pay for traders.
- **De Beers** announced plans to ethically source diamonds and be carbon neutral by 2030.
- **DoorDash** will attempt to double its \$1.4 billion valuation ahead of its IPO.
- **Amazon.com Inc** reported that independent businesses selling on its platform crossed \$4.8 billion in worldwide sales from Black Friday through Cyber Monday, an increase of more than 60 percent from a year earlier.
- The British fashion group **Arcadia** collapsed into administration, threatening 13,000 jobs.
- **Unilever** will trial a four-day workweek in New Zealand.

# Africa

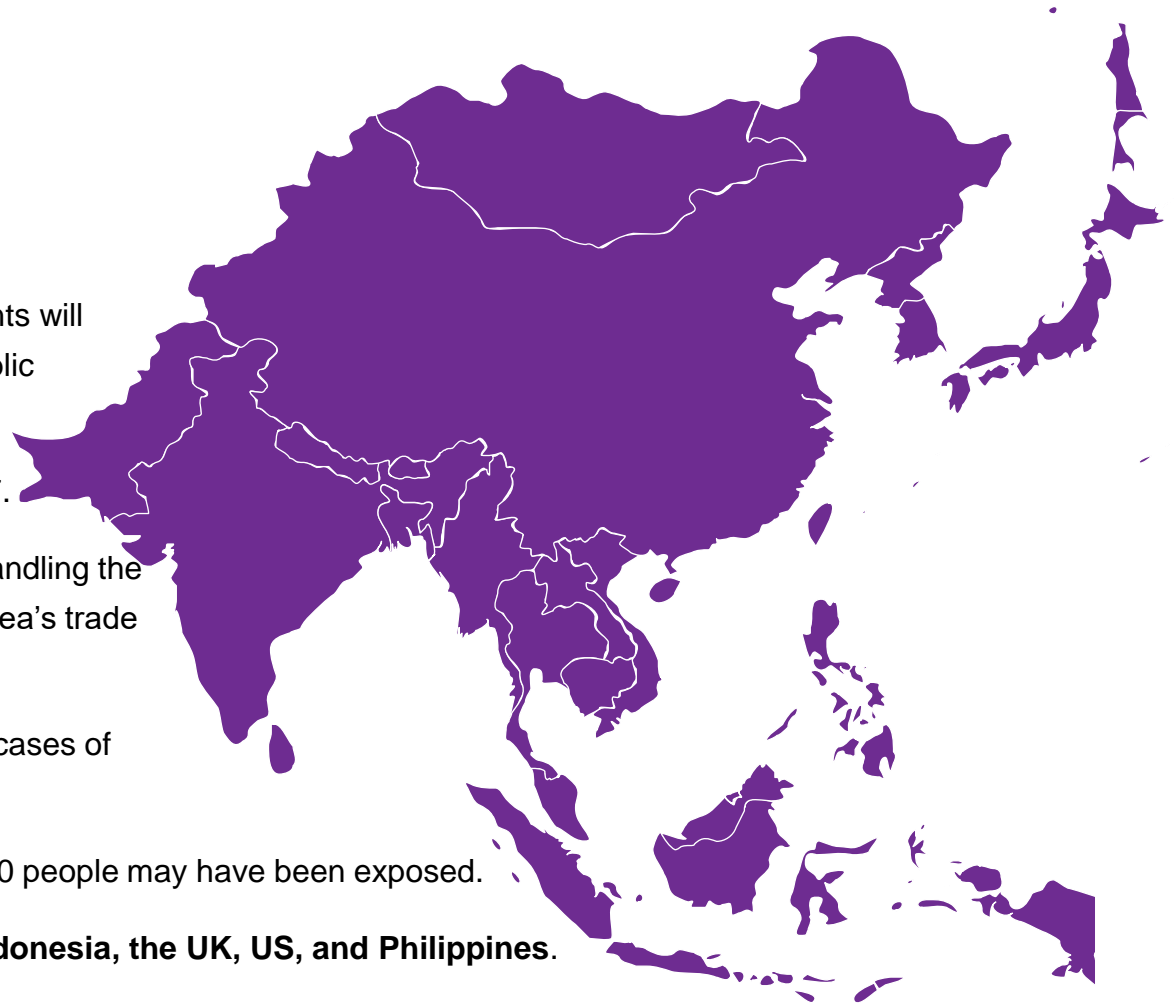
- Militants in the **Nigerian** Borno state killed at least 110 civilians on rice farms.
- **Ethiopian** PM Ahmed claimed that no civilians were harmed in offensives on Tigray.
- **South African** President Ramaphosa called for a global response to prevent debt crisis in Africa.
- **Ghana** deployed its army to the Volta state, seen as an opposition stronghold, ahead of the December 7 presidential elections.
- Authorities in **Togo** are holding two opposition leaders on charges of "*plotting to destabilize the internal security of the state.*"
- Al-Qaeda linked Islamist fighters attacked three French bases in **Mali**.
- The **Kenyan** health minister declared November the country's "*darkest month*" since the onset of the pandemic, reporting that cases in November were more than double those reported in September and October combined.
- **Somalia** ordered its envoy to **Kenya** to return, citing "*overt and blatant interferences*" in internal Somali affairs.
- **Algeria** will allow some domestic flights to resume. Algeria's President Tebboune left a German hospital where he began treatment for COVID-19 a month ago; he will return to Algiers in the coming days.

# Asia

- **Hong Kong** will limit public gatherings to two people, and Hong Kong civil servants will again work from home. South Korea banned year-end parties and said some public saunas and cafes must close after a rise in cases.
- **China's** November factory activity expanded at the fastest pace seen since 2017.
- **North Korean** leader Kim Jong Un reportedly criticized his government for mishandling the economic impacts of the pandemic a week after new data showed that North Korea's trade with **China** has fallen 76 percent.
- **Cambodia** banned wedding parties and gatherings of over 20 people, after rare cases of community transmission were detected.
- **Thailand** is racing to trace a potential outbreak in its northern provinces; over 350 people may have been exposed.
- **Taiwan** reported 24 new cases, its highest in weeks, all involving people from **Indonesia, the UK, US, and Philippines**.
- **India** reported almost 39,000 cases Monday, marking the 23rd straight day that cases have remained below 50,000. Tens of thousands of farmers took to the street in New Delhi, India, to protest new pro-market agricultural policies.
- **Indonesia's** security forces warned the public to stay alert for further militant attacks after a pro-ISIS group killed four people this weekend. Hundreds of Papuans held rallies across at least eight cities in Indonesia on Tuesday to renew calls for independence, as a separatist group declared it had established a provisional government in exile.

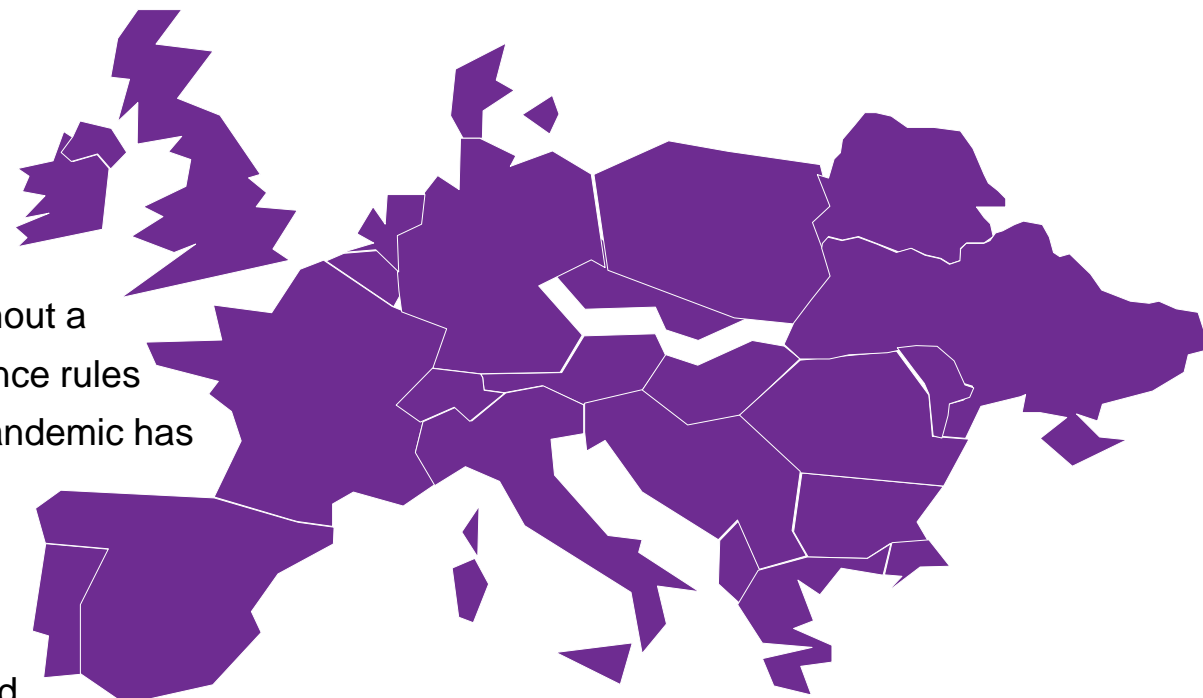

# Europe

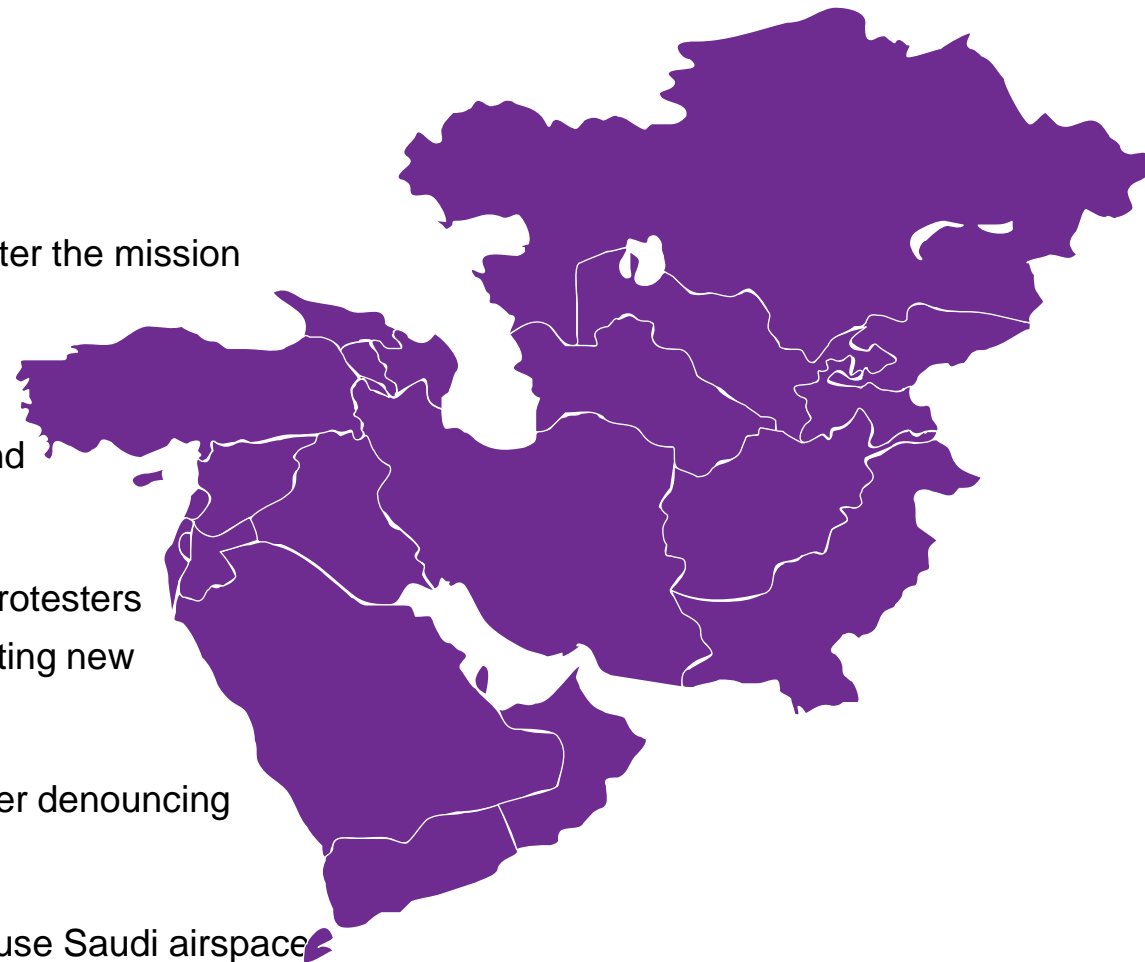
- The **UK** warned there was still a chance of a turbulent Brexit without a trade deal as talks with the **EU** had snagged on fishing, governance rules and dispute resolution. A London think tank estimated that the pandemic has pushed 700,000 Brits into poverty.
- **Turkey** announced its strictest-ever lockdown, including an overnight curfew, limits on gatherings, and limits on the use of public transportation. **Croatia's** Prime Minister and his wife tested positive for the coronavirus. **UK** health secretary Hancock announced an expansion of community testing to target asymptomatic cases. Wales will prohibit bars and restaurants from selling alcohol after 6:00pm. **Poland and Hungary** said that they were open to new proposals for **EU** coronavirus aid after rejecting a package that includes rule of law requirements. Yesterday, Poland surpassed 400,000 infections and Hungary 217,000.
- **Eurozone** finance ministers reached an agreement to update the European Stability Mechanism, a financial backstop for ailing lenders. The eurozone's economy suffered its fourth consecutive month of deflation in November; it is only the third time the eurozone has ever had four consecutive months of deflation.

# Middle East

- **Sudan** confirmed that an Israeli delegation visited Khartoum a week after the mission occurred but said that it was “*not a major visit.*”
- **Egypt’s** finance minister said that he expects to receive a \$1.6 billion disbursement from a recently negotiated \$5.2 billion IMF package by the end of December.
- An **Iraqi** protester shot in clashes between anti- and pro-government protesters died three days after being shot, bringing the death toll to 8 and prompting new protests.
- Twenty-nine arms control and human rights organizations signed a letter denouncing the proposed sale of F-35s to the **UAE**.
- **Saudi Arabia** officially agreed to allow Israeli commercial airplanes to use Saudi airspace
- **Iranian** opposition groups rejected reports that they had been involved in Israeli operations to assassinate the Iranian nuclear scientist killed over the weekend. A bill requiring Iran’s government to step up uranium enrichment closer to the level needed for a nuclear weapon and ignore other restraints on its nuclear program agreed with major powers, cleared its first hurdle in parliament.

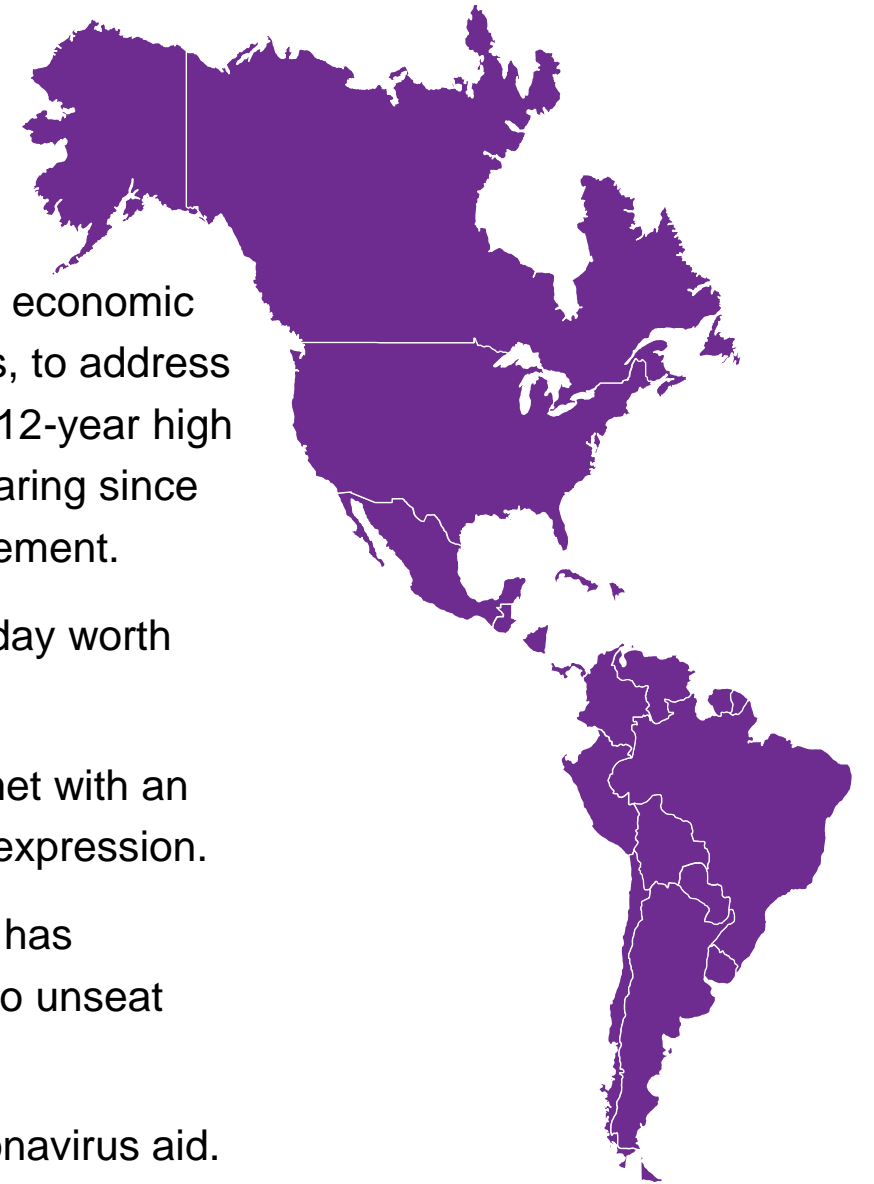

# Americas

---

- **Brazil's** most populous state of Sao Paulo introduced new restrictions on economic activity, including curbs on the hours and capacity of restaurants and bars, to address a surge in cases. Deforestation in Brazil's Amazon rainforest surged to a 12-year high in 2020, official government data showed on Monday, with destruction soaring since President Jair Bolsonaro took office and weakened environmental enforcement.
- **Mexico** announced further private and public infrastructure projects Monday worth \$11.6 billion.
- Over the weekend, a protest led by **Cuban** artists and intellectuals was met with an unexpected agreement from the government to hold talks on freedom of expression.
- **Venezuelan** opposition leader Juan Guaidó's diplomatic envoy to the UK has resigned from her post in the latest sign of trouble for the coalition trying to unseat socialist President Nicolás Maduro.
- The **Canadian** deficit is forecast to hit C\$381.6 billion on emergency coronavirus aid.

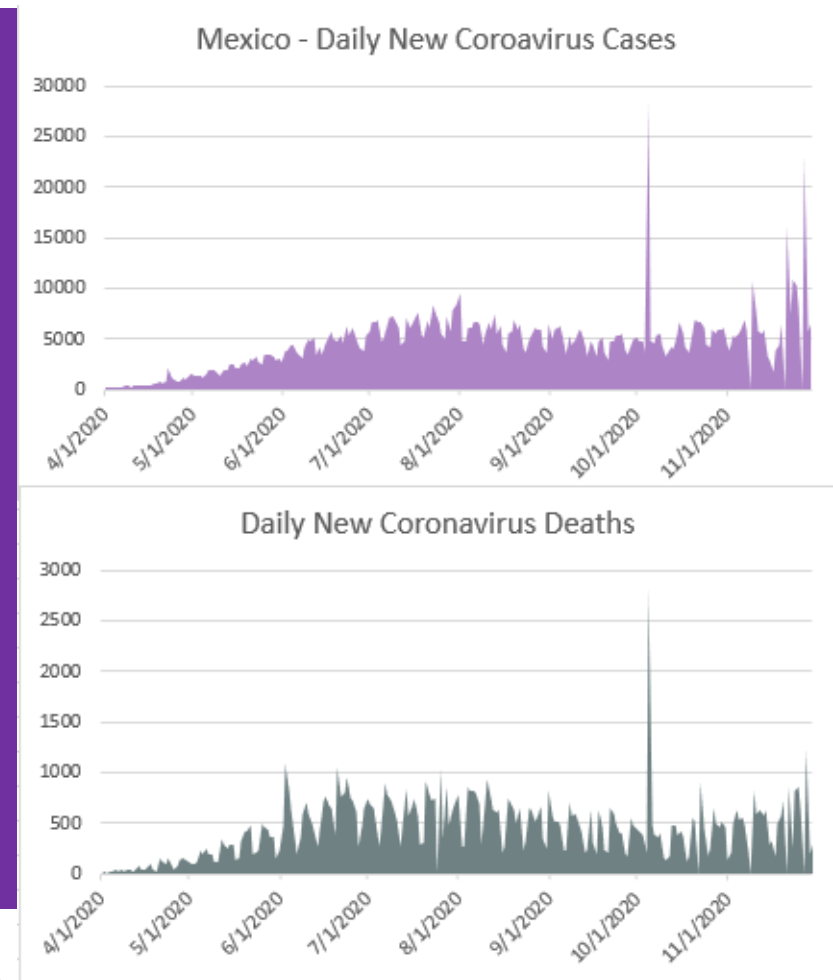
# Americas

The surge in new coronavirus cases in Mexico prompted a warning by the WHO yesterday. Mexico ranks 17<sup>th</sup> globally for the number of confirmed infections, with 1.1 million cases, but 4<sup>th</sup> in terms of global deaths, indicating a significant under reporting of the infection's spread.

At least seven of Mexico City's 54 public hospitals treating COVID-19 patients are at full occupancy for coronavirus beds with respirators, with another 14 at 70 percent occupancy. Mexico's Health Ministry reported 63 percent of all general hospital beds for COVID-19 patients in the capital are occupied.

Mexico lifted its lockdown in June and has resisted calls to reimpose national level restrictions out of concern for the impact on the poor.

# Americas: US



- Wisconsin and Arizona certified the **election results**, confirming President-elect Biden's victory.
- The TSA screened 1.18 million **travelers** Sunday, in the country's busiest travel day since March.
- **New York** Gov. Cuomo announced new emergency hospital regulations, including instructions to develop plans for staff shortages and increasing bed capacity by 50 percent. **California** Gov. Newsom said hospital capacity could run out by Christmas and warned of drastic new restrictions.
- In testimony before Congress today, Federal Reserve Chairman Powell and Treasury Secretary Mnuchin will present divergent views on the **economy**: Powell will reportedly blame rising cases and vaccine uncertainty for economic troubles while Mnuchin will blame state and local lockdowns. US pending **home sales** dropped for the second consecutive month.
- The Supreme Court is considering a case proposing excluding undocumented immigrants from the **census count** for the first time.
- The US imposed sanctions on Monday on **Chinese** firm China National Electronics Import & Export Corporation (CEIEC), accusing it of supporting **Venezuelan** President Nicolas Maduro's efforts to undermine democracy.

# Moldovan Elections and Russia's Evolving Periphery

*The November 15 elections in Moldova marked the latest in a series of geopolitical upheavals across the former Soviet space and in modern Russia's greater sphere of influence. Longtime Kremlin ally President Igor Dodon was ousted by Maia Sandu, a pro-Western former prime minister who campaigned on a platform of anti-corruption and closer integration with the European Union. Sandu, who has a Master's degree in Public Administration from Harvard University, will be the first female president of the small former Soviet republic and represents a dramatic departure from Moldova's history of pro-Russian, oligarchic leadership.*

The election results, in which the former prime minister garnered 57 percent of the vote, reflected a deep division in Moldovan politics over its geopolitical identity. Since its independence in 1991, Moldova has remained close to Russia through economic and cultural ties, and with extensive financial support from Moscow for Moldovan industry and trade. Leadership in Chisinau has been overwhelmingly pro-Russian since independence, with Moldovan politicians benefitting from ethnic and Russian speaking minorities in the country. On November 15, Sandu received most of her support from the Romanian-speaking majority of Moldovans, including from a massive Moldovan diaspora living and working abroad who are permitted to vote remotely under Moldovan law. Sandu's ascension to

power is viewed as a blow to Moscow's influence in the region, although the president-elect has been mostly careful not to provoke Russian hostility through her pro-European rhetoric and anti-corruption platform.

The breakaway Moldovan province of Transnistria, which is controlled by a separatist government armed and funded by Russia, will remain a flashpoint in relations between Chisinau and Moscow moving forward. On Monday, President-elect Sandu called for Russia to withdraw its “*peacekeeping*” force from Transnistria, which contains 1,500 Russian troops and numerous weapons and ammunition depots.

This decision represents a major departure from previous Moldovan policy, as Sandu added that the peacekeeping mission should be handed over to OSCE control (Organization for Security and Cooperation in Europe). In response, the Kremlin warned that any “*changes in the status quo*” in Transnistria could “*seriously destabilize*” regional security.

Moldova was just one of several former Soviet states to undergo a period of political transition or upheaval over the last several months. Beginning in August, massive protests have shaken the foundations of longtime Belarusian president Aleksander Lukashenko's regime, after his reelection was marred by accusations of voting fraud and corruption. Lukashenko's subsequent crackdown has only served to energize the Belarusian opposition movement and consolidate an international response to the ongoing unrest in the country. The latest reports from Moscow indicate that the Kremlin is losing patience with Lukashenko, with some even speculating that President Vladimir Putin has privately urged the “*managed transition*” Belarus's leadership.

To Russia's south, the simmering Armenian-Azerbaijan conflict over the disputed region of Nagorno-Karabakh exploded in September, with reports of thousands of casualties and a dramatic reorganization of the regional geographic claims in the region. The cease-fire brokered by Moscow is viewed as heavily skewed towards Baku's interests and claims over the territory - many in Armenia feel betrayed by Russia's acquiescence towards Azerbaijan, which they claim ignores the deep cultural and ethnic ties between Moscow and Yerevan. In fact, the truce is seen by many Armenians as so unacceptable to their interests that it is only a matter of time before violence erupts again, despite the new presence of Russian peacekeeping forces in the region.

Further to the east, in Central Asia, Kyrgyzstan experienced a dramatic power shift in October, when President Sooronbay Jeebekov resigned after mass protests and demonstrations stemming from accusations of an earlier rigged election. And, closer to home for Russia, in Ukraine, a hot war continues to tear apart the country's east, where Ukrainian forces have battled Russian-backed separatists since Moscow annexed the Crimean peninsula in 2014.

Despite disappearing from the headlines of most major newspapers, the war in the Donbass remains an active conflict zone on Europe's periphery.

The ongoing widespread disruption in former Soviet republics contradicts President Putin's claims of providing strategic stability and leadership in Russia's near-abroad. While the Kremlin retains significant abilities to influence the political and economic dynamics in their sphere of influence, 2020 has shown that the region is no longer as susceptible to Moscow's traditional toolkit of coercion and military intervention. In fact, the conflicts in Belarus, Kyrgyzstan, and Nagorno-Karabakh (as well as the recent elections in Moldova) have revealed that Moscow may not be as influential (or willing to interfere) in the former Soviet space as it was as recently as 2014. Furthermore, in the past several months, the Kremlin has lent rhetorical and financial support to the leadership of Belarus, Kyrgyzstan and Moldova, only to see political support in each country collapse under the weight of popular dissatisfaction and the economic effects of the coronavirus pandemic.

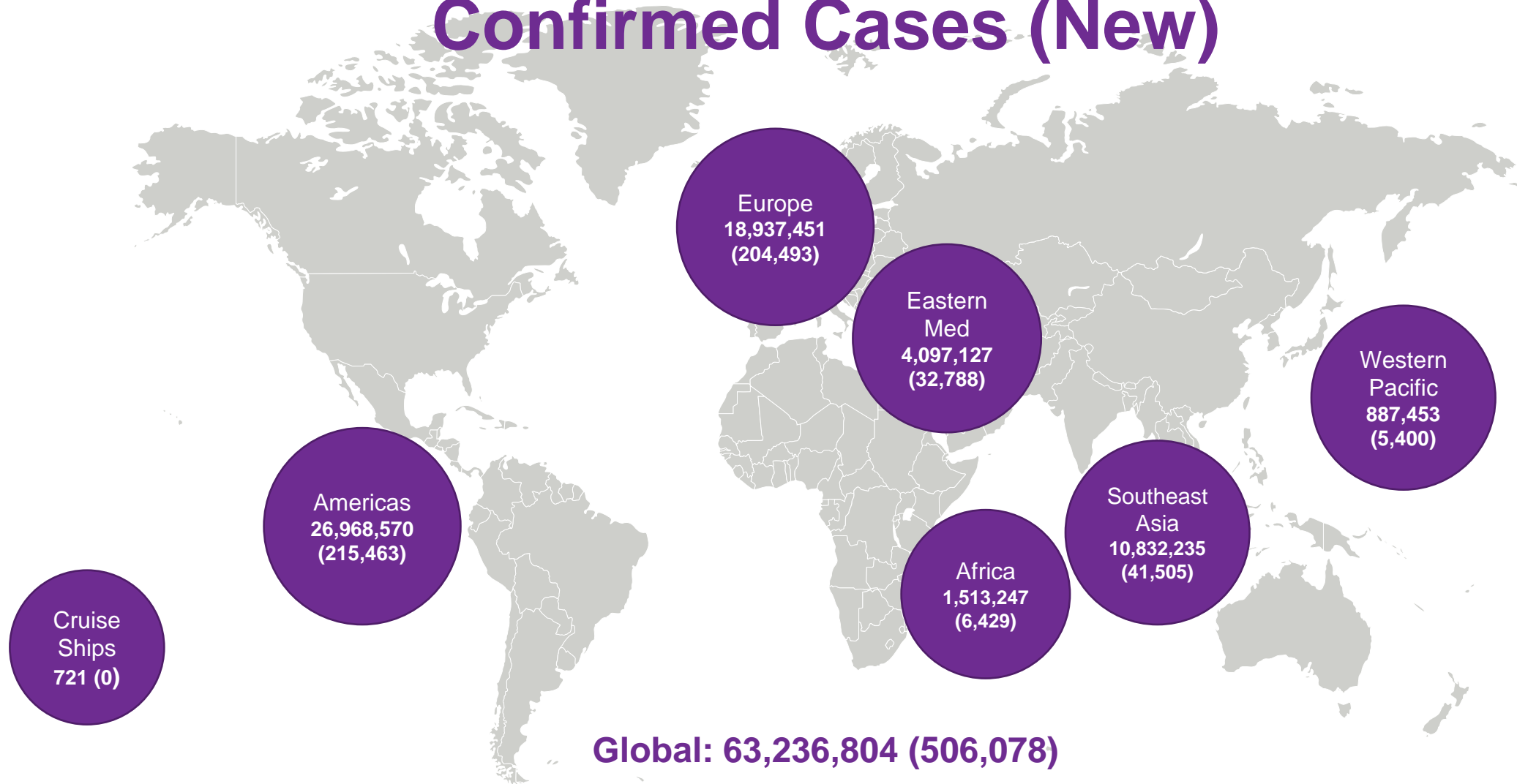
How the Kremlin will react to this perceived loss of political influence is an important area of risk. Two of Moscow's geopolitical "victories" in their sphere of influence (i.e. the ceasefire in Nagorno-Karabakh and keeping Lukashenko in power) are questionable at best, given the high potential for violence in the Caucasus and the international community uniting against electoral corruption in Belarus. Cracks are already beginning to show in Russia's regional strategy, as reporting indicates that Moscow may be looking for ways to transition away from Lukashenko while simultaneously establishing a working relationship with the pro-European president-elect in Moldova. The war in Ukraine remains a stalemate for policymakers in Moscow, Brussels, and Washington, while Central Asia continues to exhibit warning signs about its political stability. Resolving these numerous issues will depend on President Putin's willingness to cooperate with European leadership as well as President-Elect Joe Biden. Given the recent rhetorical signals from the Kremlin, it is not likely that Russian leadership will play a productive role in regional or international security through 2021.

As of 2100 hours US EDT on November 30

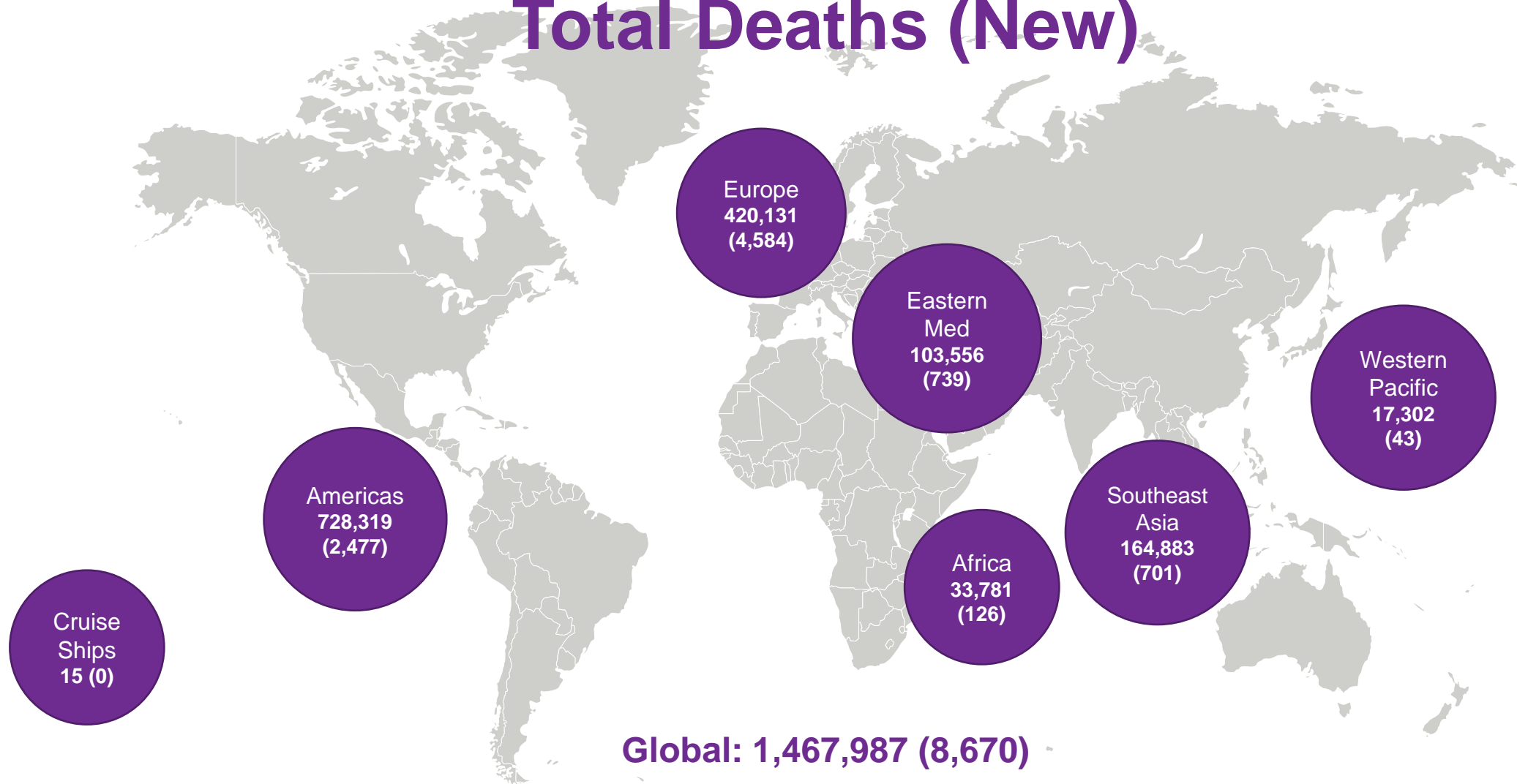
# Confirmed Cases (New)

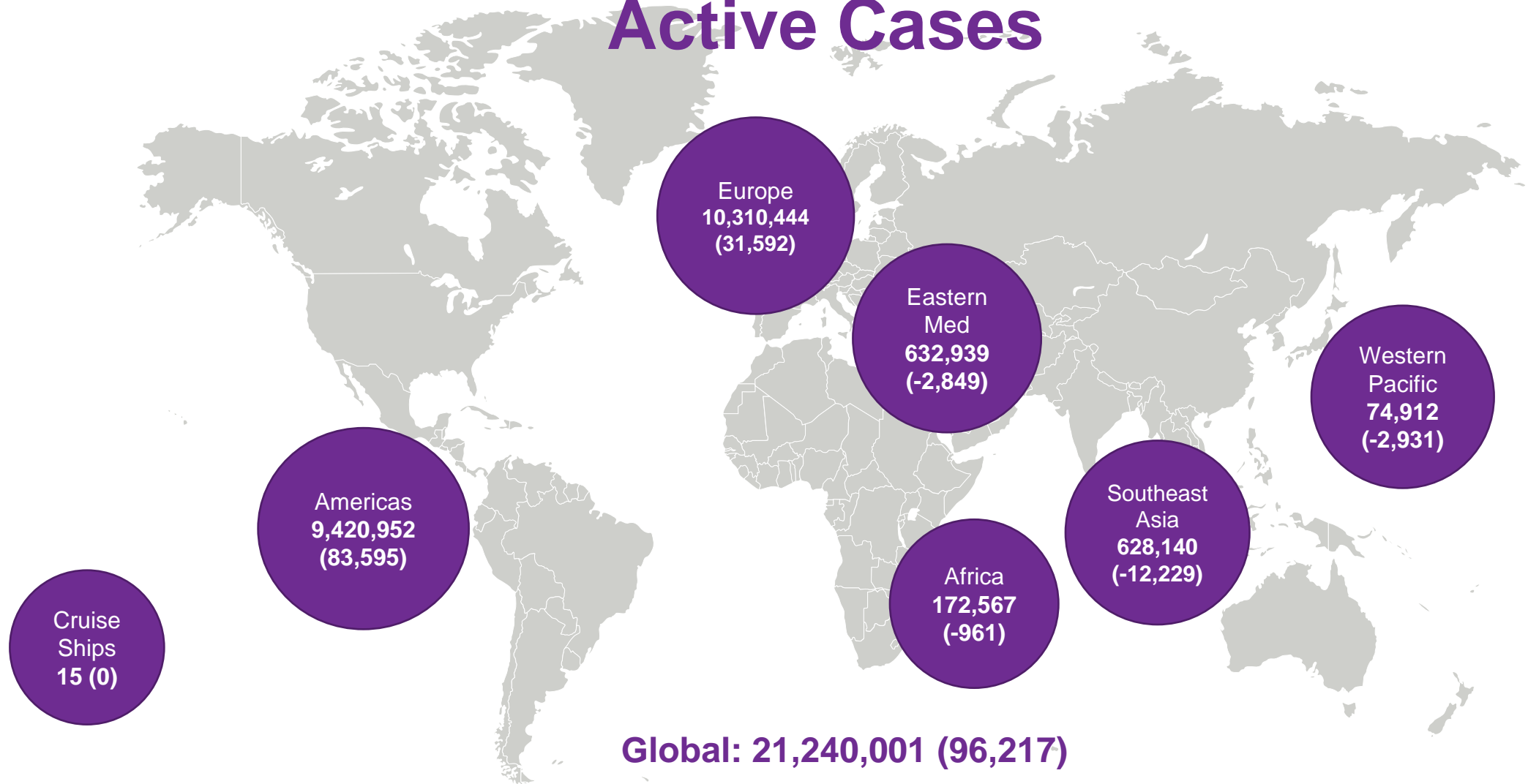
# Total Deaths (New)
