










## Global


# Overnight, confirmed cases grew to 4,818,676 in 213 countries and territories, with 316,953 deaths.

## **Markets**

## European regulators will suspend their bans on short selling, citing normalization of the market.

- European stock markets opened with considerable gains, as oil prices rose and investors welcomed the continued reopening of major economies.
- Asian stocks also edged up.

- Analysts in the US oil market are growing increasingly confident of stronger prices, as lockdowns ease, production drops and consumption increases.
- China's new home prices edged higher in April for the second month in a row, in a further sign of recovery across the country's property market.



## Business

European countries are increasingly switching to technology built by Apple and Google to power contract-tracing apps.

- With the drop in demand for clothes due to lockdowns, McKinsey estimates that up to a third of global fashion players will not survive coronavirus.
- Saudi Arabia's sovereign wealth fund invested at least \$7.7bn in US and European blue-chip companies this year, taking advantage of the drop in prices during the coronavirus pandemic.
- American Express and JPMorgan Chase are offering delayed payments, fee waivers and other credit relief to consumers to avoid defaults amid the financial fallout from the coronavirus pandemic.
- Hochschild Mining, a gold and silver mining company, said that it has met all of the Peruvian government requirements to recommence work at its mining sites after a temporary shut down due to the nation's lockdown.



## **Africa**

- Kenya has banned cross border traffic of people, except truck drivers carrying freight, with Somalia and Tanzania for 30 days.
- Benin staged local elections minus key opposition parties on Sunday with authorities pushing ahead despite the coronavirus threat and calls for a delay.







## Asia

Goldman Sachs forecasts that India's economy is set to contract by 45
per cent in the April-June quarter from the previous quarter. India
suspends new bankruptcy cases for up to a year.

 China fired five health officials in the north-eastern province of Jilin and the head of the small city at the center of a new coronavirus outbreak.

 Bangkok reopened shopping malls for the first time in eight weeks, marking a significant easing of lockdown measures in **Thailand**.

• Canberra warned on Sunday that **China's** "unpredictable regulatory interventions" in trade are making it more difficult for **Australian** businesses to invest in the bilateral relationship.

 Taiwan retracted its bid for participation in WHO's annual conference, just hours before the start of the World Health Assembly, a diplomatic victory for China.

Japan falls into recession as Q1 data shows 3.4 percent contraction.







## Europe

- Germany's domestic intelligence agency warned that rightwing extremists are driving anti-lockdown protests.
- Spain's daily death toll dips below 100 for first time since March. UK daily death figure dips to lowest since day after lockdown.
- Beaches opened in Greece on Saturday, drawing large crowds.
- Hungary will lift its lockdown in Budapest starting on Monday.
- France identifies two new hotspots linked to slaughterhouses in Val de Loire and Brittany regions.
   Confirmed cases in Serbia pass 10,000.







## Middle East

- Pakistan has resumed some domestic flights ahead of Eid marking the end of Ramadan.
- Egypt will bring forward the start of its curfew by four hours to 5 p.m. and halt public transport from May 24 for six days during the Eid holiday.
- Saudi Arabia surpasses 50,000 confirmed cases.







## **Americas**

- Brazil surpasses Italy and Spain to have the world's fourth-highest number of cases, and Bolsonaro continues to discount the need to social distancing. Hospitals in Brazil's largest city are on the verge of collapse, Sao Paolo's mayor warned.
- Japan will contribute over US\$2.7 million to help nine countries in the Americas strengthen their capacities to detect cases, monitor, and control outbreaks of COVID-19.
- Chile's capital, Santiago, began a strict quarantine Saturday after a sharp resurgence of coronavirus cases.
- In Canada, parks and beaches reopen this past weekend to commemorate Victoria Day, with businesses opening on Monday.

## **Americas: US**

- Nearly 1.5m people have now tested positive for coronavirus in the US, as testing in the country jumps to more than 400,000 a day.
- Federal Reserve chair Powell warned that a full US economic recovery
  may take until the end of 2021 and require the development of a Covid19 vaccine. According to the Fed, nearly 600 lenders tapped the US
  government's Paycheck Protection Program for about \$30bn of loans
  as of May 6.
- White House tensions with CDC spill into public view as Trump adviser Navarro criticizes the agency response.
- New York governor Cuomo took a Covid-19 test on live television, urging New Yorkers to get tests as part of getting back to work. Colorado,
   Alabama and North Dakota change the criteria for counting COVID-19 deaths to exclude those of die of complicating factors, not solely from the virus, adding to the CDC's concerns that deaths are being under reported
- The US has not made a "final decision" on whether to permanently withdraw **WHO funding**.







## Industry Perspectives on Food Supply Chain Disruption in the US

The global economic downturn and collapse of service sector demand has put unprecedented stress on food supply chains, and the US, despite its status as a resource-rich country and net exporter of food, has not been spared. Central voices in the unfolding food insecurity crisis and ongoing supply chain disruptions in the US include Zippy Duvall, president of the American Farm Bureau Federation, Julie Anna Potts, CEO of the North American Meat Institute, the spokesperson for America's major meatpackers, and Leslie Sarasin, president and CEO of the Food Marketing Institute, which represents food distributors.

Per Duvall, prior to the pandemic, nearly 50 percent of the food Americans ate was eaten outside of the home, primarily in restaurants and cafeterias. When the demand in the service sector abruptly collapsed as lockdown measures took hold, food suppliers were not able to transfer production intended for the service sector to retail outlets due to logistical challenges, resulting in unmet demand and scarcity in the retail sector as well as significant loss of income from

wasted shipments. Duvall emphasizes that the agriculture industry was under stress prior even to the pandemic - in 2019, farm bankruptcies were up 27 percent.

Most visible in this supply chain disruption has been the meatpacking industry. Throughout April, high prevalence of infection in meatpacking workers has forced the closure of multiple meatpacking plants, which, mostly operated by just four meatpacking conglomerates, caused significant ripples throughout the American meat supply. High prevalence of cases in meatpacking plants is hard to avoid - the process is labor-intensive, meaning social distancing is not possible, the plants tend to be less than hygienic, and meatpacking workers are typically lower-income and have lower baseline health. In late April, reports circulated that fast food chains were unable to stock hamburger meat, and major retailers like Costco and Hy-Vee were limiting meat purchases. In response, President Trump issued an executive order under the Defense Production Act requiring to remain

(Potts and the North American Meat Institute believe that this is the first food-related order taken under the Defense Production Act). Regardless, closures and scarcity at the consumer end has persisted, and Potts has said that production remains 31 percent down in pork and 24 percent down in beef.

Current visible difficulties in the meatpacking industry have intensified existing claims that the meatpacking industry is too consolidated. Just four meatpacking conglomerates dominate the industry - Tyson Foods Inc., JBS SA, Cargill Inc. and National Beef Inc. comprise 80 percent of the market. In early May, 11 state attorneys general have requested that the Department of Justice investigate the four major meatpackers for manipulating prices amid the crisis, a call that has been echoed by President Trump and 13 Senators. The price-manipulation allegations arise from the fact that the crisis resulted in lower-cost cattle due to the surplus, while bottlenecks due to plant closures paired with

increased, unmet retail demand caused prices, and thus meatpacker profit margins, to rise. Potts maintains that this is unintentional and regrettable - the consolidation of the beef industry, she says, has been constant for about 30 years because meatpacking plants are expensive to run efficiently, and usually this consolidation results in lower prices for consumers. Regardless, the investigation is ongoing, and the DOJ has said that it has ongoing antitrust investigations into the meat industry.

Another concern for the American food industry and supply chain is the loss of export markets due to global recession or protectionist trade trends. Per Duvall and Sarasin, many food suppliers would not be able to operate at current margins or at all without export income. If international demand disappears, reduced profit and output will lead to increased costs for logistics and maintaining plants, leading to higher prices and less product in the American market.



## Industry Perspectives on Food Supply Chain Disruption in the US

While industry leaders have been outspokenly optimistic about the industry's "nimbleness" in reacting to supply chain disruptions, and the lack of serious shortages thus far is impressive, they have not publicly addressed the fundamental changes that the US food industry faces. Potts and Duvall, mouthpieces of the meat and agriculture industries, have both referred to returning to the "50/50 split" between retail and service markets. However, betting on the service and restaurant sector bouncing back quickly enough not to require long-term supply chain adjustments is wildly optimistic. Despite the cautious re-openings taking place throughout the US, what with public anxiety and looming "second waves" of infection there is little guarantee that the service sector will return to "normal" in the next few years. Without a vaccine, which UN officials have called a "massive moonshot," even a world with managed coronavirus would be permanently different - new occupancy limits in restaurants, for example, would eat into service sector demand. Similarly, demand from school and private cafeterias

has nose-dived, and will not return soon - many higher-education institutions will likely be online-only for the next year at least, and large corporate campuses may be a thing of the past (Twitter CEO Jack Dorsey said last week that employees could work from home forever, if they chose). The food industry faces painful years of adjusting to lowered demand and a new model of distribution, one that may result in significantly lower profit margins or business failure, as well as some scarcity and increased prices for the American consumer.





### Country in Focus: El Salvador

El Salvador, despite its relatively weak public health infrastructure and limited resources, seemed to be an early example of decisive public health policy resulting in a manageable coronavirus outbreak. El Salvador's popular, young president Nayib Bukele made El Salvador the first country in the western hemisphere to implement national quarantine on March 12 (four days before the US announced federal social distancing guidelines). Bukele announced aggressive measures to enforce the quarantine, including threatening detainment in "quarantine centers" for those found in the streets without reason, thirty-day quarantines for those suspected to have the virus, and granting broad powers to police to enter homes without warrants and arrest those violating quarantine. El Salvador still seems to be seeing a measure of success in containing its outbreak - the country has tested aggressively, for the region and has 1,338 confirmed cases and 30 deaths. Cases continue to rise, but without huge spikes, and the country has avoided the half-hearted lockdowns and early case surges that have pushed other countries' outbreaks out of control.

no representations to same.

However, whatever success El Salvador has had in containing its outbreak is beginning to be overshadowed by rising reports of authoritarian tendencies from President Bukele. Bukele was a powerful figure before the pandemic - in February, he marched soldiers into the legislative building to demand lawmakers pass necessary legislation - but the coronavirus crisis has, according to international observers, allowed him and his administration to consolidate power and exercise increasingly violent authority to enforce the lockdown. The most controversial and visible example of this came in late April, when Bukele lashed out at gangs after a weekend spike in violence by rounding up gang members and publishing photos of crowded cell blocks with prisoners sitting squeezed chest-to-back, social distancing rendered impossible.



### Country in Focus: El Salvador

According to the World Prison Brief, Salvadoran prisons were at 215 percent of their capacity prior to the spike in incarcerations as a result of the quarantine. Similarly, the broad powers granted police in enforcing the quarantine has resulted in some concerning instances of police violence - President Bukele has also clashed with El Salvador's National Assembly and its court system over his stringent lockdown measures. Bukele faced multiple court decisions from the country's ruling his aggressive lockdown supreme court measures unconstitutional; he responded by tweeting that "five people will not decide the death of hundreds of thousands of Salvadorans" and dissolving the National Assembly before it could negotiate a constitutional lockdown measure. This past weekend, Bukele unilaterally extended the country's lockdown, preempting planned debate within the National Assembly and likely triggering a new round of legal and legislator challenges.

Despite criticism from international observers, Bukele is still wildly popular - he boasts approval ratings north of 80 percent. Bukele has been very popular since his election, he won in a landslide without the support of any major party on the basis of a youthful, anti-gang, protrade campaign. His administration has similarly seen support from Washington - days after the controversial round-up of gang members, he had a phone call with President Trump, who later tweeted that he would be sending ventilators to El Salvador and that they had "worked well with us on immigration at the Southern Border." While Bukele has undoubtedly maintained his popular base and has had a measure of success containing COVID-19 within El Salvador's borders, the increasing turn to police power and clashes with the legislature mirror concerning trends throughout the world.
