Global

Overnight, confirmed coronavirus cases grew to 53,180,628 in 216 countries and territories, with 1,300,857 deaths.

- At a *Financial Times* event, a panel of distinguished economists predicted that the **global economy** is facing a more protracted and wider downturn than in 2008, and industry leaders said that tourism would take years, not quarters, to recover.
- A study conducted in the US and UK raised alarms that **conspiracy theories** and misinformation could prevent sufficient numbers of people from taking COVID-19 vaccines.
- Two WHO-backed inquiries are moving forward with **investigating** the early days of COVID-19.
- The WHO-backed alliance has raised more than \$2 billion for poor countries to access 1 billion doses of **Covid-19 vaccines**, amid rising concerns rich nations will be first in line for immunization.
- According to a WHO and CDC report, **measles** killed an estimated 207,500 people last year after a decade-long failure to reach optimal vaccination coverage, with the Covid-19 pandemic further setting back vaccination efforts this year.

Markets

Federal Reserve Chairman Powell, ECB President Lagarde, and BoE Governor Bailey predict that a vaccine breakthrough will lift uncertainty in the global economy.

- **Europe's benchmark stock index** fell on Friday, setting up to end its second straight week of gains.
- **Stocks in Asia** closed down, following on from selloffs in the US as investors feared the economic impact of an accelerating rise in coronavirus infections.
- **US markets** slid Thursday as the vaccine optimism-driven stock rally abated and concern about soaring US cases deepened.
- **US petroleum demand** rose to its highest levels since March, exceeding 20m bpd last week.
- The IEA sees no prospects for vaccines boosting global **oil demand** until at least mid-2021.
- **Banks** have significantly slashed deposit interest rates since the pandemic began.
- Investors returned to funds that buy **risky corporate debt** in the US, boosted by the prospect that a coronavirus vaccine could help lift the fortunes of some of the hardest hit companies.

Business

Goldman Sachs named 60 new partners, almost half of whom are women and minorities in a marginal move towards greater diversity for the firm.

- **Edgewell Personal Care** saw sales of shaving and sun products dip in Q3.
- **Revlon** struck a last-minute debt deal, saving the company from bankruptcy.
- **Disney** says it logged \$3.1 billion in Q3 pandemic losses, but Disney plus managed to gain 73.7 million subscribers.
- **Tencent** pledged to cooperate with Chinese regulators, downplaying the potential impact of China's increased scrutiny of competition in internet platforms.
- The US Justice Department said it appealed the October 30 order that blocked government action on **TikTok**.
- **Cathay Pacific Group** released traffic figures for passengers and cargo for October, with passenger numbers falling 98.6 percent when compared with last year.
- Spanish power company **Naturgy** has agreed to sell 96 percent of its Chilean electricity utility **Compania General de Electricidad** to China's State **Grid International Development** for 2.57 billion euros (\$3.04 billion) in cash.

Africa

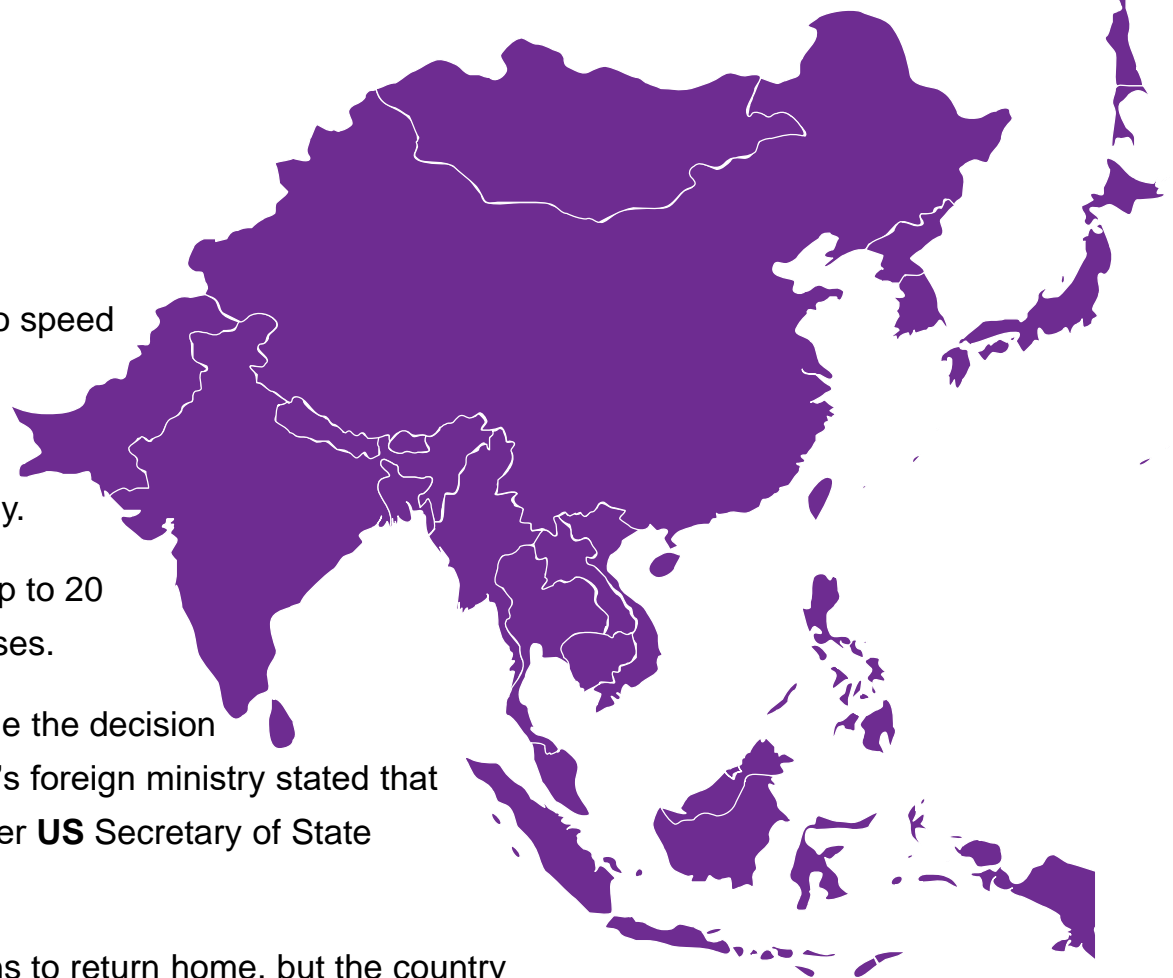
- **Ethiopia's** PM Abiy claimed a victory for Ethiopia's army in Tigray Thursday, while rights group Amnesty International reported mass killings in the region and the UNHCR estimated that 11,000 have fled Ethiopia for **Sudan**.
- Fourteen soldiers were killed in **Burkina Faso** in a suspected Islamist ambush; coming just weeks before November 22 elections, the attack underlines worsening insecurity as a main election issue.
- **Senegal** reopened schools.

Asia

- At a virtual **ASEAN** summit, member discussed creating a travel corridor to speed economic recovery.
- **South Korean** pharmaceutical company, GL Rapha, will start producing more than 150m doses of **Russia's** Sputnik V coronavirus vaccine annually.
- **India** introduced a new \$35.8 billion stimulus package that will subsidize up to 20 percent of wages for new employees in a bid to counter COVID-19 job losses.
- *Wall Street Journal* sources say that **Chinese** President Xi personally made the decision to halt Ant Group's IPO, due to long-building tensions with Jack Ma. China's foreign ministry stated that it "*will strike back against any moves that undermine its core interests,*" after **US** Secretary of State Pompeo said that **Taiwan** "*has not been a part of China*".
- **Australia** will raise its daily cap on overseas arrivals, allowing more citizens to return home, but the country does not have the quarantine capacity to accept international students.
- Fifteen **Asia-Pacific** economies are set to conclude talks on Sunday and sign the Regional Comprehensive Economic Partnership, which could become the world's largest free trade agreement, covering nearly a third of the global population and about 30 percent of its global gross domestic product.

Europe

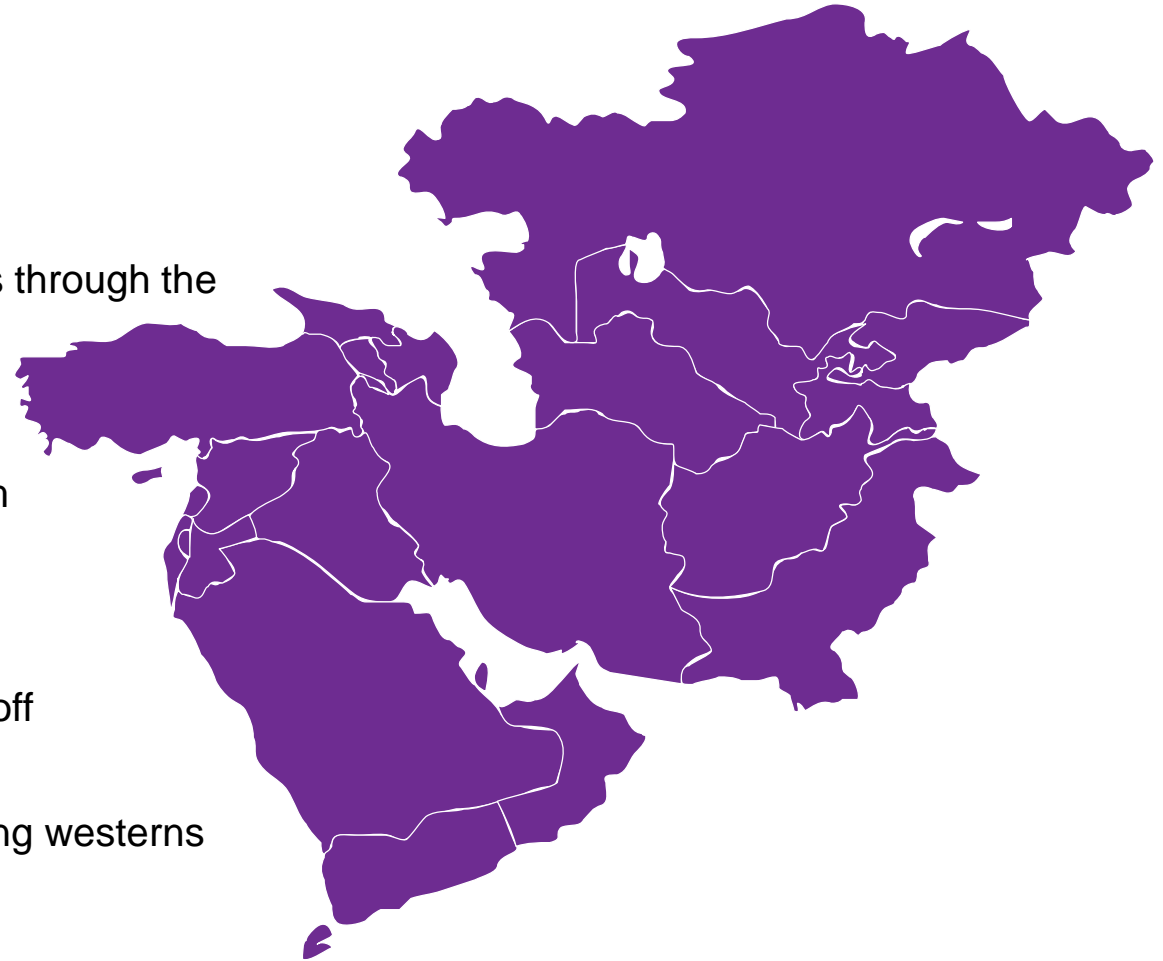


- More than 8 in 10 **EU** job losses in the second quarter were temporary workers. The **UK** granted access to £2.2bn for local authorities to support businesses. The UK's accounting watchdog told companies to issue clear guidance on the impact of COVID-19 on their businesses. **French** solar investors are protesting a government threat to renege on contracts.
- A key **UK** financial regulatory official warned that financials service firms face “*cliff-edge*” risks when the **Brexit** transition period ends in 7 weeks.
- **US** private equity executive Michael Calvey was freed from house arrest in Moscow; his criminal case has shaken foreign investors across **Russia**.
- **Northern Ireland** will extend its lockdown for one week. **France** will keep its current lockdown restrictions for at least two more weeks but hopes to begin relaying them in December. The **UK** reported a record 33,511 new virus cases yesterday. BioNTech's cofounder said that their and Pfizer's vaccine could be administered in the UK as early as December. Britain's largest foodbank network reported that demand increased 47 percent during lockdown. **Portugal** expanded its COVID-19 curfew and weekend lockdown to more areas.

Middle East

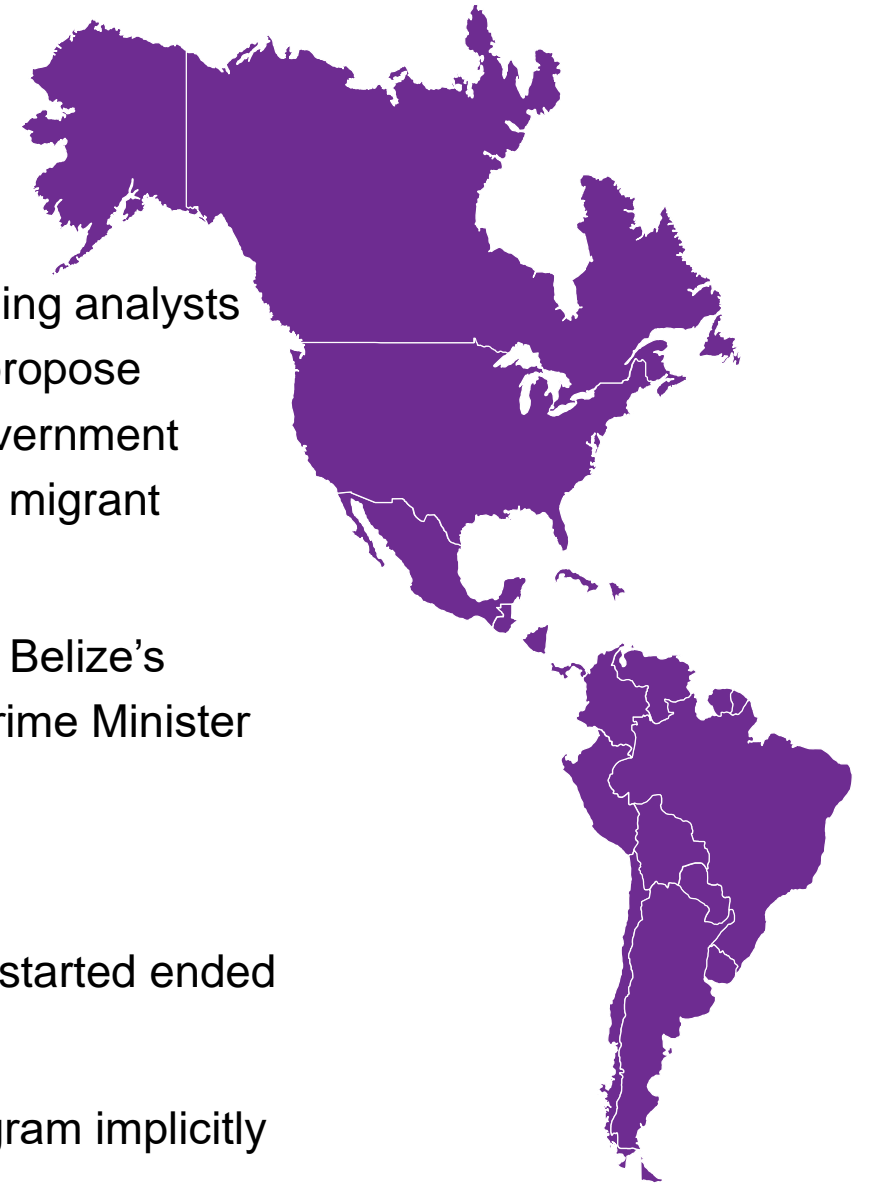
- The **UAE** emirate of Dubai will help state-owned airline Emirates through the pandemic after the airline experienced its first half-year loss in over 30 years.
- **Iran** now holds roughly 12 times the amount of enriched uranium permissible under the JCPOA. Coronavirus deaths in Iran surpassed 40,000.
- The **Saudi**-led coalition intercepted two explosives-laden boats off **Yemen**. Islamic State claimed responsibility for the attack on a non-Muslim cemetery in the Saudi Red Sea city of Jeddah injuring westerners convened for Armistice Day commemorations.
- **Lebanon** surpassed 100,000 virus infections as the country reports a brain drain of doctors due to the political and economic crisis.
- **Iraq** has started closing camps housing tens of thousands of people, including many who fled their homes during the final battle against Islamic State, but aid groups warn this could create a second wave of displacement with dire consequences.

Americas

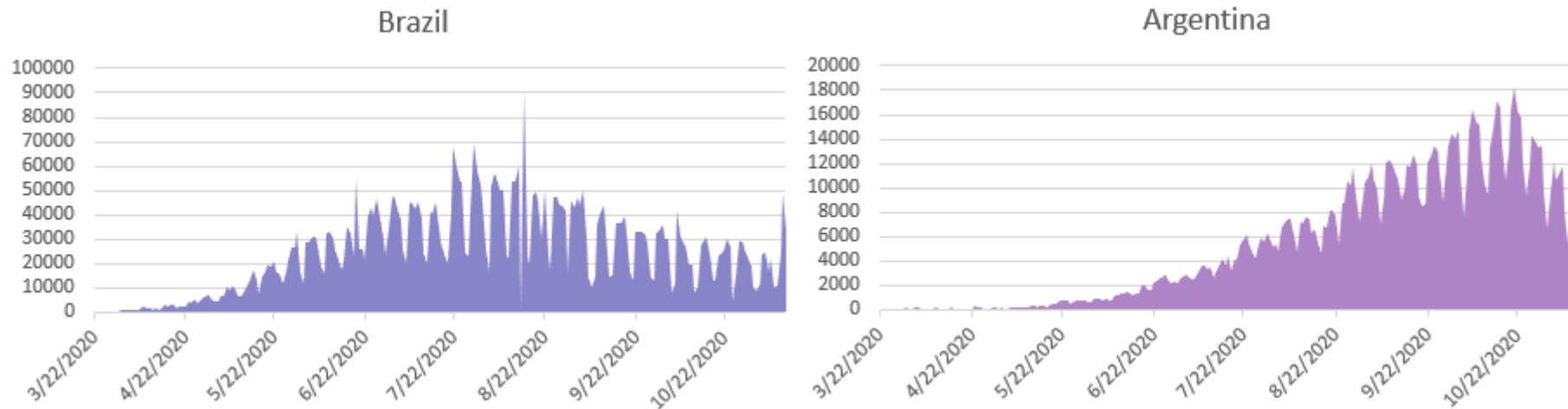
- **Mexico's** central bank left its benchmark interest unchanged, surprising analysts who expected a cut. Mexican President Lopez Obrador said he will propose legislation to make the outsourcing of jobs illegal, at least without government authorization. Mexico changed its immigration law to prohibit holding migrant children in detention centers.
- **Belize's** elections resulted in a resounding victory for the opposition; Belize's People's United Party (PUP) leader John Briceno was sworn in as Prime Minister after three terms in the opposition.
- The **EU** will prolong sanctions on **Venezuela** for another year.
- One of the first cruises on the **Caribbean** to sail since the pandemic started ended its trip due to a coronavirus outbreak.
- **Brazil's** government backed the US' Clean Network proposal, a program implicitly targeted at excluding Chinese technology.

Americas

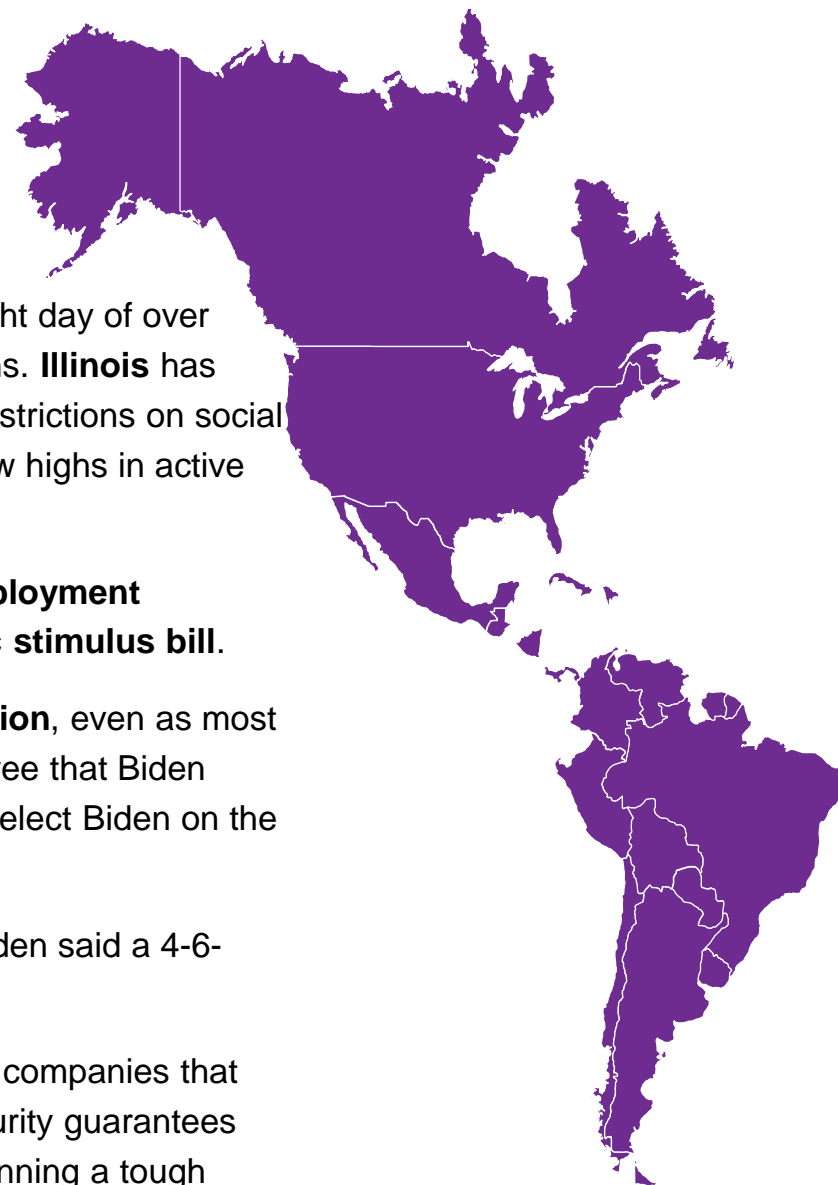
While the attention is on the high numbers of coronavirus infections in Europe and the United States, Brazil and Argentina continue to report over 10,000 new infections daily. The conditions in these two countries are improving slightly. Brazil peaked on August 16 and Argentina on October 20. Brazil has the second highest death toll in the world with 164,281 deaths and Argentina ranks 11th with 34,782.

Americas: US



- **New daily COVID-19 cases** in the US broke records again, topping 151,000 in the ninth straight day of over 100,000 new cases. **California** became the second US state to register over 1 million infections. **Illinois** has reported more than 10,000 new cases a day for seven consecutive days; Chicago tightened restrictions on social gatherings and issued a 30-day stay-at-home advisory. **North and South Dakota** reported new highs in active cases. The number of Covid-19 patients in **Texas** hospitals increased for a fifth straight day.
- New jobless claims fell to 709,000 last week and came alongside a decline in pandemic **unemployment** assistance claims. Congressional Democrats called for renewed negotiations for an **economic stimulus bill**.
- A growing number of influential Republicans are urging President Trump to **concede the election**, even as most Republican members of Congress are going along with Trump. Many Republican Senators agree that Biden should have access to intelligence briefings. Pope Francis and China congratulated President-elect Biden on the election win. Georgia's secretary of state entered quarantine as the state's **hand audit** begins.
- A CDC official said that **mask usage** may help prevent lockdowns. A coronavirus adviser to Biden said a 4-6-week national lockdown, paired with economic aid, could control the pandemic.
- President Trump issued an executive order blocking US firms and individuals from investing in companies that the US says support the **Chinese** military. US President-elect Biden has declared that US security guarantees extend to **Japan's** Senkaku Island, sending an early signal that the Biden Administration is planning a tough stance on China.

Political Transition in Washington and Potential Areas of Risk

Political risks in the US have sharpened as the outcome of the November election is being contested by President Trump. The President's team is currently engaged in several lawsuits in the key states of Michigan, Pennsylvania, Arizona and Georgia to challenge election results in the favor of Joe Biden, in some cases alleging mass voting fraud, illegal ballots, and improper election observer protocols.

Nevertheless, President Trump and his supporters, including elected Republican officials in Congress, are pressing ahead through the courts. The window of time for contesting any results is closing - most election certification dates for key states are within the next two weeks, with the earliest being Georgia (where Biden currently leads by about 14,000 votes) on November 20. After the states have all certified election results, the Electoral College will then meet on December 14, where partisan panels of electors will cast their ballots for president.

Barring any dramatic court action, the final tally is expected to be 306 to 232 in favor of President-elect Biden.

Between now and Inauguration Day on January 20, there are several areas of potential risk stemming from the lack of an orderly, cooperative transition between administrations as well as the strategic calculations made by partners and adversaries abroad. As of November 12, President-elect Biden has not been granted access to daily intelligence briefings, nor has his transition team been permitted to begin direct communication with counterparts at government agencies such as the State Department or Department of Defense. Furthermore, the Administrator of the General Services Administration (GSA) has not yet made an official determination of who has won the presidential election, therefore delaying the transition process and access by the Biden team to government funds as well as the ability to move into federal offices and utilize secure facilities to discuss classified information. An additional area of concern is the lack of official briefings from the Centers for Disease Control or Food and Drug Administration on the status of the COVID-19 pandemic and progress on vaccine development and distribution plans. Political Transition in Washington and Potential Areas of Risk

President-Elect Biden has stated that the transition is “*well underway*,” and that the Trump Administration’s failure to recognize his win “*does not change the dynamic at all and what we’re able to do*.”

President Trump has also taken steps to replace key leadership posts at the Department of Defense over the past several days, an unusual move that has raised questions about what strategic decisions the Administration will make before stepping down on January 20. On November 9, President Trump fired Defense Secretary Mark Esper, who was then replaced by Chris Miller, the National Counter Terrorism Center Director, as Acting Secretary. Shortly thereafter, the Under Secretary of Defense for Policy, Under Secretary of Defense for Intelligence, as well as Esper’s Chief of Staff submitted their resignations. Their replacements are all widely seen as Trump loyalists and more closely aligned with the President’s vision and policies. At the State Department, Ambassador James Jeffrey, the Administration’s lead diplomat on Syria and the Islamic State, also expectantly resigned on the same day that Esper was dismissed. While some have suggested that President Trump is restructuring Pentagon leadership for reasons related to the election, it is more likely that he is now simply clearing the way for a more expedited decision making process in the last two months of his term, such as removing those who

opposed a rapid reduction of US forces in Afghanistan.

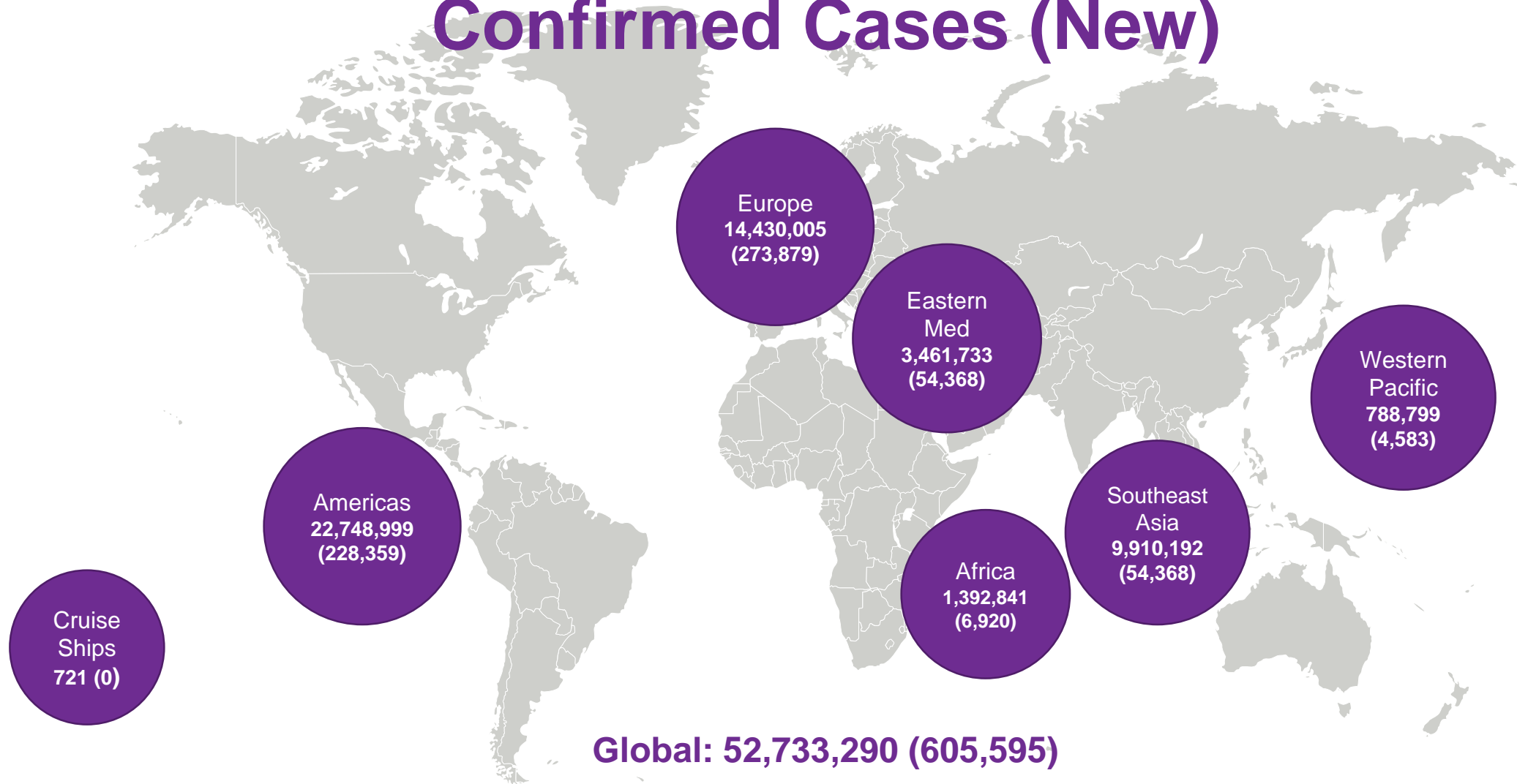
The potential also exists for international actors to take advantage of the US presidential transition period for their own strategic ambitions and goals. Countries that have maintained strong relationships with the Trump Administration, such as Israel, may seek to initiate actions against regional adversaries, namely Iran, in order to consolidate their security advantages. The Trump Administration itself has also stated its goal of unveiling new and sweeping sanctions against Tehran between now and January, although the potential remains for joint US-Israel covert actions targeting Iranian nuclear facilities. For its part, Iran is likely to avoid antagonizing the US or its allies in the region in the hope that they will be able to strike a deal with the incoming Biden Administration or obtain sanctions relief. In Europe, right-wing populists such as Hungarian Prime Minister Orban and Slovenian Prime Minister Janez Jansa are also preparing to lose an ally in Washington, as is Brazilian President Jair Bolsonaro and Russian President Vladimir Putin. The combination of an uncooperative outgoing administration and the expectations of a radically different foreign policy under President-Elect Biden has the potential to create a two-month period of uncertainty before the next inauguration on January 20.

As of 2100 hours US EDT on November 12

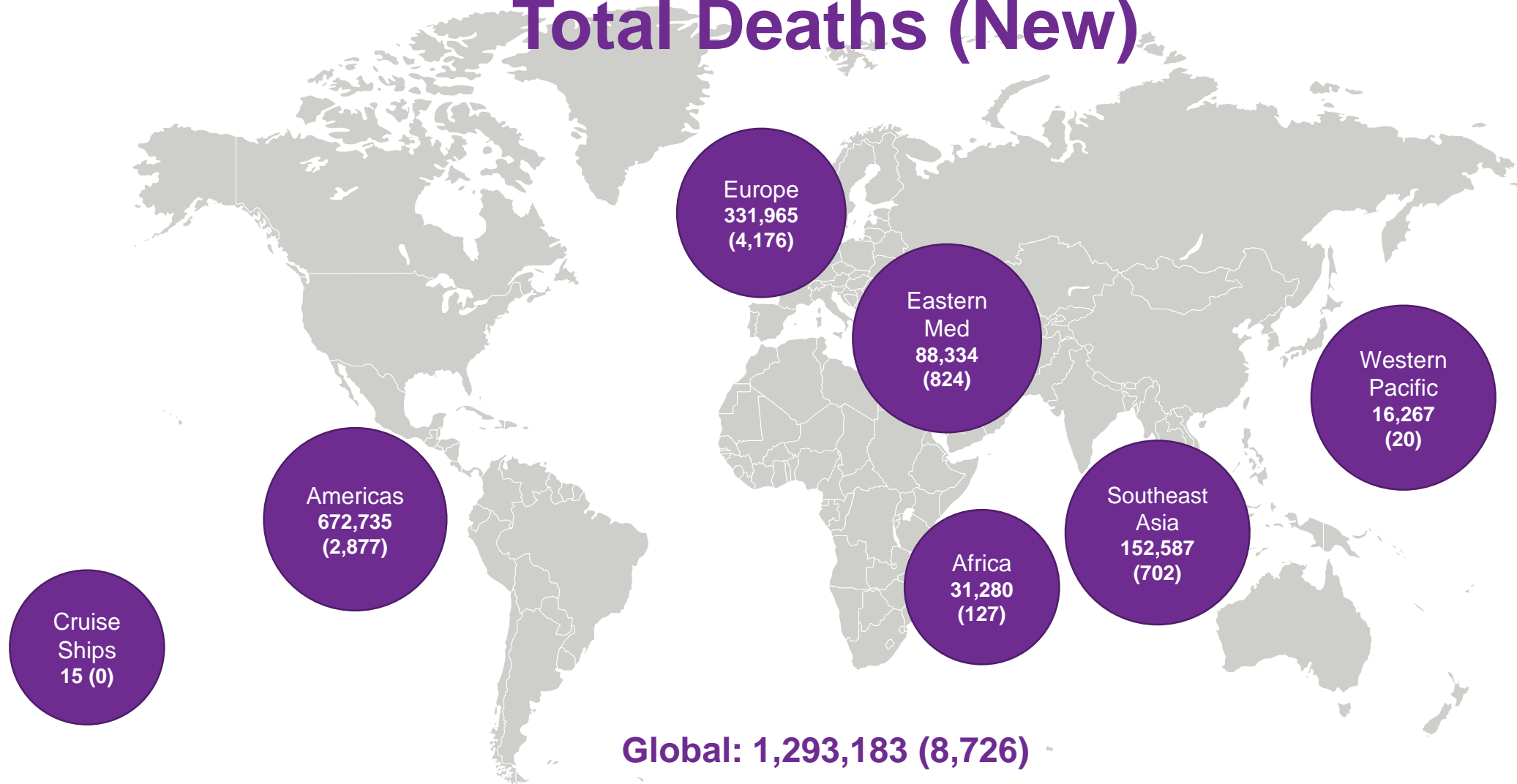
Confirmed Cases (New)

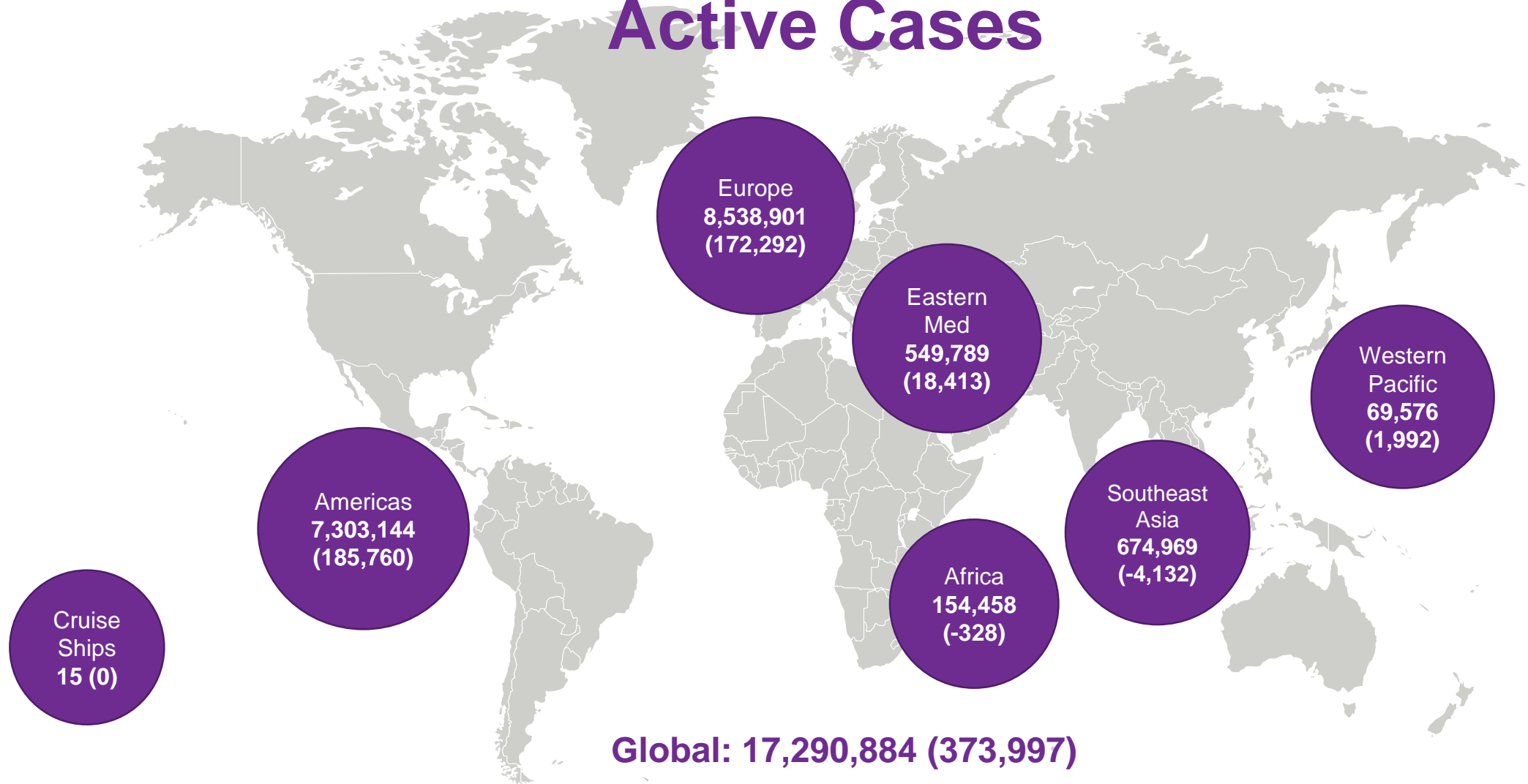
Total Deaths (New)
