Global

Overnight, confirmed coronavirus cases rose to 63,135,973 in 216 countries and territories, with 1,466,289 deaths.

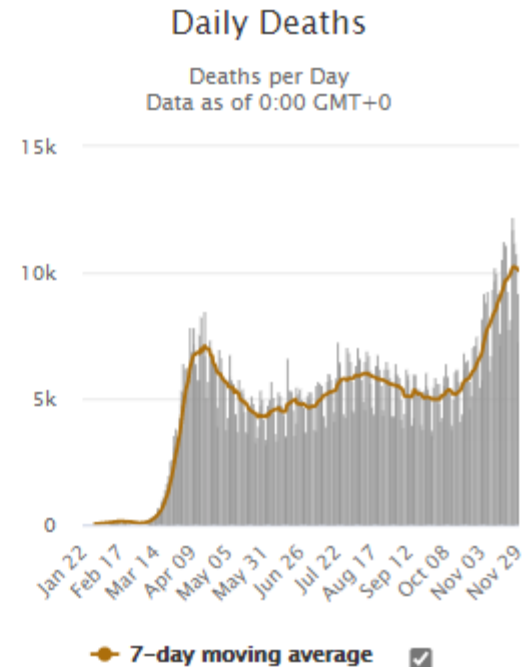
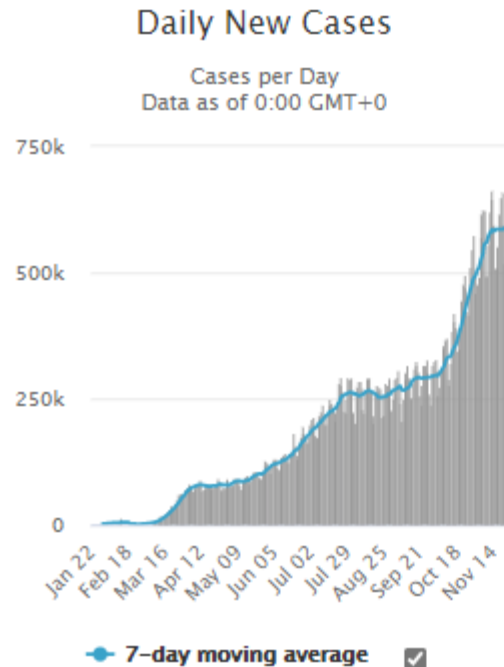
- The first **coronavirus vaccine** is on track for international deployment within weeks, with health officials on both sides of the Atlantic confident that inoculations will begin before the end of the year.
- The UK is expected to become the first country to approve a **vaccine** developed jointly by Pfizer and BioNTech, with the aim of delivering the first inoculations as soon as December 7.
- Vaccine maker Novavax Inc has pushed back the start of a US-based, **late-stage trial** for its experimental COVID-19 vaccine, due to difficulties in scaling up production.

Global

Over the past week, the rate of daily new cases of coronavirus eased, while topping 62 million. One week ago, the count was 58 million. The spread of infections in Western Europe appears to have peaked.

The upward trend for global deaths continued. Total coronavirus deaths are in excess of 1.59 million.

Markets

The head of the Tokyo Stock Exchange has resigned over a debacle that closed the \$6 trillion bourse for a day in early October and resulted in a business improvement order from the financial regulator.

- Many European stock markets are boasting their **best month ever** with France up 21 percent and Italy almost 26 percent. The MSCI measure of world stocks is up nearly 13 percent for November, while the S&P 500 has climbed 11 percent to all-time peaks.
- On Monday, **Asia-Pacific shares** edged lower while **European shares** were mostly flat.
- Saudi Arabia's benchmark **Tadawul All Share Index** on Sunday had the highest closing since July 2019.
- **Oil prices** tumbled on Monday on uncertainty about whether OPEC+ would agree to extend large output cuts at talks this week.

Business

Data giant S&P Global Inc is nearing a deal to buy IHS Markit Ltd, creating a heavyweight in the increasingly competitive market for financial information.

- **Facebook's** Libra cryptocurrency is readying to launch as early as January.
- **BAE Systems** won a £2.4 billion (\$3.20 billion) contract to keep supplying weapons and equipment to the UK armed forces.
- Sweden's **Ericsson** raised its global forecast for 5G mobile subscriptions to 220 million by the end of this year, citing faster than expected uptake in China.
- Italy's antitrust authority said on Monday it had fined **Apple** €10 million (\$12 million) for "*aggressive and misleading*" commercial practices regarding its iPhones.

Africa

- **Ethiopian** troops took Tigray's capital Mekelle over the weekend and declared defeat for the Tigray People's Liberation Front (TPLF). The leader of Tigray's forces vowed to keep fighting amid fears of a protracted guerrilla conflict.
- **Burkina Faso** President Roch Marc Christian Kaboré has won re-election in the November 22 poll with 57.87 percent of the vote, according to full preliminary results announced by the election commission.

Asia

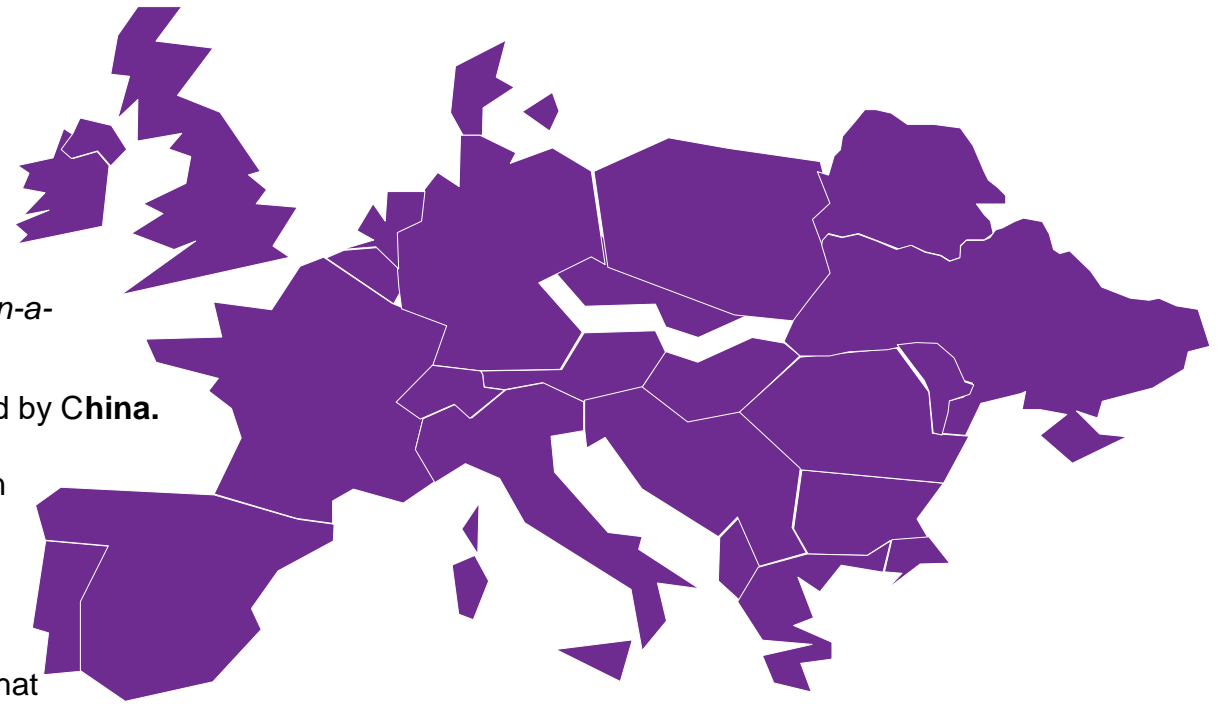
- Suspected **North Korean** hackers have tried to break into the systems of **British** drugmaker AstraZeneca in recent weeks.
- **China** plans to impose sanctions on four people working for **US** NGOs focused on democracy promotion, over what it called interference in the Asian financial hub of **Hong Kong**.
- Canberra has accused **China** of sharing a “*repugnant*” and fake image of an **Australian** soldier holding a bloodstained knife to the throat of an **Afghan** child in an escalation of diplomatic tensions.
- **Hong Kong** plans to set up a hotline to enable citizens to report on people gathering to party and dance on private yachts and homes as the territory grapples with another wave of coronavirus infections.

Europe

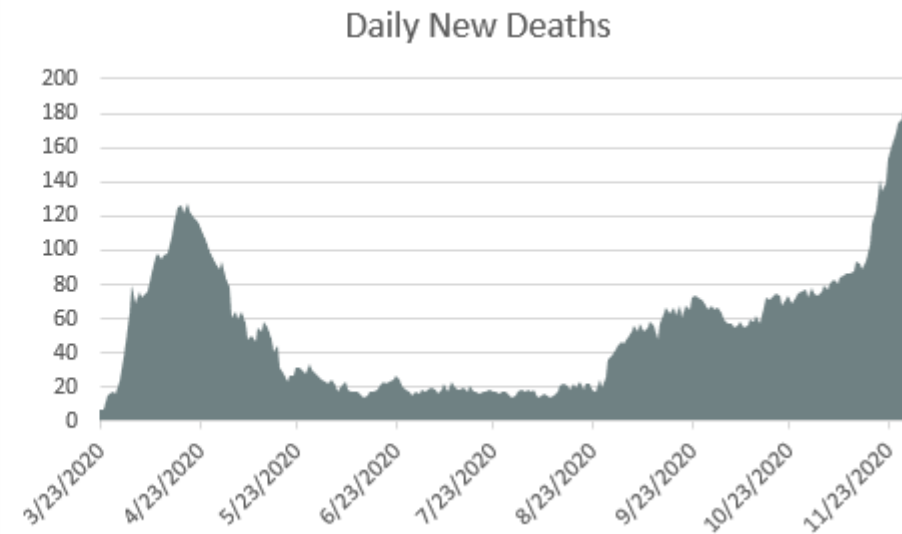
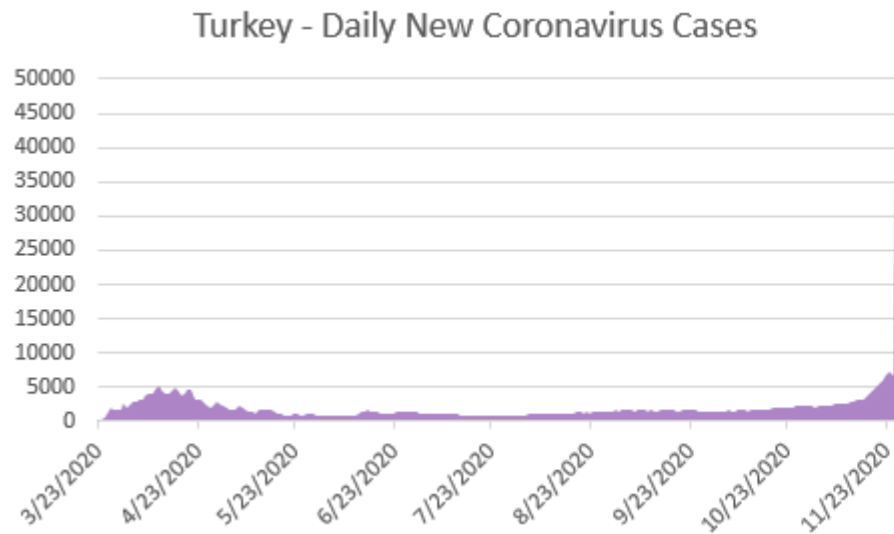
- The **EU** will call on the incoming **US** Biden Administration to seize a “*once-in-a-generation*” opportunity to forge a new global alliance, in a detailed pitch to bury the tensions of the Trump era and meet the “strategic challenge” posed by **China**.
- Approvals for mortgages for home purchases in the **UK** jumped to 97,500 in October, the highest since September 2007. The **Italian** government has approved a further support package worth €8bn for businesses struggling during the coronavirus pandemic. **Turkey** enjoyed rapid growth between July and September as the government encouraged a huge lending spree that came at the cost of a plunge in the lira.
- **Germany’s** partial lockdown measures could be extended until early Spring if infections are not brought under control, according to Economy Minister Altmaier; Germany surpassed 1 million virus cases over the weekend. Coronavirus infections in **England** have fallen by 30 percent since the latest lockdown began. In the north west and north east the decline is more than 50 percent. With deaths surpassing 52,000, **France’s** top health advisory body recommended a tiered system for the distribution of COVID-19 vaccine, with retirement homes receiving first priority and second phase which would target those aged 65 and over. **Russia’s** tally of coronavirus cases has risen as much in the past seven days as in all of September; total cases topped 2.2 million. **Turkey** continued to report record numbers of new coronavirus cases, almost 140,000 in the last four days, with more than 600,000 total cases.
- The **European Parliament** has called for sanctions on **Turkey** following President Recep Tayyip Erdogan’s controversial visit to Northern Cyprus on November 15.

Europe

Over the past week, Turkey recorded a strong surge in new coronavirus cases. The spike, however, is deceiving because it reflects a change in how Turkey is reporting new cases, previously limited to those requiring treatment, not all positive cases. The Turkish Medical Association has been warning for months that the government's previous figures were concealing the graveness of the spread and that the lack of transparency was contributing to the surge. The rising death toll in August is a better indicator of when the current surge began. ICU beds in Istanbul are nearing full occupancy. The government has imposed a nightly curfew during the weekdays and limited restaurants to takeout only.

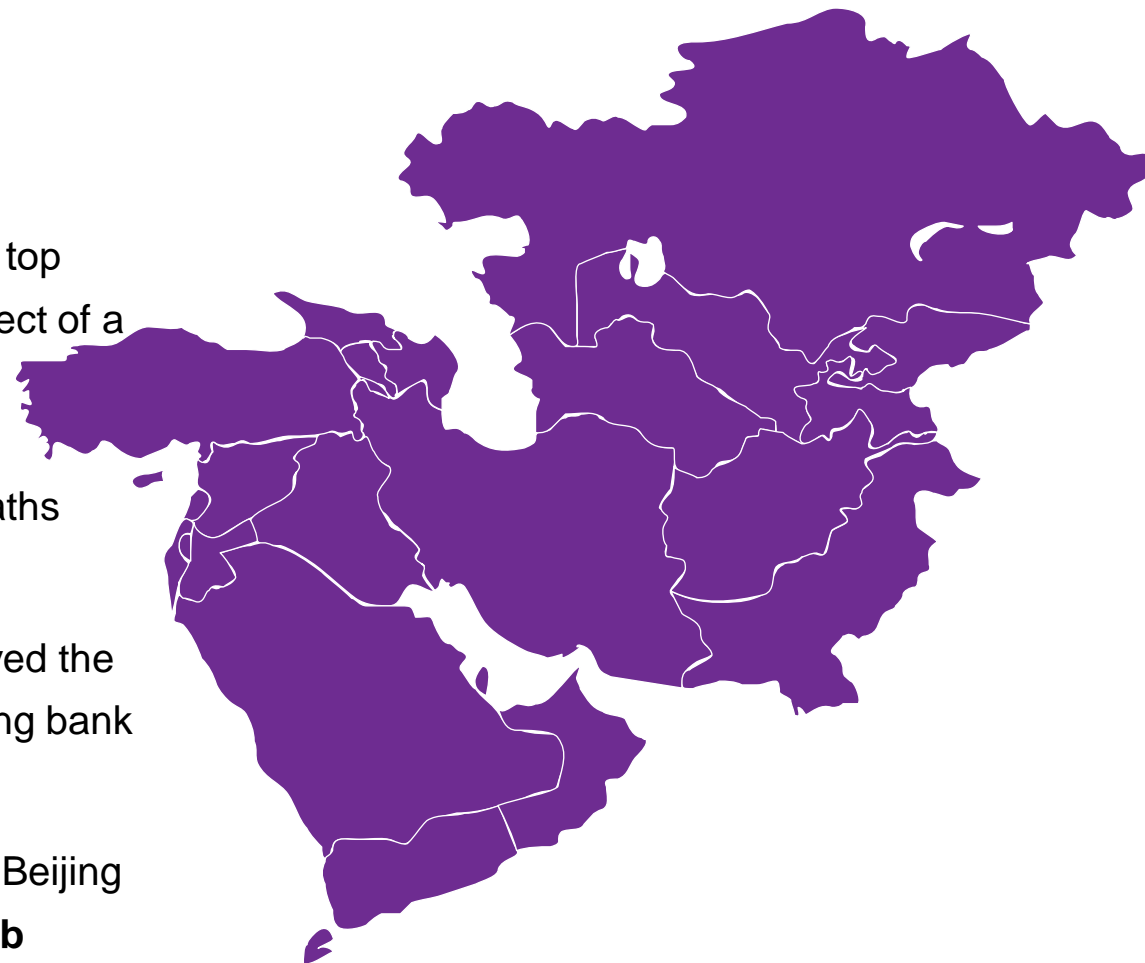

Middle East

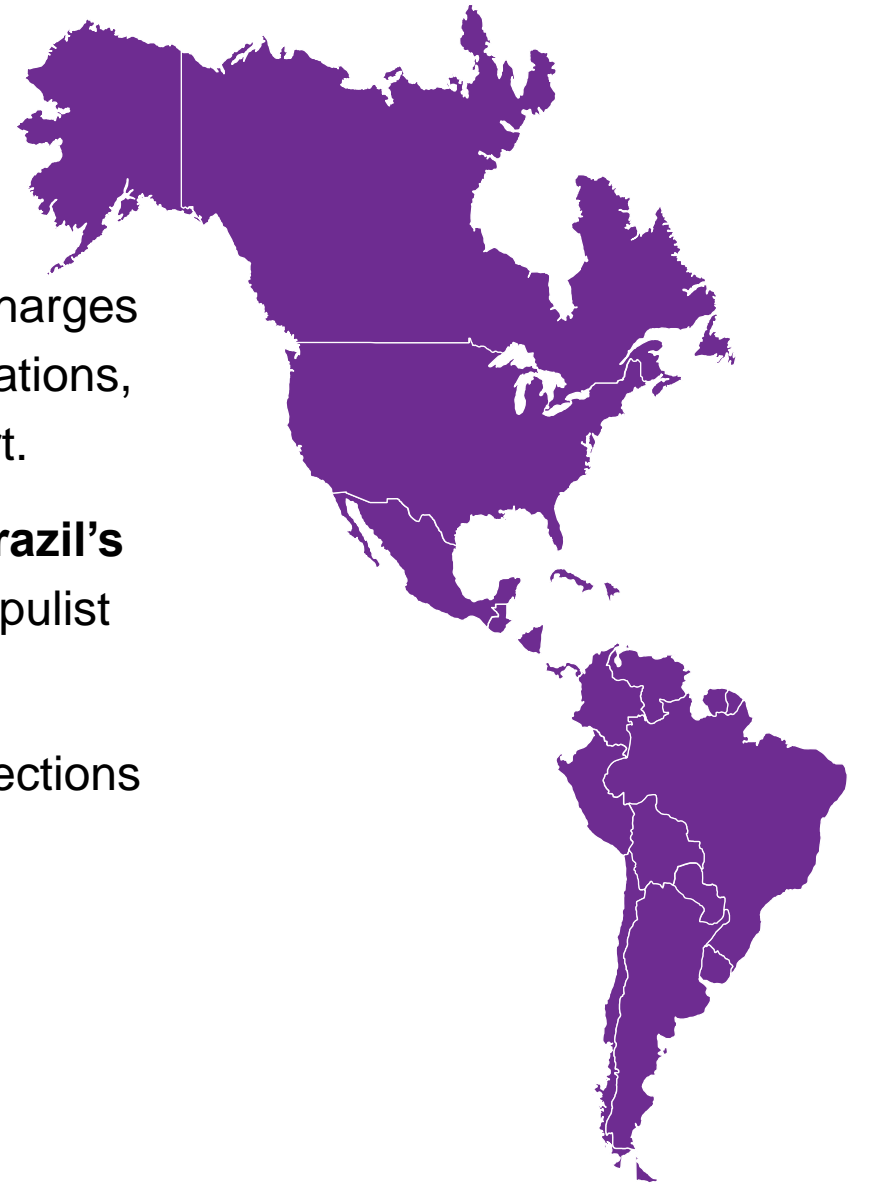
- **Iran's** supreme leader promised to retaliate for the killing of Iran's top nuclear scientist, who the West and Israel believed was the architect of a secret Iranian program to make weapons; the scientist, Mohsen Fakhrizadeh, was gunned down on Friday in Tehran. Iran's coronavirus surge continued, with cases nearing 950,000 and deaths 50,000.
- After intense political maneuvering, **Lebanon's** parliament approved the audit of all state institutions, including the Central Bank, suspending bank secrecy laws for one year.
- Abu Dhabi-based Etihad Airways will start a passenger service to Beijing from December 7, underscoring both **China's** and the **United Arab Emirates'** control of the coronavirus pandemic.
- **Israel-Lebanon** maritime border talks were postponed after Jerusalem rejects Beirut's proposals.

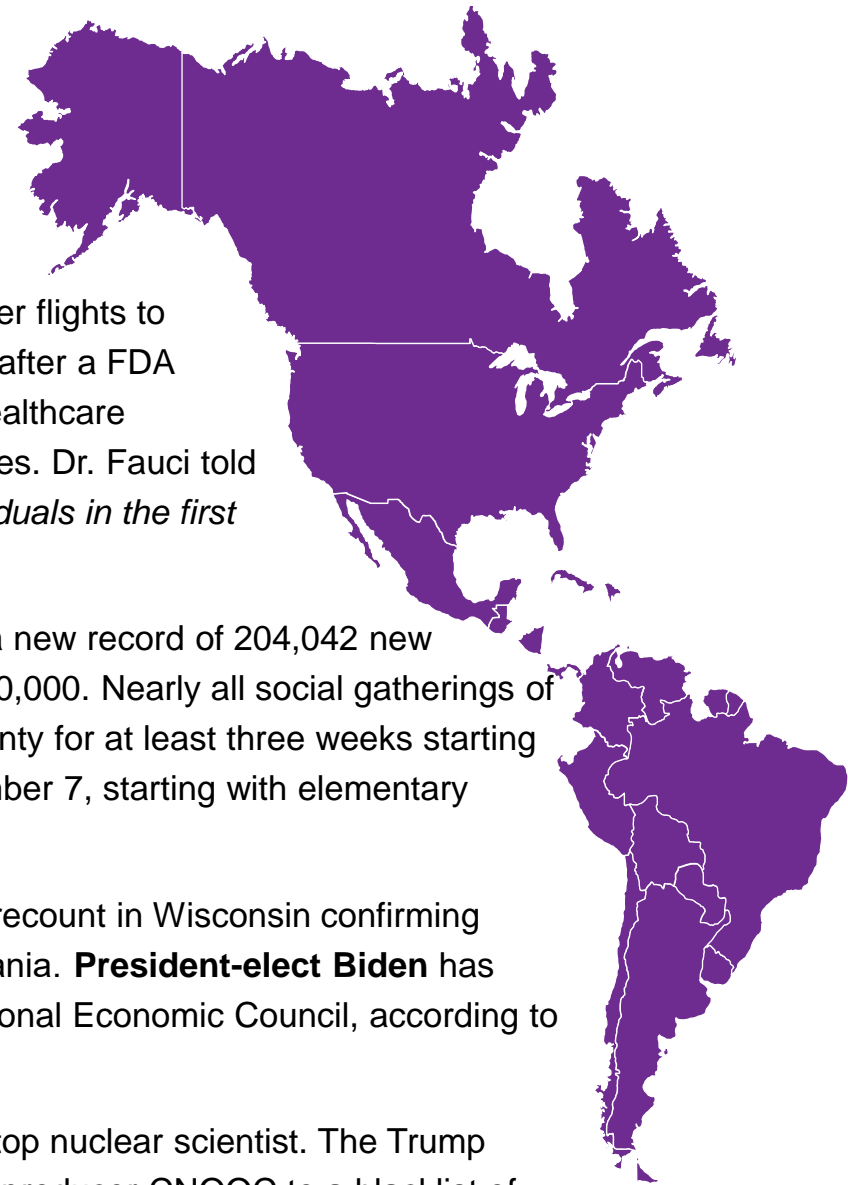
Americas

- **El Salvador, Guatemala and Honduras** have brought criminal charges against more than 700 members of cross-border criminal organizations, primarily the MS-13 and 18th Street gangs, in a **US**-assisted effort.
- Traditional center and center-right parties won the big prizes in **Brazil's** municipal elections on Sunday, while candidates supported by populist President Jair Bolsonaro floundered.
- New virus cases in **Mexico** are surging, with over 65,000 new infections last week.

Americas: US



- United Airlines has begun moving shipments of the **vaccine**, developed by Pfizer Inc, on charter flights to ensure it can be quickly distributed once it is approved. US approval could be granted shortly after a FDA advisory meeting on December 10. The CDC is expected to recommend that the FDA allow healthcare professionals and long-term care facilities to be the first two groups to get initial vaccine supplies. Dr. Fauci told NBC on Sunday: *“We likely, almost certainly, are going to be vaccinating a portion of the individuals in the first priority before the end of December.”*
- Over the weekend, the nation surpassed **13 million confirmed infections** and on Friday, set a new record of 204,042 new cases. **California** surpassed 1.2 million cases, **Illinois** 700,000 and **Wisconsin and Ohio**, 400,000. Nearly all social gatherings of individuals from more than a single household will be banned in **California’s** Los Angeles County for at least three weeks starting Monday. **New York City’s** public schools will begin to reopen for in-person learning on December 7, starting with elementary schools for students whose parents agree to a weekly testing regimen.
- President Trump persisted with efforts to challenge the **outcome of the election**, despite the recount in Wisconsin confirming Biden’s victory and the federal appeals court dismissal of Trump’s legal challenge in Pennsylvania. **President-elect Biden** has picked Brian Deese, a White House advisor during the Obama administration, to head his National Economic Council, according to the *New York Times*.
- US aircraft carrier USS Nimitz deployed to the Gulf this week, days before the killing of **Iran’s** top nuclear scientist. The Trump administration is poised to add **China’s** top chipmaker SMIC and national offshore oil and gas producer CNOOC to a blacklist of alleged Chinese military companies.

2020 US Ballot Initiatives

While most media attention was focused on the dramatic presidential and Congressional races of the 2020 elections, ballot initiatives swept through a series of important state-level policy changes this November. In particular, breakthrough reform in drug legalization and electoral processes may set the stage for wider changes in US policy, while nationwide observers again looked to California initiatives as potential bellwethers of future policy trends.

The Green Wave: Marijuana Legalization in Five States

New Jersey, Montana, South Dakota, and Arizona voted to legalize recreational marijuana, passing ballot measures with decisive margins. Mississippi and South Dakota both also legalized medical marijuana, making South Dakota the first state ever to approve medical and recreational marijuana measures at the same time. This latest round of ballot measures means that recreational marijuana is now legal in 15 states and District of Columbia, while medical marijuana use is legal in 35 states and District of Columbia. Colorado-based business news outlet

Marijuana Business Daily projects that these breakthroughs for the marijuana industry could generate over \$2.5 billion in cannabis sales over the next four years.

The latest round of victories for marijuana legalization is indicative of such policies' growing popularity. Arizona voted on a similar measure in 2016 which was narrowly defeated; this year, however, the proposition passed by a vote of 60-40 percent, despite opposition from Arizona's Republican governor. Similarly, in South Dakota, Republican Governor Kristi Neom campaigned against both legalization measures, but medical legalization

(Measure 26) passed with almost 70 percent of the vote, while recreational legalization (Amendment A) passed with 54 percent. The show of bipartisan enthusiasm for marijuana legalization is likely to propel plans in further states. In particular, New Jersey's success is likely to inspire further northeastern states to legalize marijuana; New York Governor Cuomo has expressed support for new cannabis policy, and state leaders in Pennsylvania and Connecticut are calling for legalization as well. While significant political resistance to the policy remains, particularly in the Republican party, the impact of marijuana legislation on tax revenues and the criminal justice system has boosted support for legalization even among voters not concerned with marijuana use. This broad perspective may also help drive policy towards federal decriminalization; for example, Vice President-elect Kamala Harris has famously pledged to expunge the criminal records of people convicted for cannabis-related offenses in the past, a policy focused on the intersection of marijuana law and the criminal justice system.

Drug Decriminalization: Oregon Ballot Measures 109 & 110

Oregon passed one of the most attention-grabbing ballot initiatives of the election, Ballot Measure 110: The Drug Decriminalization and Addiction Treatment Initiative, which passed with almost 60 percent of the state's vote. The measure reclassified non-commercial drug possession offenses of Schedule I-IV substances (which includes drugs such as heroin, cocaine, and methamphetamines), as a Class E violation rather than a Class A misdemeanor. This means that while individuals who manufacture or distribute illegal drugs are still subject to criminal penalties, individuals possessing small amounts of drugs are only subject to either a \$100 fine or a completed health assessment, conducted at an addiction recovery center. The measure also established the Drug Treatment and Recovery Services Fund, which will receive money from the Oregon Marijuana Account and state budget savings from reduced costs of arresting and incarcerating drug offenders. The measure has caught the interest of public health and addiction experts around

the country. Many welcome Oregon's new approach to drug crime policy as a shift away from punishment and towards a focus on health and recovery. Others argue that removing the threat of criminal penalties will lead to increased drug abuse and hinder law enforcement's ability to address drug issues.

Oregon also became the first state to legalize psilocybin mushrooms, more commonly known as "magic" mushrooms, through ballot measure 109, which passed with 56 percent support. However, psilocybin mushrooms will not share the same legal status as cannabis, which has been legal for recreational use since 2014. Rather, once regulatory details are worked out over the next two years, licensed facilities will be allowed to store and administer psilocybin.

Voting Against the Electoral College: Colorado Proposition 113

This year Colorado became the first state to affirm the National Popular Vote Interstate Compact at the ballot box, narrowly

passing the proposition with 52 percent of the vote. In 2019, Colorado lawmakers became the first swing state (although it is becoming reliably blue) to join the Compact, which pledges to delegate the state's electoral vote to the winner of the popular vote, essentially making the electoral college obsolete without removing it from the constitution. However, the Compact only kicks in once states representing 270 electoral votes join – currently it has only 15 states (California, Illinois, New York, Delaware, Hawaii, Rhode Island, Vermont, Colorado, Connecticut, Maryland, Massachusetts, New Jersey, New Mexico, Oregon and Washington), plus District of Columbia, which total to 196 electoral votes. Colorado's addition turned into a ballot measure referendum because opposition to it gained sufficient signatures. As Democrats have won the popular vote in every election but one over the past two decades, the question of overriding the Electoral College has become increasingly partisan, with Republicans leading resistance to the movement.

Regulating the Gig Economy: California's Proposition 22

Proposition 22 (commonly called “Prop 22”), one of the most controversial and widely watched ballot initiatives of the year, passed with almost 60 percent of the state’s vote. Seen as the first of many electoral battles for the gig economy, Prop 22 exempts app-based transportation (rideshare) and delivery driver firms from having to classify their workers as employees rather than independent contractors. The ballot measure allows the companies to sidestep California’s Assembly Bill 5, which went into effect last January and created an “ABC” test of three requirements that employers must meet to register workers as independent contractors. The proposition’s success delivers a win for the likes of Uber, Lyft, Doordash, Instacart, and Postmates – who backed the initiative with nearly \$200 million, making it the costliest ballot measure in California history. Opponents, namely labor unions, spent closer to \$20 million, causing many to question the equity of advertising on proposition – firms like Uber also promoted the measure on their own apps and services. The passage of Prop 22 is likely to have

implications beyond California, given the frontier nature of legislation on the gig economy. Proponents argue that it helps the gig economy, but critics worry it could worsen the prospects for protecting gig workers from exploitation – undermining the intentions of laws like Assembly Bill 5.

Affirmative Action: California's Failed Proposition 16

California’s Proposition 16, which would have repealed the state’s 1996 ban on affirmative action in public employment, education and contracting decisions, was rejected by a 57-43 percent vote. Given the state’s reputation as a stronghold of diversity and liberal politics, the decision came as a surprise to many, and has prompted a flurry of speculation about how the decision may impact future prospects for affirmative action across the country.

Ranked-Choice Voting: Alaska Ballot Measure 2

In a tight vote, Alaska’s Ballot Measure 2 passed by only a margin of only about 4,000 ballots. Measure 2 is a unique combination of election reforms that will cause sweeping

changes to how the state conducts elections, changing both how primaries are held and instituting ranked-choice voting. Alaska will now hold one open primary, in which the top four candidates, regardless of party affiliation, proceed to the general election. Ranked choice voting allows voters to rank their candidates from least preferred to most preferred. When ballots are counted, the candidate with the fewest first-place votes is eliminated, and their voters switch to chosen second-place candidates. Maine already uses ranked-choice voting, and many voting reform activists are enthusiastic about the policy. Both of Measure 2's reforms are designed to address issues of partisan divisiveness and polarization, as both open primaries and ranked-choice voting are thought to reward non-polarizing figures who appeal across groups of voters. The reforms also open the door for third party candidates to gain a platform. In Alaska, where almost 60 percent of registered voters are independents, this third-party element is particularly important. However, opponents also warn that the new system will be logistically challenging and may cause hurdles for orderly elections.

While Measure 2 will dramatically change how Alaska conducts elections, similar electoral reform measures in other states failed to pass. Florida's Amendment 3 would have instated top-two open primaries for a series of state-level offices, meaning that the top two primary candidates would go to the general election, regardless of party. However, Amendment 3 failed to reach the 60 percent threshold to pass, although it received a majority 57 percent of votes. Massachusetts Question 2, which would have instituted ranked-choice voting, also failed by a vote margin of 55 to 45 percent.

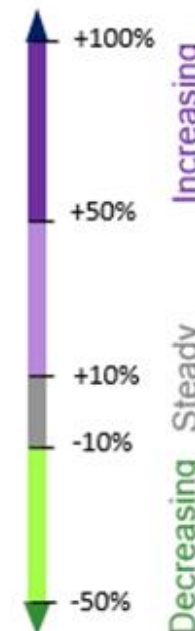
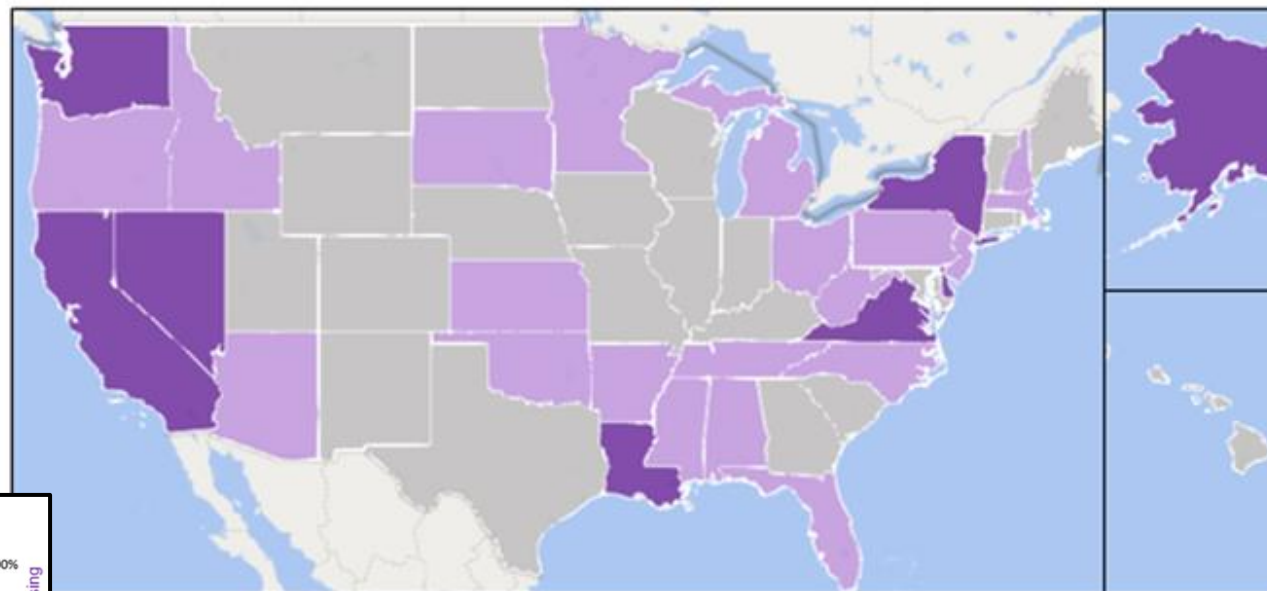

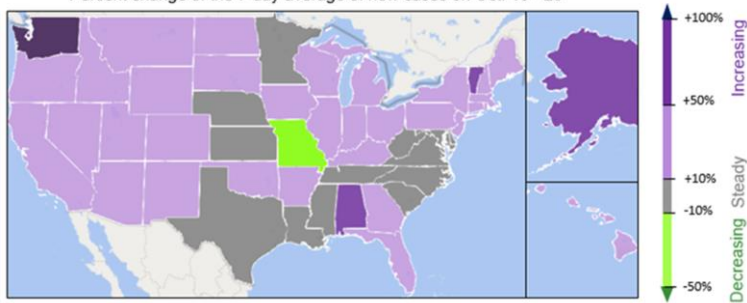
Change in new COVID-19 cases in the past week

Percent change of the 7-day average of new cases on Oct. 19 - 25



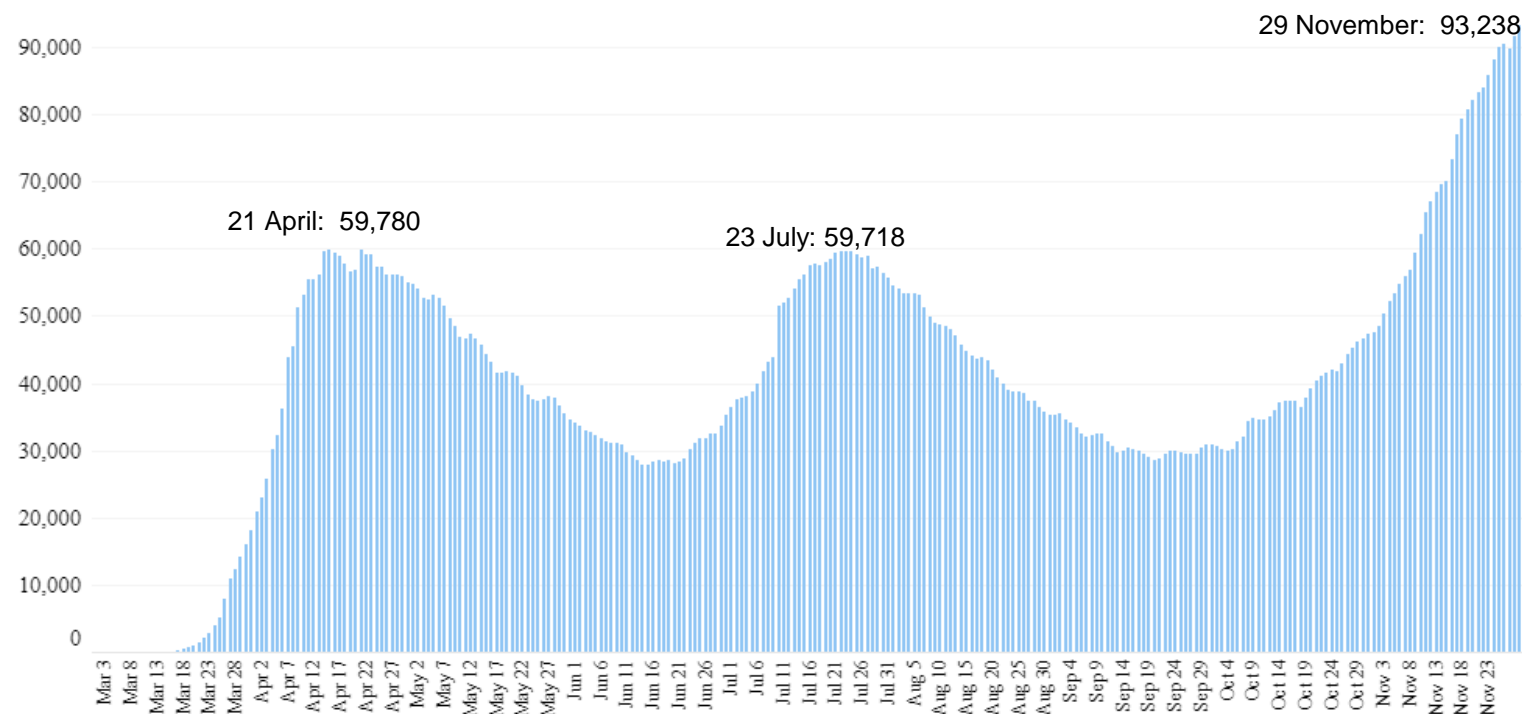

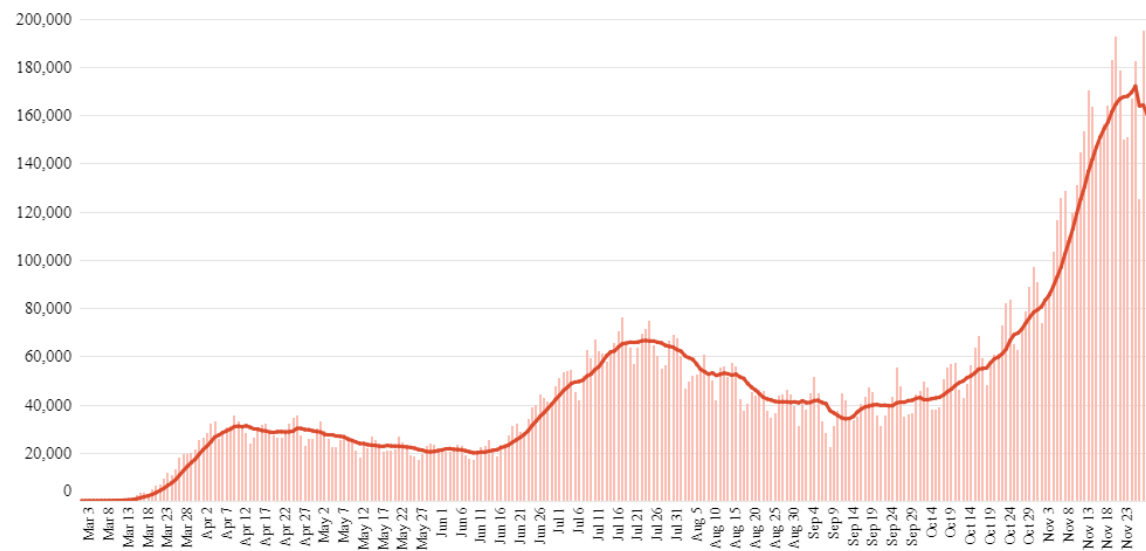

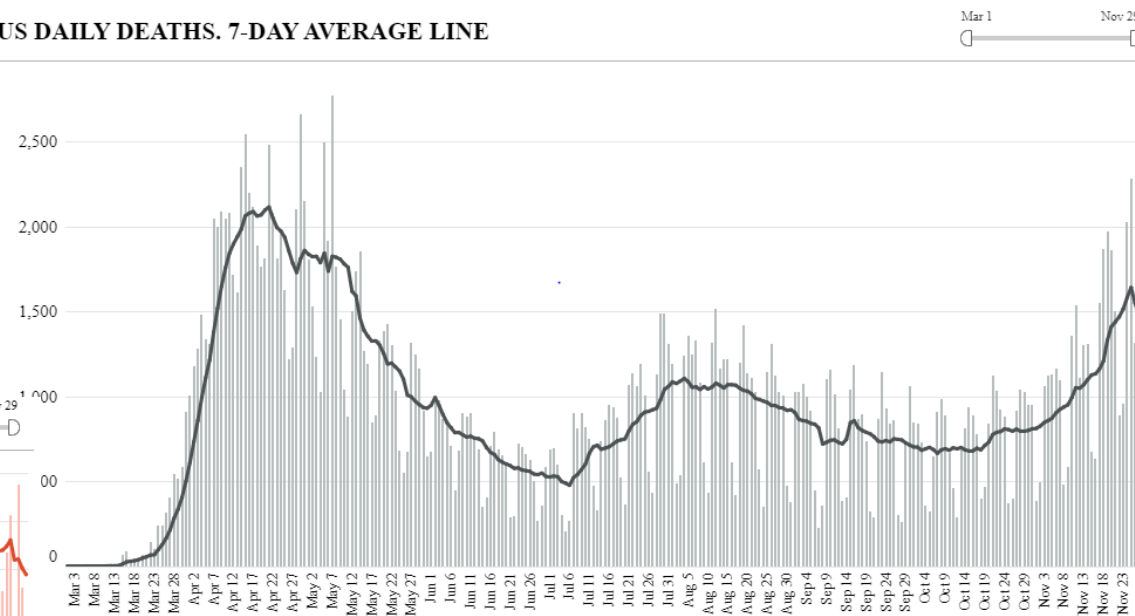

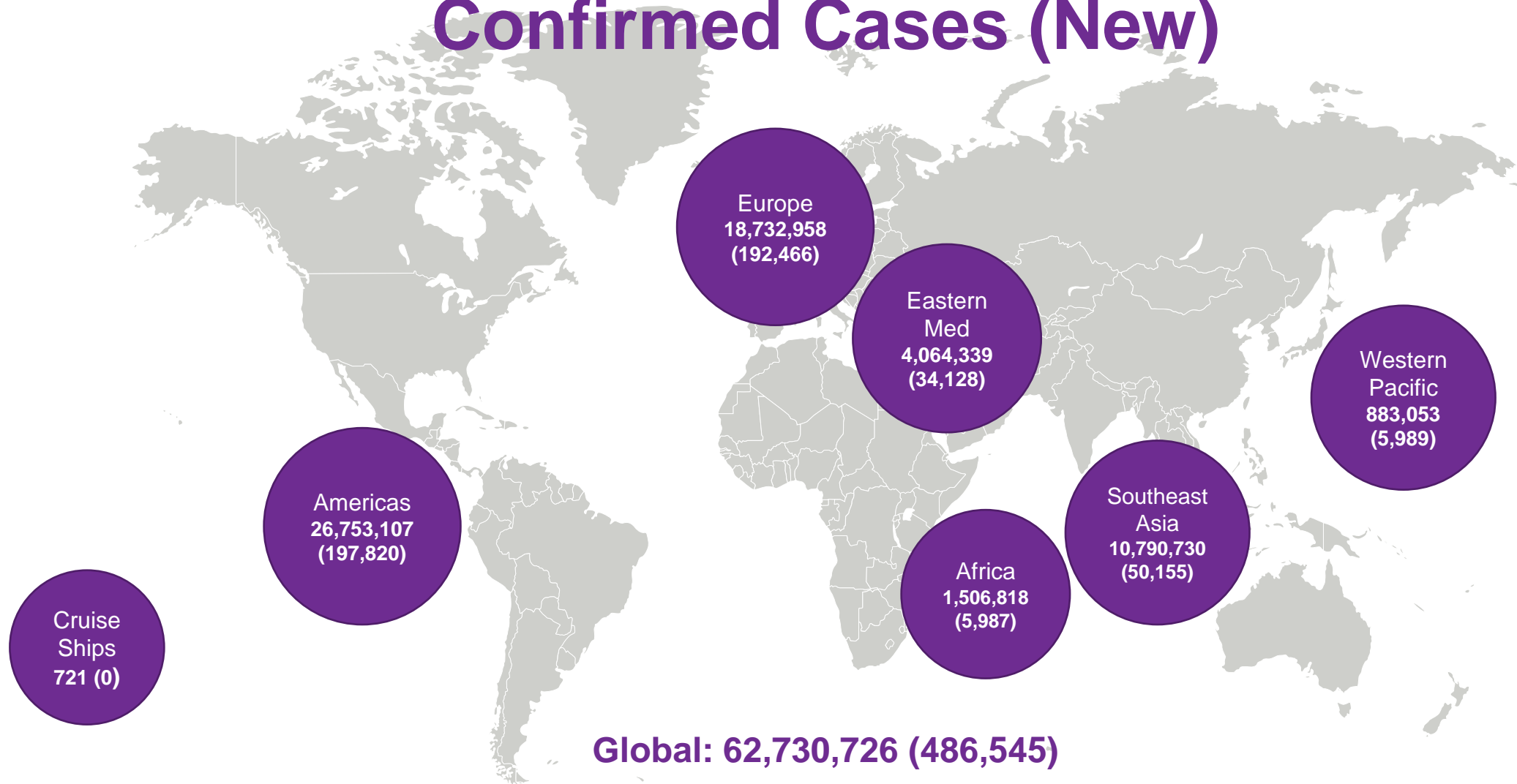

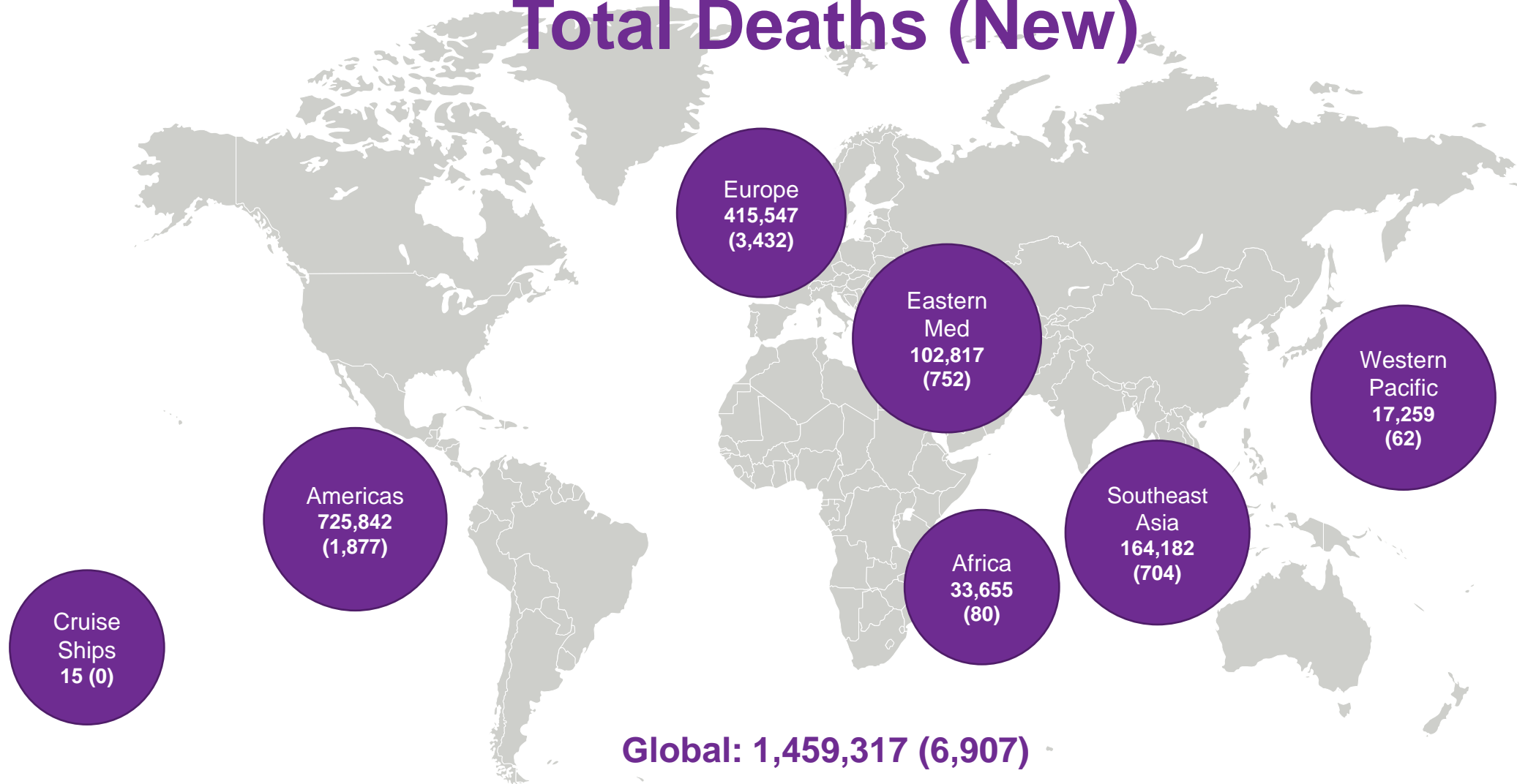
Confirmed Cases (New)

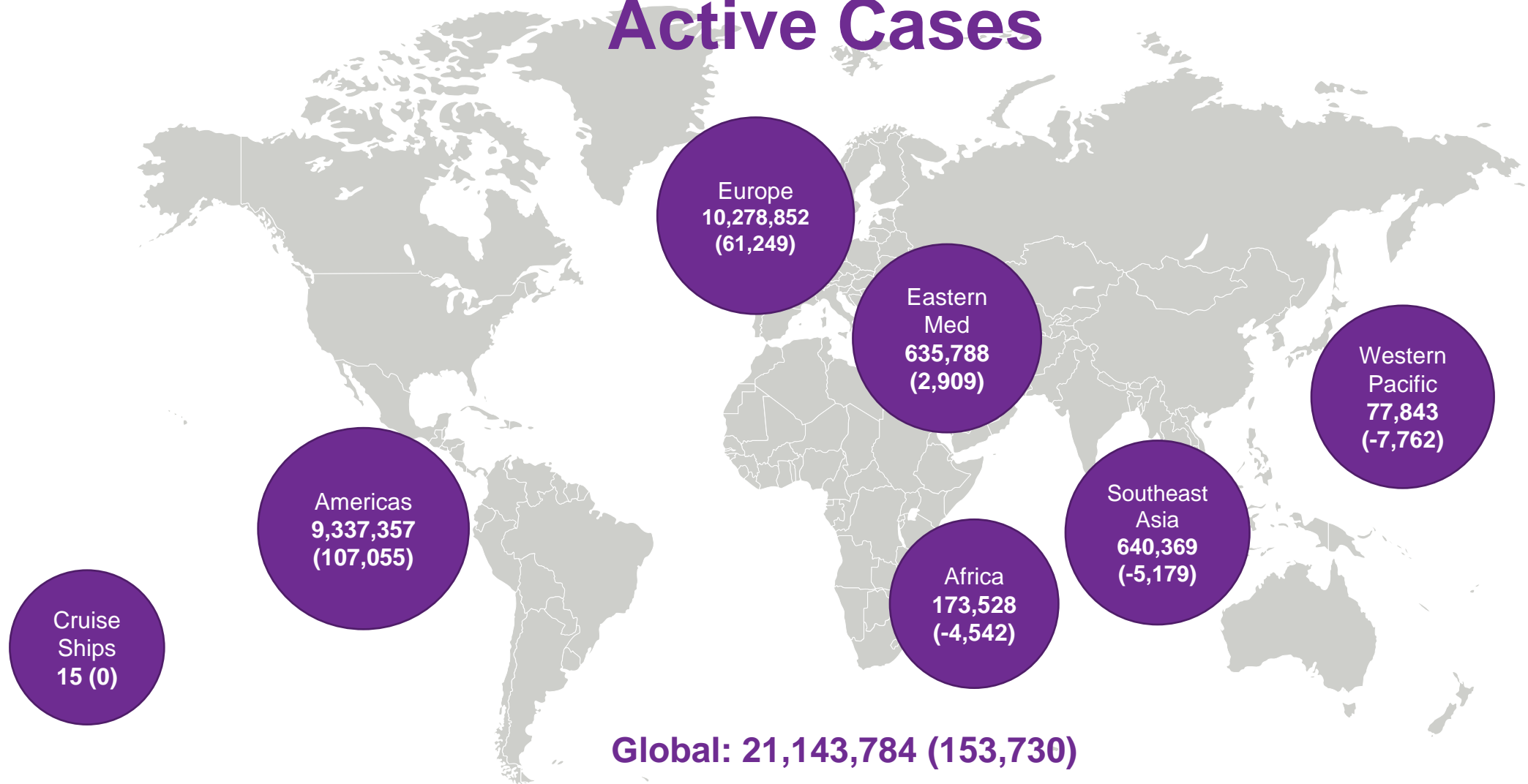
Total Deaths (New)
