Global

Overnight, confirmed coronavirus cases rose to 30,063,255 in 213 countries and territories, with 945,542 deaths.

- Smoke from **wildfires** on the US' western coast will reach Europe this week.
- Early trials show Eli Lilly's antibody treatment to be effective in reducing the rate of hospitalization for COVID-19.
- Turkey began Phase III trials of a Chinese experimental **vaccine**.



Markets

The Fed said overnight it would keep interest rates near zero until inflation is on track to "*moderately exceed*" the central bank's 2 percent inflation target "*for some time*," but stopped short of offering further stimulus to shore up a battered U.S. economy.

- European stocks opened down on Thursday, investors left uneasy that the US Federal Reserve stopped short of promising changes to its massive bond-buying program.
- Asian stocks also closed down.
- **US stocks** lost ground, reflecting sluggish retail and food recovery and concerns about a slow recovery.

- The **Turkish lira** fell past 7.5 to the dollar, bypassing a symbolic threshold, likely to leave unchecked rampant inflation.
- **Oil prices** jumped more than 4 percent as US supply suffered due to a hurricane on the Gulf of Mexico.
- The collapse of bond yields in the developed world is driving investors back into battered emerging markets, fueling gains despite a series of high-profile defaults and concerns about the pandemic's blow to fragile economies.

Business

Investment flows between China and the US fell to their lowest level in almost a decade in the first half of the year.

- The Trump Administration will reportedly push for majority American ownership of **TikTok**; **Oracle** said they would review TikTok's source code to check for Chinese access.
- El Al Airlines raised \$148m in a governmentmandated share offering that will allow it to access government aid.
- **GE** expects profits to return in the second half of 2020.
- **JP Morgan** will stop reimbursing junior staff for Uber rides to the office, previously introduced as a coronavirus-related precaution.

- Canadian insurer **Manulife** will reinstate some coronavirus-related travel insurance coverage after initially removing most pandemic-related policies.
- German auto supplier Mahle will cut 7,600 jobs.
- Germany's BioNTech has agreed to buy a specialist production facility from Swiss pharma giant Novartis, which will allow it to deliver more than 500m additional doses of its Covid-19 vaccine next year.
- A seven-hour "flight to nowhere" advertised by Australian airline Qantas sold out within 10 minutes on Thursday

Africa

- **Mozambique's** defense minister called videos of apparent soldiers committing atrocities, which have sparked international outrage and the military has condemned as "*horrifying*," an attempt to denigrate the military.
- Rwandan prosecutors said that Paul Rusesabagina, portrayed in "Hotel Rwanda," could face life in prison over terrorism charges.
- South Africa will open for international travel from October 1.
- **Mali's** military junta said they had begun the process of naming an interim president after facing rebuke for passing a deadline imposed by ECOWAS without clarifying the transition.





Asia

- The Red Cross warned that the novel coronavirus is driving discrimination towards vulnerable communities in **Asia**, including migrants and foreigners.
- Malaysia surpassed 10,000 confirmed virus cases.
- **Thailand's** opposition leader questioned spending by the royal family as the economy struggles due to the pandemic.
- Yoshohide Suga officially became **Japan's** new Prime Minister, forming a *"continuity cabinet"* containing about half of former PM Abe's ministers.
- Vietnam will resume commercial international flights with six Asian destinations.
- A prominent Chinese finance professor said that China needs to develop new capabilities to investigate foreign investment and breaches of Chinese law by foreign companies. Hong Kong called on the Trump Administration to drop requirements requiring a "Made in China" label on domestically produced products.
- The US will send a top State Department official to Taiwan for the funeral of a former president, a move likely to stoke tensions with Beijing. The US reportedly plans to sell as many as 7 major weapons systems to Taiwan. China said military drills near Taiwan are a "necessary action."

Europe

- The EU's von der Leyen called for stricter emissions controls and more relaxed migration policies throughout the bloc.
- France revised up its economic forecast to -10 percent from -11 percent. Paris' expanded bike lanes will be made permanent after the pandemic.
 French COVID testers plan a strike over unsafe working conditions.
- Hundreds of Jewish pilgrims were denied entry to the **Ukraine** for Rosh Hashana due to coronavirus restrictions.




- **Spain's** total deaths jumped 239 cases in 24 hours, with 11,193 new cases, a new high amid a virus resurgence in the country. The Bank of Spain estimated that national economic output would remain up to 6 percent under pre-virus estimates by end-2022.
- PM Johnson said that the **UK** will boost testing to 500,000 per day by the end of October. Areas of northeast England will be subject to further coronavirus restrictions from Friday.
- An **Irish** case modelling group warned that Ireland is on the cusp of "exponential" case growth.
- The **UK** said that **Russian** spies were almost certainly behind the Navalny poisoning Russia said that negative reporting over the poisoning of Navalny is negatively affecting plans to borrow on the international market..



Europe

New coronavirus infections in Spain grew over the past 7 days by an average of 9.8 percent. The second wave is more intense than the initial onset, as Madrid has rejected a renewed lockdown. The death rate, while increasing, is not as high, reflecting more effective treatments.

Middle East

- The US will return to the UN Security Council this week to invoke snapback sanctions on Iran.
- Lebanese leaders failed to form a new government by the deadline set in French President Macron's reform plan.
- A rocket hit the Green Zone in Baghdad. Confirmed coronavirus cases surpassed 300,000 in **Iraq**.
- The **Israel and Dubai** diamond exchanges have signed an agreement to promote cooperation between the Middle East's main diamond hubs.
- **Israel** reported a record 6,063 new virus cases yesterday as the country settles into a three-week lockdown. The UN agency for Palestinian refugees warned that it will halt more services amid a budget crisis.
- The head of the internationally recognized Libyan GNA, PM Sarraj, announced his intent to resign by the end of October following widespread anti-government protests. Turkish and Russian officials said they had moved closer to a Libya ceasefire deal in recent Ankara talks.
- Somali money transfer companies moved more than \$3.7 million in cash between suspected weapons traffickers in recent years, including to a Yemeni under US sanctions for alleged militant links, according to a watchdog report.
- Sudan arrested 41 people in possession of enough explosives to "destroy" Khartoum, the capital. The UN estimate that some 650,000 have been affected by historic floods in Sudan.

Americas

- Barbados says it will remove Queen Elizabeth as head of state and become a republic.
- UN experts accused the **Venezuelan** Maduro government of crimes against humanity, citing reports of torture and targeted assassination of dissidents by secretive security forces.
- **Bolivian** polls show Luis Arce, the candidate of former socialist president Evo Morales' party, with a wide margin for victory in next month's presidential election.
- WHO Director Ghebreysus warned that Latin America is opening too quickly.
- Ontario's top medical expert called for smaller class sizes throughout Canada as cases rise.



Americas: US

- Hurricane Sally caused wind damage in Alabama and severe flooding in Pensacola, Florida.
- The Fed boosted its forecast of the US economy, predicting that unemployment will fall to 7.6 percent by the end of 2020. President Trump called for large economic stimulus including individual payments, contradicting the GOP position. NY Mayor de Blasio will furlough himself and 500 city hall workers for one week, citing budget crisis. Advance reports on August retail and food sales data show a slower than expected rise. Homebuilder confidence rose to a record high. The Trump Administration is considering \$300m in aid to oil refiners.
- The director of the CDC told Congress that after a vaccine is developed, it may take 6 to 9 months for enough Americans to get the vaccine to significantly affect the pandemic; President Trump contradicted, insisting that distribution will begin in October, within 24 hours of FDA approval.
- **Major League Baseball** reached an agreement to expand the league's post-season with bubbles in two cities, and the possibility of spectators. **US college football's** Big Ten reversed course and will start the season in October.
- US intelligence officials reversed course, saying they would provide in-person briefings to members of Congress on election interference.
- A Senate report found that controversial new USPS policies widely seen as politically-motivated delayed 7 percent of the country's mail. The health department's top communications official was put on leave after posting a Facebook accusing liberal states of planning an armed insurrection. Democrats demanded a probe after whistleblower reports that ICE has conducted forced hysterectomies at border facilities.



Russia Update: Belarus and Navalny

Since the August 9 presidential election, hundreds of thousands of protestors in Belarus have taken to the streets in Minsk and across the country to protest the rigged electoral process. Meanwhile, prominent Kremlin critic and anti-corruption activist Alexey Navalny has awoken from a medically-induced coma after being poisoned on a flight from Siberia to Moscow. Both events have triggered massive international economic and political implications of the recent developments in Belarus and Russia.

The unprecedented scale of the demonstrations, as well as the duration and staying power of the movement, has surprised even close Belarus-watchers and Eurasian analysts. Incumbent Belarusian President Alexander Lukashenko also appeared to be caught off-guard by the civil unrest, having only experienced minor protests over his 26 years in power. Although Lukashenko and his security forces have cracked down on the protestors in recent weeks through arrests, detentions, and other forms of violence, the Belarusian people continue to flood the streets, while exiled political opposition coordinates both domestic and international responses to Lukashenko's intransigence. On Tuesday, the European Union's high representative for foreign affairs declared that the bloc does not

recognize Lukashenko as the legitimate president of Belarus, and that the August 9 elections were fraudulent and marred by vote rigging and other forms of electoral corruption.

Amid the ongoing domestic upheaval, Lukashenko traveled to Sochi, Russia to meet with President Putin, where the two leaders discussed their bilateral relations and responses to the ongoing domestic crises and coronavirus pandemic. Among the issues raised was the prospect of a \$1.4 billion loan to Belarus, as well as increased economic and political integration measures between the two countries. Although there are no explicitly stated conditions attached to this loan, Moscow is likely to use this financial lifeline to leverage their political aims and

and keep Belarus from drifting into Europe's orbit. Lukashenko stated that he also asked Putin for several types of new weapons systems and military equipment, a request that comes amid a period of joint Russia-Belarus military drills through late September. These drills have included live exercises demonstrating Moscow's ability to deploy forces to Belarus on "short notice," a worrying sign as Putin has recently confirmed the existence of a "law enforcement" battalion stationed on the Belarusian border, should the civil unrest in Minsk continue to escalate.

Meanwhile, prominent Kremlin critic and anti-corruption activist Alexey Navalny has awoken from a medically-induced coma after being poisoned on a flight from Siberia to Moscow. After a medical evacuation to Berlin, three separate European blood tests revealed that Novichok, a Soviet-era chemical nerve agent, was used in the attempt to take Navalny's life. Supporters of the opposition leader and, most recently, the British government claim that Putin or his operatives were responsible in poisoning Navalny while he was in Siberia building political networks and organizations for the September 13 regional elections. The Kremlin has predictably denied these accusations while also threatening to turn the incident into

another flashpoint between Moscow, Brussels, and Washington. In a cruel twist, the Kremlin has appointed Andrei Lugovoi to the committee responsible for investigating Navalny's poisoning. Lugovoi, a member of the Russia Duma and former KGB officer, gained notoriety in 2006 for his role in the Alexander Litvinenko poisoning in London. Russia has repeatedly rejected the UK's request for Lugovoi's extradition, which has remained a point of contention between the two countries.

There are several massive international economic and political implications of the recent developments in Belarus and Russia. The first is the status of Nordstream II, an \$11 billion project to carry natural gas from Russia to Germany. As a result of Navalny's poisoning and status in a Berlin hospital, there have been renewed calls on both sides of the Atlantic to cancel the pipeline, which is already over 90 percent completed but remains unfinished because of US sanctions. Although German Chancellor Angela Merkel has strongly supported the project, she has recently hinted that she may be softening her position as a result of perceived Russian bad behavior related to Navalny and Moscow's handling of domestic human rights issues. Furthermore, as a result of the domestic shale

boom, the US is now in a position to meet Europe's demand for natural gas and reduce their dependence on exports from Russia. The Navalny poisoning has thrown another wrench in the already-fragile relations between Brussels and Moscow, especially as tensions rise in Belarus.

Although Lukashenko's appeals to Russia for security and economic assistance are unsurprising, there are significant risks in the Belarusian president's efforts to tie his country closer to Moscow. The popular demonstrations have shown unprecedented durability, even as the state security forces become increasingly violent in cracking down. Lukashenko is no longer viewed as the legitimate leader of Belarus, either inside the country or in Europe, and has no institutional path back to power. His attempts to stay in power will only succeed if he dramatically escalates the crackdowns on the protestors and there are no further defections within the Belarusian security forces. Previously, it would have been enough to let the demonstrations burn themselves out - now, Lukashenko has brought the attention of the international community onto Belarus through his own mismanagement of the crisis as well as the effective organization and

coordination of the opposition parties. The meeting between Putin and Lukashenko on Monday indicated that Moscow will increase its involvement through military assistance and financial support. Putin likely views the situation in Belarus as an opportunity to fully reincorporate Belarus into the Russian orbit - Lukashenko's desire to show independence from Moscow over the last several years, combined with his diplomatic outreach to Washington and the EU, had begun to sound alarm bells in the Kremlin.




Coronavirus Condition Updates

As of 2100 hours US EDT on September 16




Confirmed Cases (New)




