Global Situation Update: April 7, 2021

WHAT WE'RE WATCHING

Greenland held parliamentary elections yesterday, with left-wing opposition party IA winning more than a third of votes. Mining projects in Greenland are increasingly politically sensitive, and IA-led government would likely impede future mining operations. With its vast deposits of rare earth metals (which many international companies are keen to exploit) the election could therefore impact Greenland's long-term economic outlook, potentially hurting the independence prospects for the autonomous Danish territory.







Global

Globally, confirmed coronavirus infections surpassed 132.3 million, with deaths surpassing 2.8 million.

- The IMF predicted that most advanced economies will emerge from the pandemic with little lasting damage, due to the monetary and fiscal response efforts marshalled by authorities.
- Finance officials from the G20 are poised to back a \$650 billion boost in the IMF's emergency reserves and extend a freeze on debt payments as part of an effort to help developing countries still struggling to combat the COVID-19 pandemic.
- Japan's Takeda Pharmaceutical suspended development of a COVID-19 plasma therapy after it failed to prove effective in clinical trials.

- One in three COVID-19 survivors in a study of more than 230,000 mostly American patients were diagnosed with a brain or psychiatric disorder within six months, suggesting the pandemic could lead to a wave of mental and neurological problems, per a new Oxford University study.
- The Biden administration has floated the idea of a boycott
 of the 2022 Beijing Winter Olympics to protest against the
 persecution of Uyghurs in China's Xinjiang province.
- The number of billionaires soared last year, according to Forbes' annual ranking, reflecting a massive accumulation of personal wealth that stands in sharp contrast with the economic struggles of many caused by the pandemic.



COVID-19 Vaccine

The Serum Institute of India, the world's largest vaccine manufacturer, could resume exports of the Oxford/AstraZeneca vaccine in June provided domestic cases of coronavirus are falling.

- Moderna announced that deliveries this month of its COVID-19 vaccine are on track to meet the number of doses previously communicated to governments.
- The EU drug regulator will launch an investigation into whether clinical trials of Russia's Sputnik V COVID-19 vaccine contravened ethical and scientific standards. Regulators will be focusing on whether clinical trial participants were coerced into participation.
- Oxford University paused a small clinical trial in children of the COVID-19 vaccine developed with AstraZeneca, ahead of new risk assessments this week by regulators investigating possible links between the vaccine and rare but potentially fatal blood disorders in adults.

- Globally, 693.37 million vaccine doses have been administered.
- Mexico's foreign minister said that the country is on the verge of approving India's homegrown COVID-19 vaccine Covaxin, despite Brazil's refusal to grant the regulatory green light earlier this month.
- **Brazilian** President Bolsonaro spoke to Russian President Putin to discuss buying or domestically manufacturing the **Sputnik V vaccine**.
- An adviser to the Hong Kong government recommended the Chinese territory hold off on ordering the Oxford/ AstraZeneca vaccine citing concerns about its effectiveness against certain variants.



Markets & Business

Carnival Cruise threatened to move its shops away from US ports due to continued restrictions on its operations.

- European stocks hovered near record highs on Wednesday as investors awaited data on services sector activity for the region.
- Air New Zealand and Qantas Airways said they will increase flights to at least 70 percent of pre-pandemic levels once the bubble opens.
- BP said it saw a strong start to 2021 and is on track to lower net debt to \$35 billion in Q1, in a sign of broader recovery for the oil industry.

- Chinese sportswear brands like Li-Ning and Anta are experiencing a surge in interest as numerous Chinese consumers boycott western brands like Nike and Adidas.
- A national coalition of small businesses in the US is pushing for stricter antitrust laws, which they hope could break up Amazon.
- Amazon's outgoing CEO Jeff Bezos said that the company is in support of Biden's plan to raise corporate tax rates.
- Cryptocurrency inflows hit an all-time high of \$4.5 billion in Q1.

Africa

- Egypt and Sudan reported that the latest round of talks over the Grand Ethiopian Renaissance dam had ended with no progress made.
- **Somali** leaders again failed to decide on a procedure for a new election, extending President Farmaajo's de facto term, which was supposed to end in February.
- Opponents of **Benin** President Talon protested in several cities ahead of next week's election, in which he will seek a second term.
- Nigerian judiciary workers began a strike to call for financial independence for the judiciary, shutting down the country's supreme court.
- The South African Development Community condemned terrorist attacks in the Cabo Delgado province.
- The UN called on Tanzania to not turn away Mozambican refugees. Tanzanian President Suluhu
 announced plans to establish a coronavirus advisory committee, seemingly reversing the country's lax
 coronavirus policies.



Asia

- In Myanmar, a Chinese-owned factory was set on fire in the commercial capital Yangon and activists burned the Chinese flag.
- Indonesia reported its first case of a more transmissible variant with the mutation nicknamed "Eek."
- India reported a record of 115,269 new infections yesterday, as government health
 officials warned that the coming four weeks will be "critical" in controlling the spread
 of the virus.
- The WHO has raised the alarm about surging coronavirus infections in the Philippines.
- The IMF urged **China** to address its high corporate debt levels, which have worsened during the pandemic. **Hong Kong** media tycoon Jimmy Lai and two pro-democracy activists pleaded guilty to charges of participating in an illegal march during mass anti-government protests in 2019.
- Sri Lanka banned imports of palm oil, in a further blow to an industry plagued by concerns around forced labor and deforestation.
- **Malaysia** announced Tuesday that it has returned 267 containers of illegal plastic waste to sending countries since 2019 and is in the process of sending back another 81. Malaysia's policemen are set to start wearing body cameras this year in an effort to improve services and integrity.



Europe

 France and Germany threw their support behind the new US efforts to establish a global minimum corporate tax.

 Ukraine's President Zelensky called on NATO to back a membership action plan (MAP) for the country in order to deter Russian aggression.

Alexei Navalny's lawyer says he is "seriously ill" in prison. Russian
police detained several Navalny supporters outside his prison.

• **Turkey** summoned **China's** envoy to the country over comments condemning two Turkish politicians for criticizing Beijing's actions in Xinjiang.

- Greece reopened its embassy in Libya and called for a reset of relations after a 2019 maritime agreement between Turkey and the
 western Libyan government.
- In the **UK**, Climate activists from the Extinction Rebellion group used hammers to break the windows and then pasted the message "In Case of Climate Emergency Break Glass" on the front of Barclays London headquarters.
- The Czech Republic will reopen some schools and shops from next week, the first time it has lifted restrictions this year. Hungarian Prime Minister Orban announced that the country will begin reopening, as a quarter of its 10 million residents have begun vaccination. France's COVID-19 hospitalizations are at a near five-month high. Norway surpassed 100,000 confirmed infections.



Middle East

 The Sudanese parliament voted to officially repeal the country's 1958 boycott of Israel.

UAE-based Etihad airline began direct flights to Israel.

• **Lebanon's** finance ministry agreed to give Alvarez & Marsal information for a financial audit, a long-resisted step that would be required for IMF aid.

Jordanian King Abdullah will make a national address today to explain the events
of the weekend. Saudi Arabia's foreign minister visited Jordan to express support
for the monarchy.

 Israeli President Rivlin gave Prime Minister Netanyahu the first chance to form a governing coalition.

- The UAE announced that the first unit of its Barakah Nuclear Energy Plant had begun commercial operations.
- Iran has enriched 55 kg of uranium to 20 percent, indicating quicker production than the 10 kg a month rate required by an Iranian law. An Iranian ship linked to the IRGC was attacked in the **Red Sea**. Iran indicted ten over the shooting-down of a **Ukrainian** passenger plane inn January 2020 that killed 10.







Americas

Schools in El Salvador partially reopened on Tuesday after being closed for over
a year due to COVID-19 restrictions.

• Toronto, **Canada** will cancel in-person learning due to an ongoing variant-driven surge in cases there.

• Colombia's capital Bogota will tighten coronavirus restriction, including a three-day lockdown starting on Saturday.

Trinidad and Tobago Prime Minister Kieth Rowley tested positive for COVID-19.

 A former representative for energy giant Gunvor pled guilty to involvement in a scheme to bribe **Ecuadorian** officials to win business from state-backed Petroecuador.








Americas

Scientists are predicting that Brazil's surge in COVID-19 deaths could surpass that seen in the US in January; yesterday new fatalities climbed above 4,000.







Americas: US

Nationally, 108.3 million people have received one or more vaccine doses, 32.6 percent of the total
population. President Biden urged all states to make all adults eligible for vaccines by April 19. Texas
Governor Abbot signed an executive order banning vaccine passports in the state. The White House
said it does not currently support the system of vaccine passports.

California Governor Newsom said the state is targeting full reopening by mid-June. South Carolina's
Republican governor is being sued by the American Civil Liberties Union over his mandate to
"immediately expedite" a return to in-person work for state employees.

- **US job openings** climbed to their highest level since 2019 in a sign of strong labor market recovery.
- **Democratic US Representative Alcee Hastings** has died at the age of 84. Hastings, who became the first African American elected to Congress in Florida since the post-Civil War period, was serving his 15th two-year term in the US House of Representatives.
- The US and Iran will meet indirectly on Friday to further discuss reviving the 2015 nuclear deal, after
 experts discuss options to walk back nuclear enrichment and lift sanctions. Tuesday's talks were
 described as "constructive." The White House said that they do not anticipate a change in policy resulting
 from the talks.



Emerging and Existing Hotspots: Militant Insurgency in Mozambique's Cabo Delgado Region

In late March, Mozambique grabbed international headlines when an Islamist militant group seized the northwestern city of Palma, a gas hub home to a liquefied natural gas plant owned by French multinational Total, displacing thousands and ultimately forcing Total to suspend operations and evacuate its employees. Although the Mozambican army has now reportedly recaptured Palma, the ongoing Islamist insurgency that began in 2017 in the northwestern Cabo Delgado province has not been quashed, and risks of future incidents, humanitarian impact, and business interruptions remain.

The seizure of Palma is the most recent and most impactful in a string of attacks and provocations by local ISIL affiliates, the largest of which is al-Sunnah, amid a years-long regional insurgency that began in October 2017. Since 2017, al-Sunnah and other Islamist groups have sought to loosen the central government's control over the impoverished Cabo Delgado region, simultaneously threatening the large natural gas discoveries there which leaders in the capital

city of Maputo hope will transform the Mozambican economy. On March 24, militants surrounded and attacked the town of Palma, destroying public buildings, driving thousands of Mozambicans to flee and killing an indeterminate amount of people, constituting the groups' most sustained and impactful offensive thus far. On Friday, Total paused construction of its new LNG plant near Palma and evacuated its staff. On April 4, ten days after militants seized Palma, the Mozambican military regained the town with a "significant number" of militant casualties.

The Palma attack is a stark demonstration of the growing strength of Mozambique's militant Islamist groups and, more broadly, the spread of violent Islamist groups throughout the region. While Mozambican President Nyusi has assured the public that his security forces are capable of countering al-Sunnah, the attack laid bare deficiencies in the country's military and the extent to which al-Sunnah has undermined the central government's ability to function in Cabo Delgado. Al-Sunnah had seized towns before - nearby Mocimboa da Praia in March and August of 2020, which remains the epicenter of their operations - but never for so long, or so close to critical foreign infrastructure.



Total's decision to evacuate its staff is also consequential: the company has been forced to interrupt work at the \$20 billion plant before, pausing work and reducing staff levels at the plant in January and only resuming construction after Total's CEO met personally with Nyusi to request a more robust security perimeter. The decision to entirely evacuate its staff is likely a pessimistic sign that Total does not believe violence will be quelled any time soon.

In addition to immediately endangering the town of Palma and international LNG operations, the humanitarian effects of the insurgency threaten to continue to destabilize the country. Humanitarian organizations estimate that some 10,000 have fled Palma, many to the regional capital of Pemba, straining an already overburdened refugee infrastructure and,

according to some reports, fueling food scarcity. Some refugees have remained in the bush awaiting al-Sunnah's retreat, but it will be difficult to resettle the refugees or reconstruct the areas of Palma destroyed by militants. Further destabilization and displacement in Cabo Delgado will continue to strain the low-income region, while threatening the foreign investments - such as the Total LNG plant - that Maputo has relied on to transform the country's economy.

The deteriorating situation Mozambique has prompted some international powers to pledge support. Portugal will send a group of soldiers to Mozambique, which is former Portuguese colony, to lead a training mission. The move builds on calls in March early from Portugal's representatives at the European Union


for a united European effort to counter Islamists in Somalia and Mozambique, although those failed to garner support in the bloc. The US had designated al-Sunnah and sent a training mission to Mozambique just two weeks prior to the attack to counter the spreading Islamist insurgency in Africa. In the past, the Mozambican military has struggled to address militants but has declined foreign troops in case foreign intervention strengthens anti-west recruitment rhetoric from Islamists. In recent years, Maputo has turned to private military companies to supplement their operations; however, the government seems unlikely to renew its relationship with its primary contractor, Dyck Advisory Group, which is under investigation by Amnesty International for committing war crimes in Cabo Delgado. Another option to bolster the country's military capabilities is direct intervention by the South African Development Community, aided by foreign contributions, but this too seems unlikely as regional countries deal with their own Islamist insurgencies and domestic issues. Despite the end of the immediate Palma crisis and pledges from governments in Maputo, the US and Portugal to bolster Mozambique's military capabilities, al-Sunnah has not been defeated, and the destabilizing trend in the country is likely to continue.






Coronavirus Condition Updates

As of 2100 hours US EDT on April 6, 2021




