WHAT WE'RE WATCHING

By 2024, Saudi Arabia will cease doing business with international companies without a regional headquarters in the Kingdom. The move may incentivize foreign direct investment, supporting economic diversification and creating employment, or risk losing out on businesses without a Saudi presence.



Global

The global number of new coronavirus cases has declined by 16 percent over the past week, the WHO said, even as more virulent strains of the virus spurred outbreaks in multiple regions.

- The world's first COVID-19 "human challenge" trial — infecting healthy young adults with coronavirus — will begin in London within a month, the UK government announced.
- Britain is pushing the UN Security Council to embrace its call for a cease-fire in conflict zones so that vaccines against the coronavirus can be delivered to some of the world's most vulnerable populations.

COVID-19 Vaccine

Vaccine manufacturers are struggling to secure supplies of giant plastic bags used in bioreactors that mix pharmaceutical ingredients, creating a bottleneck that threatens the rollout of COVID-19 shots around the world.

- The UN Children's Fund has signed an agreement with 16 airlines to prioritize Covid-19 vaccines, essential medicines, medical devices and other pandemic-related equipment and goods to support the COVAX Facility.
- Johnson & Johnson has sought authorization from the European Medicines Agency for its single-dose Janssen COVID-19 vaccine candidate.
- The European Commission is set to announce millions of additional euros in funding to research new coronavirus variants.
- Japan began vaccinations today, aiming first at immunizing older citizens.

- Indonesia has made coronavirus vaccination mandatory for all citizens, meaning people who refuse the shot could be subject to fines, suspension of social aids, or suspension of access to public services.
- A deal for Taiwan to buy 5 million doses of a COVID-19 vaccine developed by Germany's BioNTech SE is on hold, with Taiwan pointing to Chinese pressure on BioNTech for the delay.
- Gaza will receive its first shipment of COVID-19
 vaccines on Wednesday after Israel approved the
 transfer through its border.




COVID-19 Vaccine

Markets

Today, Goldman Sachs will unveil Marcus Invest, robo-advisory wealth-management platform for retail investors.

- European shares retreated from near one-year highs on Wednesday as concerns about a possible rise in inflation tempered optimism around a vaccineled global economic recovery.
- Asia-Pacific stocks edged lower on Wednesday as upward momentum from vaccine rollouts faded.
- In US markets, the Dow closed at a record high Tuesday, while the S&P 500 and Nasdaq saw more muted interest.

- Oil prices advanced further on Wednesday, underpinned by major supply disruption in the south of the US this week caused by a winter storm in Texas.
- On Tuesday, **Bitcoin** hit \$50,000 for the first time.



Business

Microsoft President Smith said that the SolarWinds attack is presumably ongoing and affected organizations should overhaul their malware-infected systems.

- Southwest Airlines expects its Q1 cash burn to slow to \$15 million per day.
- Insurance conglomerate AIG saw Q4 adjusted income fall 10 percent on continued additional COVID-19 costs.
- CVS said it will return to selling health insurance plans through the online marketplaces created by the Affordable Care Act.
- A US judge ruled against Citigroup in its bid to recover \$500 million in funds mistakenly sent to Revion lenders.
- Italy's competition watchdog has fined Facebook
 7 million euros (\$8.5 million) for not complying with a request to correct improper commercial practices in its treatment of user data.

- Warner Music Group has invested in Rotana Music, the Middle East's largest record label and will distribute Rotana Music's releases globally, which includes some of the biggest music stars in the Arab world.
- Swedish cloud computing services provider Sinch AB has agreed to buy communications company
 Inteliquent for \$1.14 billion in cash to expand its presence in the US.
- Mexican cement producer Cemex has acquired Beck Readymix Concrete Co. LTD, a concrete business in San Antonio, Texas, as it looks to expand in the US.
- ByteDance is reportedly looking to raise money by listing shares of Douyin (the Chinese sister app of TikTok) in New York.



Africa

• The **Senegalese** military restored state control to four rebel strongholds on **the Guinea-Bissau** border.

The African Development Bank said Japan had signed a 73.6 billion yen
 (\$668 million) loan agreement to help replenish the lender's main development fund.

• **French** President Macron promised that there would be no immediate reduction in French support for counterterrorism operations in the **Sahel**, but reiterated calls for an eventual drawdown.

- The Ugandan Supreme Court rejected additional evidence filed by Bobi Wine in his petition to contest the electoral victory of incumbent President Museveni.
- The trial of 'Hotel Rwanda hero' Paul Rusesabagina set to begin amid family's fears of injustice; Rusesabagina faces charges of terrorism.
- Thousands protested in the **Algerian** town of Kherrata, hoping to revive the Hirak movement that ousted Algeria's president in 2019 but slowed down amid COVID-19.



Asia

 Authorities in Maharashtra, an Indian state of more than 100 million and home to the Mumbai metropolis, have warned of a new lockdown after cases have risen in recent days.

• **Singapore** will issue up to \$68 billion in bonds to finance big infrastructure projects, in a rare move for the wealthy city-state.

• Hundreds of thousands of people marched in Myanmar on Wednesday, rejecting the army's assertion that the public supported its overthrow of elected leader Aung San Suu Kyi. China's ambassador to Myanmar said that the current political situation is "absolutely not what China wants to see," and dismissed social media rumors about Chinese involvement in the coup as "complete nonsense." Myanmar experienced a near-total internet shutdown for a third consecutive night.

Some analysts predict that 2021 could bring a series of defaults from corporate China, following a gap in rates on US versus
 China junk bonds, which has fueled interest in higher-yielding Chinese debt. China overtook the US as the EU's largest trading
 partner in 2020. Satellite images show that China has dismantled dozens of structures and moved vehicles to empty out entire
 camps along a disputed Himalayan border, where Indian and Chinese troops have been locked in a face-off since last summer.

Europe

 In Spain, thousands of protestors took to the streets in Barcelona Tuesday evening to demand the release of a rapper arrested on charges of glorifying terrorism and insulting royalty in his songs.

Italy's first bond offering under the leadership of Mario Draghi drew strong demand.

- Poland said it will amend aspects of its controversial plan to tax advertising revenues, which critics say would undermine independent journalism.
- France's National Assembly approved a controversial bill aimed to crackdown on "Islamist separatism."
- The **UK** has created a modelling technology to identify COVID-19 risk factors, called QCovid. An additional 800,000 adults have been given vaccine priority following QCovid's findings. Deutche Bank predicted that UK government spending on vaccines will have a noticeable positive impact on the country's overall economy. A UK official said all adults could be immunized by August or September. **Hungary's** first 550,000 doses of China's Sinopharm vaccine arrived in Budapest. **Scotland** will begin to reopen school from next week. A **Dutch** court ordered the government to lift the midnight curfew. **German** business groups criticized Berlin for extending the country's lockdown.



Middle East

• **Egypt** is planning to reopen its embassy in **Libya** for the first time since 2014.

Saudi Arabia intercepted a Houthi drone aimed at Abha Airport,
 which the militant group hit last week in its first successful attack on
 a civilian aircraft. The UN warned that the offensive by Yemen's
 Houthi group to take Marib city, the last stronghold of the
 internationally-recognized government, threatens to displace hundreds
 of thousands and complicate a renewed diplomatic push to end the war.

 Starting 2024, Saudi Arabia will cease signing contracts with foreign companies if they do not have a regional headquarters in the country.

 Turkish President Erdogan said that Ankara would increase crossborder operations against Kurdish militants after 13 captured Turks were killed in northern Iraq.



Americas

- Northern Mexico is suffered a second day of power outages stemming from natural gas supply
 failures in Texas. A plan by Mexican lawmakers for a biometric phone registry, billed as a measure
 to fight kidnapping and extortion, has sparked backlash from telecoms companies and human rights
 groups. Mexico surpassed 2 million virus infections, with 175,987 deaths, the third highest death toll
 globally.
- Peru's president announced that 487 officials have leveraged privileged positions to secretly receive early COVID-19 vaccinations that had been purchased for health workers, fueling the country's intensifying scandal over unequal vaccine access.
- Architects in **Colombia** have created inflatable chambers to house COVID-19 patients in gyms or parking lots, due to a shortage of hospital beds.
- **Brazil's** public health system has been pushed to the breaking point by one of the world's deadliest coronavirus outbreaks (9.9 million infections), but its private healthcare sector is experiencing an unlikely dealmaking boom.
- Canada's top doctor warned that the rapid spread of new coronavirus variants threatens to engulf the country in another wave of infections, with at least four provinces currently reporting evidence of community transmission associated with these faster spreading variants.



Americas: US

- Nationally, 39.9 million people have received one or more vaccine doses. The White House announced another increase to vaccine supplies, boosting weekly supply to states from 11 million to 13.5 million. US COVID-19 hospitalizations continued to drop, now at their lowest level since early November, while the daily increase in cases and deaths were among the smallest in months. US hospitals are seeing an increase in MIS-C, the severe inflammatory condition identified in children after infection with COVID-19.
- Winter storm weather has disrupted vaccine distribution across affected areas including Texas. At least 14 have died in a four states amid the historic storms. More than 4 million people have faced freezing temperatures without power.
- The Transportation Security Agency reported back-to-back days of **traveler volume** over 1 million for Presidents Day weekend, surpassing New Year's travel.
- The NAACP filed a **federal lawsuit** against former President Trump and Rudy Guiliani, accusing them of conspiring to incite violence at the capitol.
- The Biden Administration is reportedly reviewing US policy towards **Nord Stream 2**. A US Navy warship sailed by islands claimed by China in the **South China Sea** on Wednesday in a freedom of navigation operation, marking the latest move by Washington to challenge Beijing's territorial claims in the contested waters. President Biden had yet to call Israeli Prime Minister Netanyahu, Saudi Crown Prince Mohammed bin Salman, Turkish President Erdogan, and Egyptian President al-Sisi, prompting some analysts to anticipate a forthcoming change in US **Middle East policy**.



Emerging and Existing Hotspots: Iran

President Biden is set to face his first major test in the Middle East as the new administration learns more about the attack on a US military base in northern Iraq which killed a military contractor and wounded an American soldier. The Monday evening attack involved 15 rockets directed at the US military presence near Erbil International Airport, a strategically important base in Kurdish-controlled Iraqi territory.

Within hours, a previously obscure Iran-backed militia claimed responsibility for the attack, raising questions about the extent of Tehran's involvement and whether the events portend future instability both in Iraq and around the region. A tense regional environment in the wake of tests of an Iranian "smart" missile this past weekend and the start of joint naval drills between Iran and

Russia in the Gulf of Oman, which followed IRGC drills near the Iraqi border last week, serve as the background for this most recent attack. The White House has thus far declined to confirm attribution, while Secretary of State Blinken has said that he is "outraged" by the attack, and Press Secretary Jenn Psaki stated that President Biden "reserves the right to respond in the time and manner of our choosing".

The timing of the attack so early in the Biden Administration poses significant risks to both short-term US strategy in the Middle East and greater regional security. In the last several months of the Trump Administration, Iran-backed militias in Iraq acted with relative restraint as they monitored the US presidential race and gauged the risks and rewards of antagonizing Washington. This approach mirrored the "strategic patience" from Iran itself, where leadership was widely expected to be trying to "wait out" the Trump Administration in the hopes of a better deal from President Biden. Monday's attack on US interests in the region marks the greatest escalation since January of last year, when Iran responded to the killing of Quds Force leader Qassem Soleimani with a barrage of

missile attacks on US military bases outside Baghdad. Although the risks of an escalatory cycle remain low, the Biden Administration will likely be monitoring subsequent developments in Iraq closely to determine whether the attacks represent a one-off incident or part of a larger pattern. Since assuming office and during the presidential campaign, Biden has emphasized the need for greater diplomatic outreach in the region, as well as the need to reduce the US's military footprint where possible. That being said, it is clear that the new Administration is keen to avoid appearing passive in response to attacks on US interests. On Tuesday, Secretary of State Antony Blinken pledged to "hold accountable those responsible" in a call with Kurdistan regional leadership.

How the Biden Administration responds will also be closely watched by US regional partners and allies. Leadership in Riyadh and Jerusalem remains wary of President Biden's approach to Iran and Iran-backed proxies in Iraq, Yemen, and Lebanon, and will likely demand a strong response to maintain credible deterrence. The new administration's determination to rejoin the 2015 nuclear deal with Iran remains a sticking point with most of the US's regional allies and will have knock-on geopolitical effects in Iraq and in the Persian Gulf. On Tuesday, Israel's envoy to the United Nations held

out the possibility that they would not engage with President Biden on negotiations to revive the deal, and urged the US to apply new, tougher sanctions while enforcing a "credible military threat." In addition to throwing cold water on involving Israel in future negotiations, the comments arrive at a testy moment in US-Israel bilateral relations. Biden and Prime Minister Netanyahu have not spoken since the inauguration, with many in Israel speculating that the new president still resents Netanyahu's open partisanship in US politics and cool attitude towards former President Obama. Any cracks in the US-Israel relationship, perceived or otherwise, may present an opportunity for bad actors in the region to drive wedges in collective regional security policy.

The timing and sequencing of Biden Administration policy in the Middle East will also have been altered by Monday's attacks in Iraq. Already under immense domestic political pressure to resist open diplomacy with Iran, President Biden will now need to reassess US steps towards rejoining the JCPOA, and how culpable Iran is for the actions of its regional proxies. Although Administration officials have insisted that they do not see the need for nuclear negotiations within a set timeframe, it was widely speculated that the US would attempt to secure a preliminary agreement with Tehran ahead of the Iranian





presidential elections in June. This is likely no longer the case, especially if the US sees increased threats from Iranian-backed militias in Iraq and elsewhere. For its part, it can be expected that Iran will increase pressure on the EU and US in different ways to attempt to gain sanctions relief, including rejecting international nuclear inspectors and conducting military drills with US great power competitors. Although the immediate security impacts of Monday's attack appear relatively contained, it still may cause a major rethink of strategy in Washington if Iran continues to apply different forms of regional pressure.




