### Global


# Confirmed coronavirus cases globally surpassed 106 million, with deaths at 2.3 million. The rate of new infections and deaths continued to ease.


- Across low and middle-income countries, a median average of 70 percent of those surveyed reported a drop in income in the early months of the coronavirus pandemic last year, while 30 percent reported a loss of employment and 45 percent said they had missed or reduced meals, according to a study by US universities.
- A second senior leader of a vast drug syndicate has been arrested in Thailand, as a transnational dragnet tightens on the Sam Gor group, which police say dominates the \$70 billion annual Asia-Pacific drug trade.

### Global

The number of daily new cases in the US and UK dropped continued to decline, with the UK weekly average dropping below 20,000. France, after recovering from November highs, is edging back up with new outbreaks.

Conditions in Peru are deteriorating, with daily new cases nearing the August highs. Hospitalizations are also approaching record highs.

### **COVID-19 Vaccine**

A COVID-19 booster in the autumn and then annual vaccinations are very probable, Britain's vaccine deployment minister assessed.

- The UK, already the cradle of the more contagious variant of the COVID-19 virus, has discovered a **new mutation** affecting certain strains of the disease, same as the one found in South Africa and Brazil, further complicating the European epidemiological landscape.
- India has approved the shipment of COVID-19 vaccine to Cambodia and plans to supply Mongolia and Pacific Island states, as supplies arrived in Afghanistan - all part of the country's widening vaccine diplomacy.
- The Oxford/AstraZeneca vaccines offers only limited protection against mild disease caused by the South African variant of COVID-19, based on early data from a small-scale trial, confirming concerns that the pandemic coronavirus will find ways to continue to spread in vaccinated populations.



### Markets

Taiwan's central bank has banned Deutsche Bank from trading Taiwan dollar deliverable and non-deliverable forwards and suspended it for two years from trading forex derivatives as part of a crackdown on speculation.

- European shares rose on Monday, as sentiment was lifted by hopes of a quicker recovery and multibillion dollar M&A deals in the region.
- Asia-Pacific stocks were broadly higher at the start
  of a new week following a record high for Wall Street on Friday.
- **Oil prices** rose on Monday to their highest in just over a year, with Brent nudging past \$60 a barrel, boosted by supply cuts among key producers.
  - Long-term US bond yields have struck their highest level in a year in the latest sign that investors expect President Biden's stimulus plan will boost US economic growth and eventually lead to higher levels of inflation.



### **Business**

### An international coalition of lawmakers has written to HSBC Holdings Chairman Mark Tucker, calling on the bank to unfreeze Hong Kong pro-democracy activist Ted Hui's accounts.

- Microsoft Corp announced it will suspend all donations by its political action committee (PAC) through 2022 to all U.S. lawmakers who voted to object to the certification of Joe Biden's election as president.
- Japanese beer company Kirin will end its brewing joint ventures with ties to Myanmar's army after the coup, citing the company's human rights policy. The decision underscores the impact the coup could have on the more than 400 Japanese companies that have entered Myanmar in anticipation of its democratic transition.

- South Korea's **Hyundai Motor Co** announced it has ended talks with Apple Inc on autonomous electric cars, triggering a \$8.5 billion slide in market value.
- British online fashion retailer Boohoo has bought the Dorothy Perkins, Wallis and Burton brands from the administrators of Arcadia for 25.2 million pounds (\$34.6 million), completing the break-up of Philip Green's empire.

### Africa

- South Africa halted Monday's planned rollout of AstraZeneca's COVID-19 vaccinations after data showed it gave minimal protection against mild infection from the South African variant.
- **Somalia's** leaders have failed to break a deadlock over the country's elections, with no clear path to a vote just days before the government's mandate expires.
- **Angola** has asked a Dutch court to hand over a half-billion-dollar stake in the Portuguese oil company Galp linked to ex-first daughter Isabel Dos Santos, who is accused of siphoning off profits from state oil company Sonangol.
- UN agencies have deployed staff to the east of the Democratic Republic of Congo after another Ebola outbreak was confirmed late on Sunday. According to the WHO, this is the twelfth Ebola outbreak in the country in over four decades and started only three months after another epidemic in the western province of Equateur was declared over in November.





### Asia

- Tens of thousands of people rallied across Myanmar for three days to denounce last week's coup and demand the release of elected leader Aung San Suu Kyi, in the biggest protests since the 2007 Saffron Revolution that helped lead to democratic reforms. Monks and nurses have joined the nationwide protests.
- China's drug authorities have given "conditional" approval for Sinovac's
  CoronaVac vaccine, permitting its use among the general population. Sinovac said trials in Brazil had shown around 50 percent efficacy in preventing infection and 80 percent efficacy in preventing cases requiring medical intervention.
- An **Australian** journalist who has been detained for nearly six months in **China** where she worked for a statetelevision channel has been formally arrested on suspicion of illegally supplying state secrets overseas.



### Europe

- Exports from **Britain** to the **EU** fell by 68 percent in January as trade was disrupted after the end of a transition period following Britain's departure from the EU, according to a trade body representing truckers.
- Losses at the 100 largest UK restaurant groups increased 112 per cent to an aggregate £571m last year, an accounting group's research has found.
- **Portugal's** health ministry said the AstraZeneca vaccine should preferably be used on under-65s, the latest European country to express reservations about its efficacy on older people.
- Hungarian health authorities have approved Russia's coronavirus vaccine Sputnik V after repeatedly criticizing the slow pace of the EU's process for acquiring vaccines.
- **France** reported a fall in new infections and the number of patients being treated in hospital, slightly easing pressure on the health system as the country rolled out shots with a third approved vaccine.



### Middle East

- The International Criminal Court decided it has jurisdiction over the Palestinian territories, which could lead to criminal investigations of Israel and Palestinian militant groups including Hamas.
- The US intends to revoke the Houthi movement's designation as a terrorist organization. UN special envoy on Yemen is visiting Iran for the first time to discuss Yemen's crisis.
- **Saudi** King Salman Humanitarian Aid and Relief Center (KSrelief) and WHO announced a partnership to assist Yemen through \$46 million program on COVID-19 preparedness and response, nutrition, water and environmental sanitation services.
- Tunisians defied a police lockdown and blocked roads on Saturday to take part in the country's largest protest in years. Protests that began last month over inequality have increasingly focused on the large number of arrests and reports of abuse of detainees, which the government has denied.



- Delegates from rival factions in **Libya** agreed on a new interim leadership that will guide the conflict-hit North African nation toward national elections on December 24.
- Israeli Prime Minister Netanyahu pleaded not guilty on Monday to corruption charges at the resumption of his trial, six weeks before voters again head to the polls to pass judgment on his leadership.

### Americas

- In a major reform of the state-dominated economy, the **Cuban** government will allow small private businesses to operate in most fields.
- Corpses in **Bolivia** have begun to pile up as a fierce second wave of the coronavirus has overwhelmed funeral homes and cemeteries, according to officials, stoking fears the growing backlog could become yet another focal point of infection.
- Pfizer Inc has applied for full regulatory approval in Brazil of its COVID-19 vaccine developed with BioNTech.
  Credit data firm Experian said on Monday it was continuing to investigate whether the personal data of millions of people in Brazil that was found to be illegally offered for sale online could be connected with its Brazilian business Serasa.
- Ecuadorean economist Andres Arauz on Sunday won a first round victory in the country's presidential election, moving the Andean nation a step closer to socialism following years of austerity measures made more painful by the pandemic. Authorities continued counting votes to determine whether his challenger will be a conservative banker or an environmental activist.
- **Canada** surpassed 800,000 virus infections. The UK variant is spreading across Canada, with Saskatchewan and New Brunswick finding first cases. Ontario, British Columbia, Alberta also have reported the variant.

### **Americas: US**

- US states on Sunday reported fewer than 100,000 COVID-19 cases for the first time in more than three months. Nationally, 31.9 million Americans have received at least one dose of coronavirus vaccine. More than 1,000 active-duty military personnel are poised to support state vaccination sites, as the Biden administration continues to look for ways to ramp up the national inoculation effort. The federal government allocated too much vaccine to elder-care facilities, and many states are now redistributing hundreds of thousands of the unused doses to others. Supermarket giant Kroger announced Friday that workers who get vaccinated for the coronavirus will be given \$100, joining a growing list of US retailers incentivizing employees to get inoculated against the virus.
- Iowa Gov. Reynolds lifted coronavirus restrictions including the use of masks, social distancing and limitations on social gatherings, while its two largest cities said they will keep their own measures in place. Washington DC resumed in-person school, to find low attendance. Experts worry Super Bowl, held in Tampa Bay Florida, could turn into a superspreader, as fans poured into the streets to celebrate without masks. Over the weekend, Wisconsin surpassed 600,000 infections and Oklahoma, 400,000.
- The Biden Administration suspended Trump-era **asylum agreements** with El Salvador, Guatemala and Honduras plans to raise the **refugee cap** for the current fiscal year to 62,500, a sharp increase from the 15,000 set by former President Trump,
- The US will rejoin the **UN Human Rights Council** as an observer, three years after former President Trump withdrew over what his administration called bias against Israel and a lack of reform.
- US Treasury secretary Yellen said the US could reach full employment next year if Congress passes Joe Biden's \$1.9 trillion stimulus package. The Biden administration has taken steps to bring the manufacturing of surgical gloves a component critical to the fight against the coronavirus to the US.

## Vaccine Update: Diplomacy and Soft Power in Global Vaccine Rollout

"Beyond being an *important driver of* global vaccine distribution, vaccine diplomacy is likely to leave lasting impact on the reputations and soft power of major global players."

As the race for global immunization picks up pace, vaccine diplomacy promises to continue being a driving force in international vaccine rollout. The idea of "vaccine diplomacy" is far from new - it has been a COVID-19 topic of discussion since international vaccine trials first began. But as inoculations actually get underway across the world, efforts at vaccine diplomacy are now at full force. This use of vaccines to expand ties with or influence over other countries has one obvious upside: it will help countries get much needed vaccines. Beyond being an important driver of global vaccine distribution, vaccine diplomacy is likely to leave lasting impact on the reputations and soft power of major global players. For the moment, Russia, China and India seem to be making the most of vaccine diplomacy, with western powers on track to reap fewer

diplomatic dividends – despite developing many of the world's leading vaccines.

China has been the country most explicit about its intention to use vaccine diplomacy to expand its international soft power. China has pledged to make COVID-19 vaccines a "global public good," promoted stories of China's vaccine donations to low-income countries. and integrated vaccines (as well as other forms of COVID-19 aid) into Beijing's "Health Silk Road" strategy - all moves that will boost China's global reputation. Beyond broadly casting itself as a generous and responsible global leader in COVID-19 vaccines, China is using bilateral deals to develop its international ties, primarily through the country's leading vaccines from Sinopharm and Sinovac (CoronaVac). These two vaccines are critical to national vaccination

plans across the world, despite some persistent concerns about safety and efficacy (CoronaVac was found in Brazil to be just over 50 percent effective, while international health experts continue to raise concerns about lack of transparency surrounding Sinopharm trial data). In particular, Sinopharm's shot is being used widely across the Middle East and Africa, with Gulf Arab states becoming global hubs for testing and manufacturing is vaccine, while CoronaVac has an even broader global reach across Latin America as well as Asia and Africa. Media and international analysts have also questioned how China may utilize vaccine deals to gain concessions from international governments for present and future gains. Beijing has maintained that it will not use vaccine deals for diplomatic leverage.

Alongside China, Russia's goals for vaccine diplomacy have been clear from early in the pandemic. Sputnik V, the COVID-19 vaccine with the most memorable name of them all, was developed and marketed globally by the Russian Direct Investment Fund, made reputationally inseparable from its country of orign. Despite many early concerns about Sputnik V's safety and efficacy, the vaccine can now finally boast peer-reviewed trial results showing it to be safe and in the top tier of vaccine efficacy. With international confidence in

Sputnik V now bolstered, Russia is likely to only keep expanding the reach of its vaccine diplomacy. Interestingly, Russia's biggest success may be in Latin America, where Sputnik V's role in regional immunization is growing increasingly important. For these relatively distant countries where public opinion may not include strong existing impressions of Russia, vaccine diplomacy could prove particularly effective. In many parts of Russia's more direct neighborhood, mistrust is much higher; Ukraine, for one, has banned the use of Russian COVID-19 vaccines outright.

Over the past few weeks, India has emerged as a power player in vaccine diplomacy. Leveraging its competitive advantage as the world's largest vaccine manufacturer to make deals across the world, India has made deals across the world, emphasizing its exports' "Made in India" quality, though they are primarily shipments of the Oxford-AstraZeneca vaccine manufactured by the Serum Institute. India is developing its own vaccines as well and has approved the Bharat Biotech shot for domestic use, but no foreign government have yet followed suit. Though India already has a massive challenge in vaccinating its own 1.3 billion citizens, as long as Prime Minister Modi ensures vaccinations are on track at home (India plans

to vaccinate 300 million people in the first round of inoculations, in one of the world's largest immunization campaigns), he is unlikely to face major backlash for sending vaccines abroad. India has not only been selling vaccines abroad through bilateral deals brokered by the Indian government or Serum Institute but has also been giving millions of free vaccine doses to neighboring states. These donations support both targeted and broad foreign policy goals for New Delhi. Giving to countries like Nepal and Bangladesh help India to improve relations and repair outstanding issues with important neighbors. Emerging as a regional force for vaccine diplomacy expands India's soft power and helps counterbalance China's influence. Globally, deals boost India's reputation and improve distant diplomatic ties. Beyond material deals, it is notable that India has been a leading advocate for the temporary suspension of intellectual property rights for COVID-19 vaccines, a role that is likely to resonate across parts of the world where the pandemic will be prolonged by the unequal global distribution of vaccines.

Though vaccines developed by western countries have the widest global reach, namely the US/Germany Pfizer-BioNTech and the US/UK AstraZeneca-Oxford shots, their influence effect is very

different. Unlike vaccines from Russia or China, international governments sign deals with companies, not countries, to get access to western vaccines. While this state of affairs aligns with western market values and demonstrates the prowess of western private sector innovation, it means that the US, UK, and German governments are not getting the same kind of international soft power boost that Russia, China, or India are pursuing in their vaccine deals. Moreover, many actions of western powers vis-à-vis global vaccine distribution have not improved international opinion, from the US declining to join Covax (though the Biden Administration intends to reverse this) to the EU's highly visible vaccine supply spat with AstraZeneca and corresponding decision to limit exports. Governments in North America and Europe are currently more concerned with domestic support than international reputation – but in the long run, this discrepancy in vaccine diplomacy could have implications for the shifting geopolitics of soft power.




More than 41.2 million vaccine doses have been administered across the nation, of which 9.2 million are second doses; 21.6 million are Pfizer-BioNTech while 19.4 are Moderna vaccines.

The gap between the number of doses distributed and administered remained the same – about 18 million. West Virginia is doing the best, having administered 84 percent of its stock; Mississippi is at the bottom, at 50 percent.


#### Total Doses Administered



Last week, the rate of daily new cases continued to decline, with only California and Texas routinely reporting more than 10,000 cases.


There is only one state with 7-day averages of new cases above 5 percent (Vermont); two week ago, there were 17.



A total of 690 UK strain (B.1.1.7) cases of the virus has been discovered in 33 states.

Six cases of the South African variant have been found in 3 states (Maryland, Virginia and South Carolina).

Three cases of the Brazilian strain have been discovered in 2 states (Oklahoma and Minnesota).



Daily deaths remain high, averaging 3,160 over the week (slightly up from the previous week at 3,158). The numbers are skewed because of Indiana reporting a backlog of 1,500 deaths last Thursday. Controlling for this, the average dropped to 2,945 deaths.

Hospitalizations have dropped below 85,000, the level from Thanksgiving. All states are trending down except for Vermont. California leads all states with at least 13,137 patients now hospitalized, but 5 states (Arizona, New York, Georgia, Texas and Washington DC) still have a higher rate per capita.





As of 2100 hours US EDT on February 7, 2021




### **Confirmed Cases (New)**


