Global

Yesterday, the global death toll hit a new daily high, with 17,469 new fatalities, bringing the total to 1,962,219.

- Save The Children called for governments to give \$50 billion to lower- and middle- income countries to prevent a crisis of over 10 million **children permanently dropping out of school.**
- Highly contagious **new variants of coronavirus** will emerge more frequently and spur further infection waves such as those threatening to overwhelm hospitals in the UK and South Africa, one of the world's leading infectious disease experts has warned.
- Siemens Gamesa and Siemens Energy are developing a commercial offshore wind turbine that produces hydrogen via electrolysis, marking a breakthrough for the **mass production of renewable hydrogen.** Renewable hydrogen can replace fossil fuel in sectors that are struggling to decarbonize, a way to meet goals to reduce emissions.

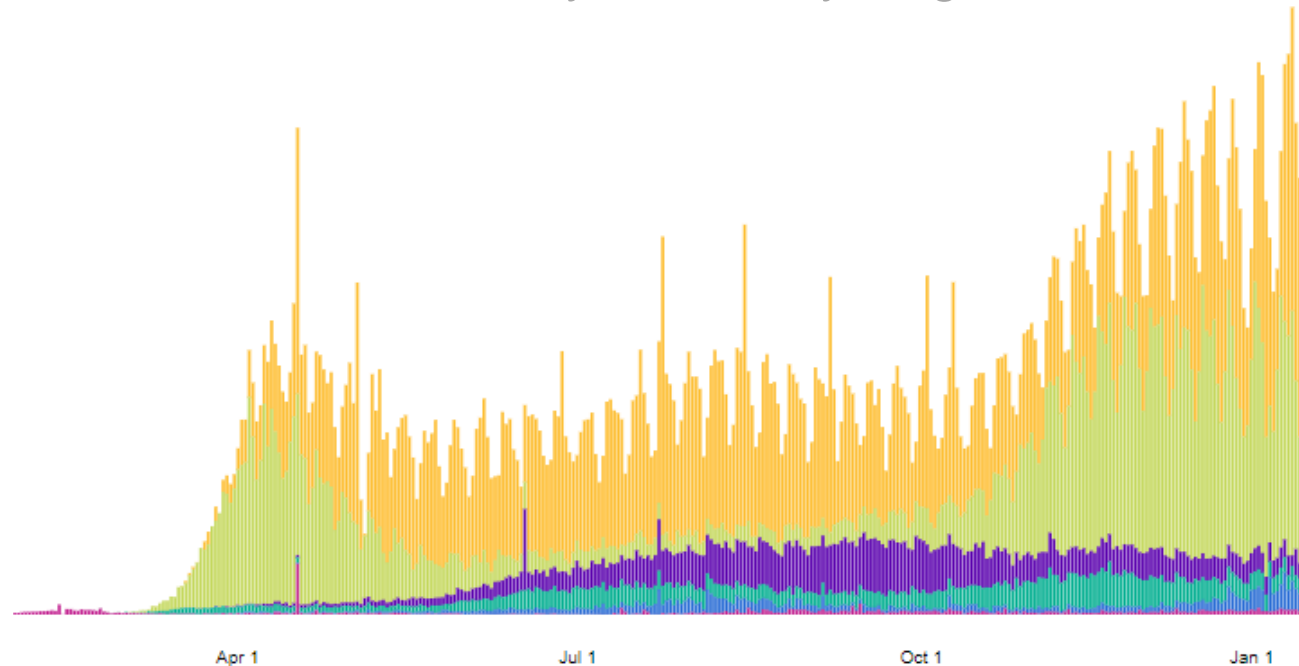

COVID-19 Vaccine

The pharmaceutical industry has warned against straying from tried-and-tested dosing intervals for Covid-19 vaccines, saying doing so risks public confidence in the shots.

- Governments have squandered the surge in **public trust** they saw early in the Covid-19 pandemic, imperiling their chances of persuading their populations to get vaccinated, according to a 28-country survey showing that skepticism of official guidance is growing around the world.
- Australian scientists have called on the government to review its Covid-19 immunization strategy over concerns that the University of **Oxford/AstraZeneca vaccine** was not effective enough to generate herd immunity.
- Health officials at Brazil's Butantan Institute said that CoronaVac, developed by **China's Sinovac**, has an efficacy rate of just over 50 percent, lower than initially indicated; however, the vaccine appears far more effective at preventing moderate to severe cases.
- The European Medicines Agency will review the **AstraZeneca-Oxford vaccine** *"under an accelerated timeline."*
- Gavi, the Vaccine Alliance, will provide **Egypt** with 20 percent of its necessary doses.
- The **African Union** has reached deals to secure 300 million vaccine doses for the continent.
- The Russian institute that developed the **Sputnik V vaccine** plans to seek permission to conduct trials on children, beginning in April or May.

Markets

US Municipal-bond issuance in 2020 hit decade highs, reflecting the increased costs faced by cities due to COVID-19.

- **European stocks** inched up on Wednesday as investors took a pause after last week's strong rally.
- **Asia-Pacific equities** were also flat, as concerns over the economic impact of high case counts came up against expectations for more fiscal stimulus.
- **US stocks** closed flat Tuesday as investors weighed a worsening pandemic outlook against the likelihood of coming stimulus.
- The US Energy Information Administration forecast that **US crude production** will keep falling in 2021.

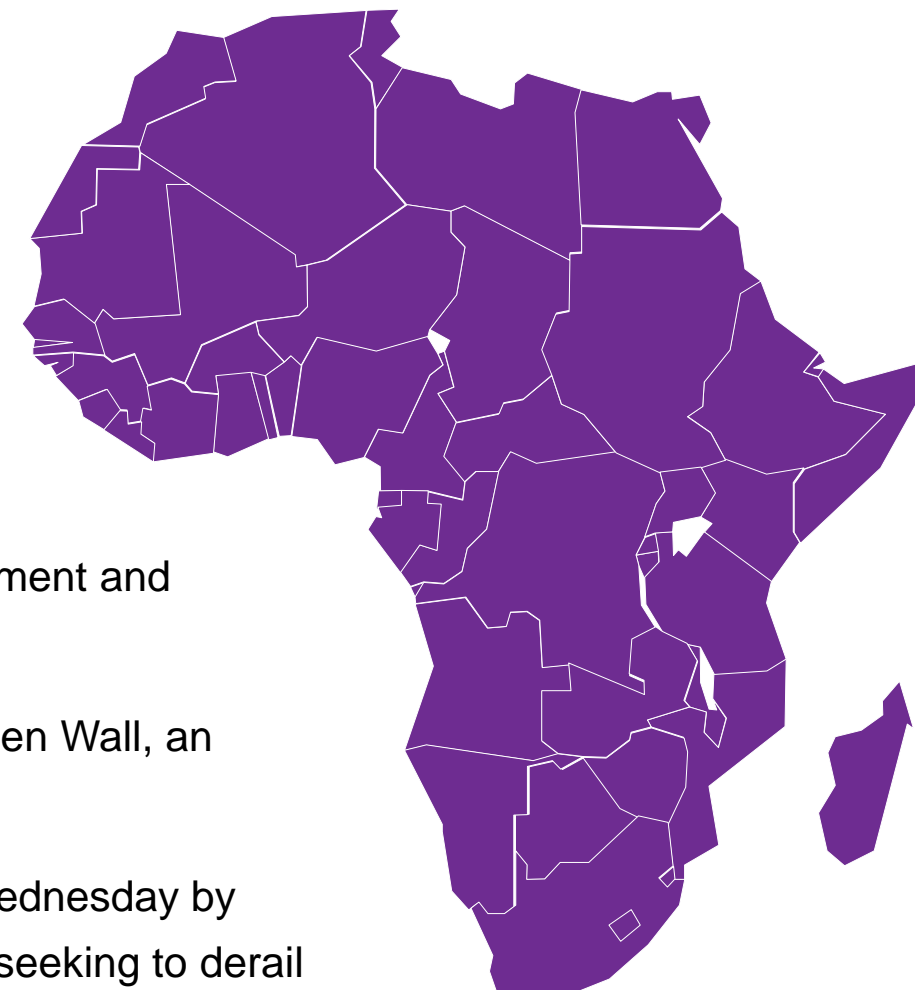
Saudi Arabia is offering multinational companies incentives including 50-year tax holidays to relocate to the Kingdom.

- California-based KB Home saw its orders rise to a 15-year high in Q4 as housing demand remains robust.
- Supermarket chain **Albertsons**, owner of **Safeway and Vons**, boosted its full-year outlook as consumers continue to dine at home.
- **Amazon** and other large e-commerce companies reported a rise in US online holiday shopping of over one third compared to 2019. **Urban Outfitters** disclosed a drop in holiday sales, a further datapoint indicating a trend of holiday losses for brick-and-mortar stores.
- **Visa** dropped its planned acquisition of **Plaid** after a US Justice Department antitrust lawsuit sought to block the deal.
- **Walmart** joined the list of companies suspending contributions to US lawmakers who opposed certifying the 2020 election.
- **Honda's** Swindon plant in Hong Kong will close for four days next week because of a global supply shortage of semiconductors, the latest disruption to hit the facility.

Africa

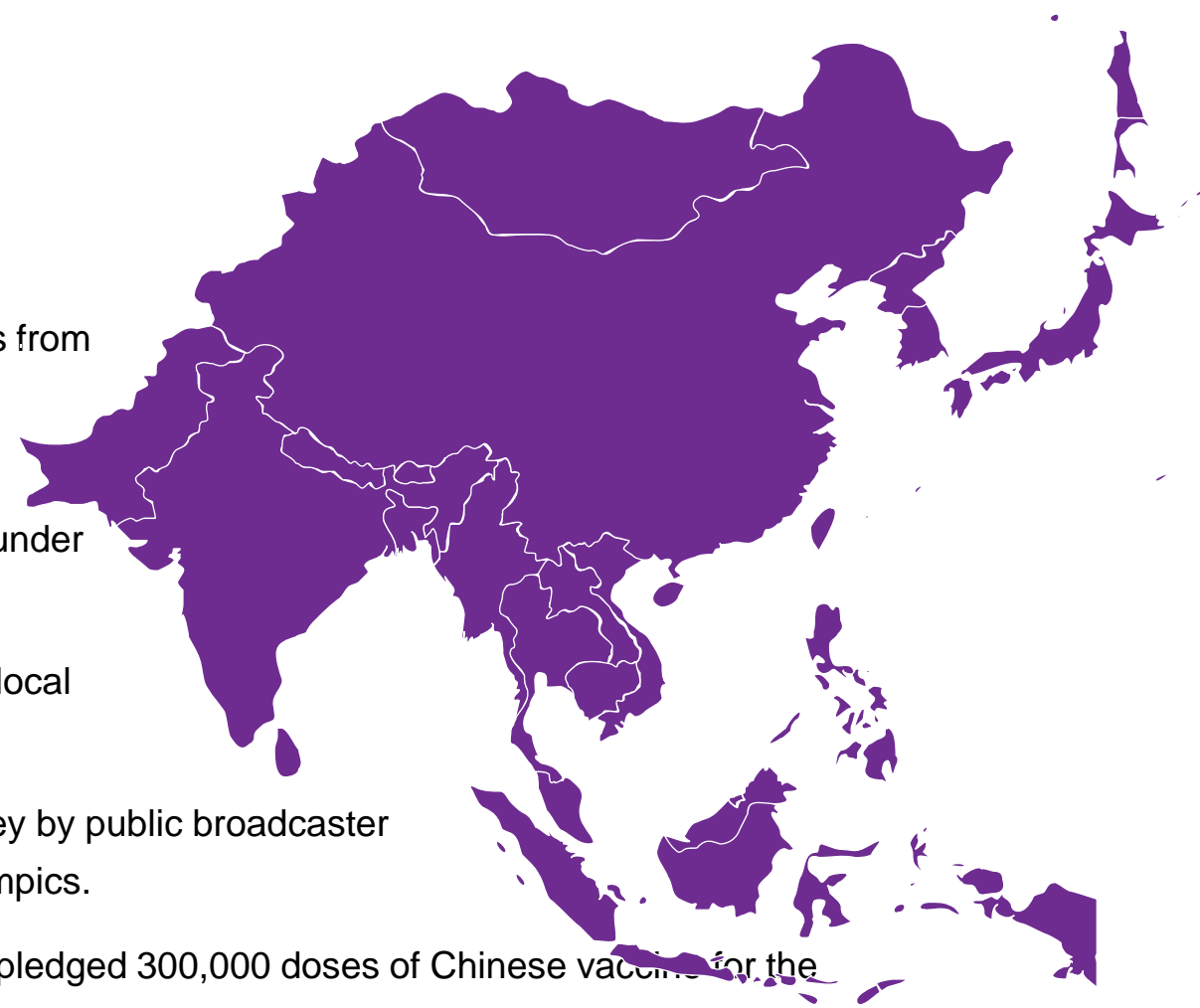
- **Uganda's** government ordered social media sites to be blocked ahead of Thursday's contentious presidential election; opposition candidate Bobi Wine said that the police had raided his home.
- Two members of the **Malawian** cabinet, the ministers of local government and transport, died of COVID-19 on the same day.
- The African Development Bank pledged \$6.5 billion for the Great Green Wall, an environmental initiative aiming to reverse desertification in the **Sahel**.
- Security forces in **Central African Republic** repelled an attack on Wednesday by armed groups seeking to seize the capital Bangui. Rebel groups are seeking to derail a disputed December 27 election in which President Faustin-Archange Touadera was declared victor.

Asia

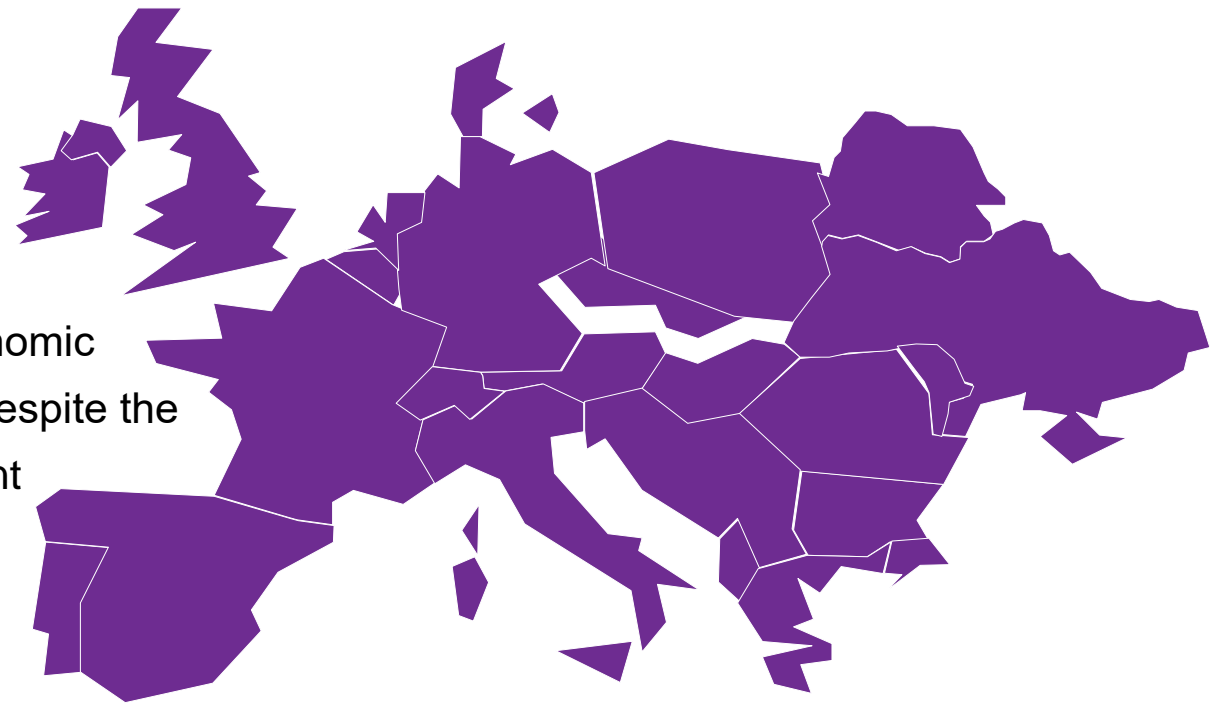
- **US** intelligence officials have warned publicly against using products from BGI, **China's** leading genetics company, saying it has a history of misusing personal data.
- **China's** Hebei province put two more cities, Langfang and Xingtai, under lockdown as cases continue to rise ahead of Chinese New Year.
- **Taiwan** reported two local transmissions, only the second and third local transmissions in the country since April.
- **Japan** expanded a state of to seven more prefectures, while a survey by public broadcaster NHK showed most people want to cancel or delay the Summer Olympics.
- On a two-day visit to **Myanmar**, **Chinese** Foreign Minister Wang Yi pledged 300,000 doses of Chinese vaccine for the country and signaled continued support on Myanmar's handling of the Rohingya. The *South China Morning Post* reported that China has withdrawn 10,000 troops from its border with **India** in recent weeks, citing anonymous sources.
- **South Korea** lost the most jobs in December in more than two decades as business slashed hiring amid stronger social restrictions.

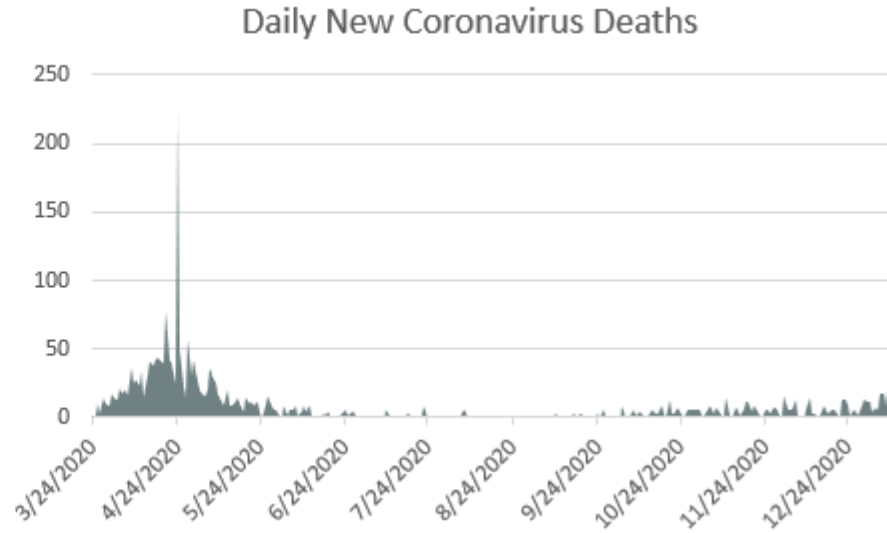
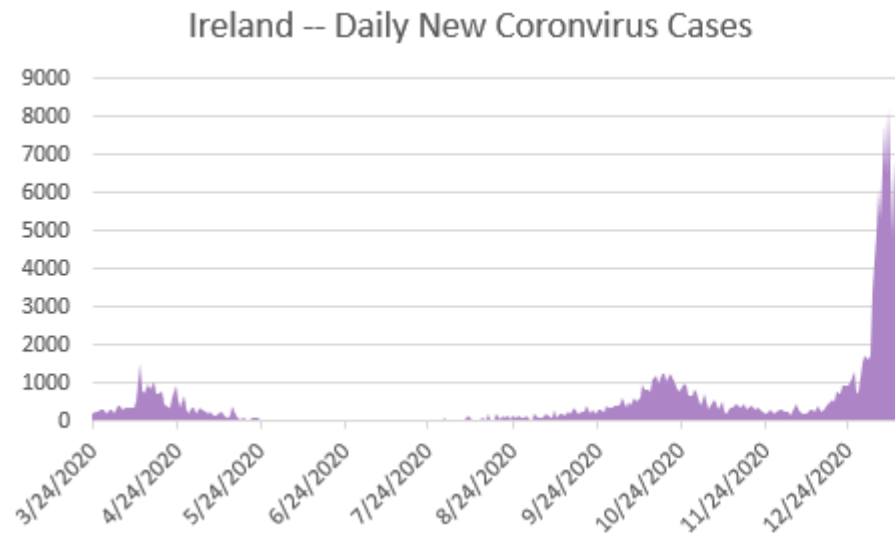
- The **European** Central Bank's latest projections for economic growth in the euro area are still "*very clearly plausible*" despite the resurgent coronavirus and renewed lockdowns, President Christine Lagarde said.
- More than 9,000 infants died in homes for unmarried mothers in **Ireland** between the 1920s and the 1990s, many run by Catholic religious orders, a long-awaited inquiry concluded.
- **Germany's** finance minister said he will seek a deal on global rules for corporate taxation with the incoming Biden Administration.
- The **UK** will introduce new rules to prevent goods from **China's** Xinjiang region from entering global supply chains.
- Hundreds of alleged members of **Italy's** most powerful mafia group are set to face justice in the country's biggest organized crime trial in decades. The 355 suspected mobsters and corrupt officials were charged following a long inquiry into the 'Ndrangheta group.

Europe

Ireland had early success in containing the spread of COVID-19, until December when an outbreak took root and has grown in alarming rates, with Ireland now having the highest incident rate per million in the world. Public health experts attribute the outbreak to increased socialization over the Christmas holidays and the impact of the more transmissible UK variant of the virus, accounting for around 40 percent of all new cases. Ireland shut restaurants, pubs serving food and some shops on Christmas Eve and has since further tightened its lockdown measures -- including closing non-essential construction sites, schools, and childcare services.

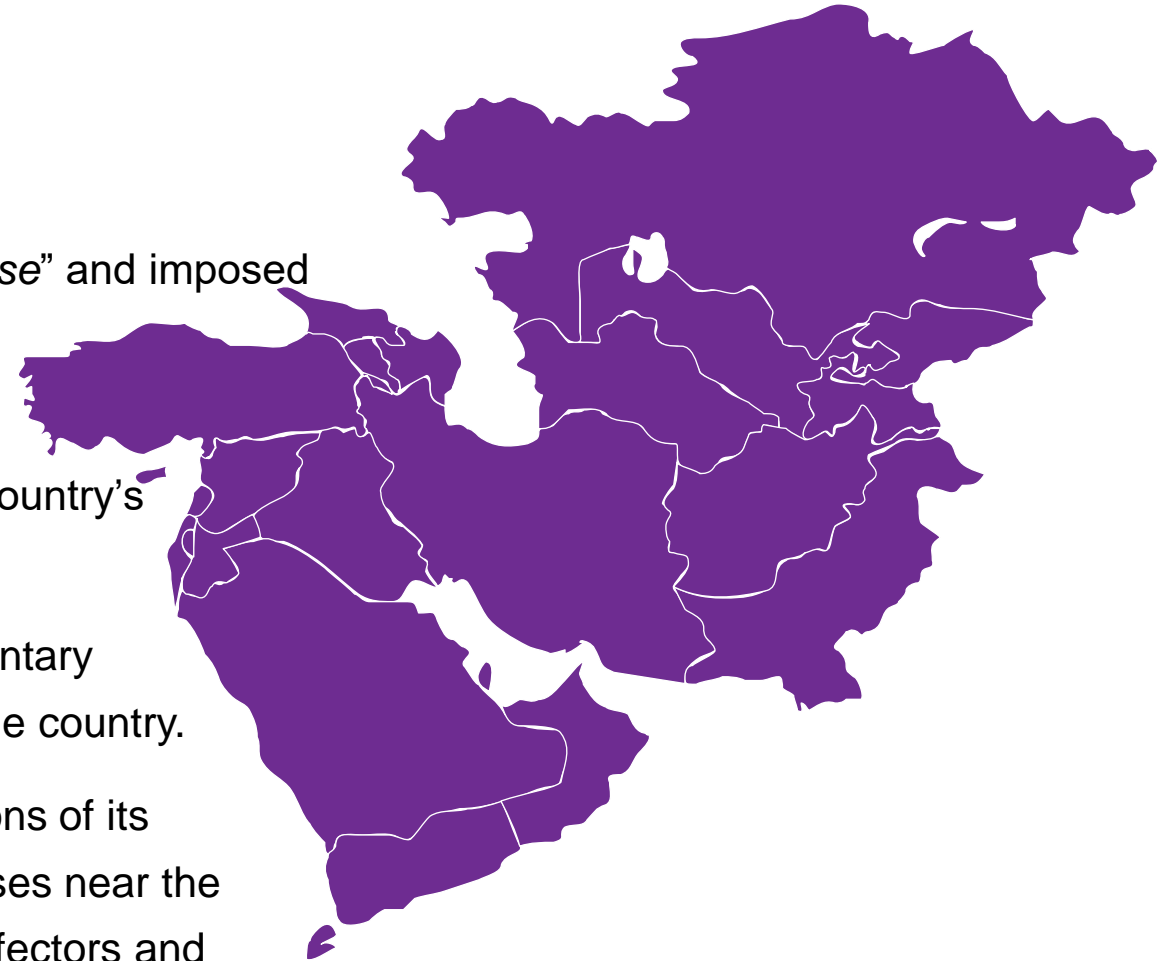

Middle East

- The **US** accused **Iran** of serving as al-Qaida's “*new home base*” and imposed sanctions on Iran-based terrorist leaders.
- **Omani** Sultan Haitham named his eldest son, Dhi Yazan, as heir, designating a Crown Prince for the first time under the country’s new constitution.
- **Kuwait’s** cabinet submitted its resignation ahead of parliamentary questioning in the latest instance of government clashes in the country.
- **Lebanon** will file a complaint with the UN over **Israeli** violations of its airspace. **Syria** said Israel bombed Iranian-backed militia bases near the Iraqi border in the early hours of Wednesday, with military defectors and Western intelligence sources describing the raid as one of Israel’s most extensive in recent months.
- The **UAE** has vaccinated more than 1.25 million of its 9.6 million people, giving it the second highest proportion of inoculated residents after **Israel**.

Americas

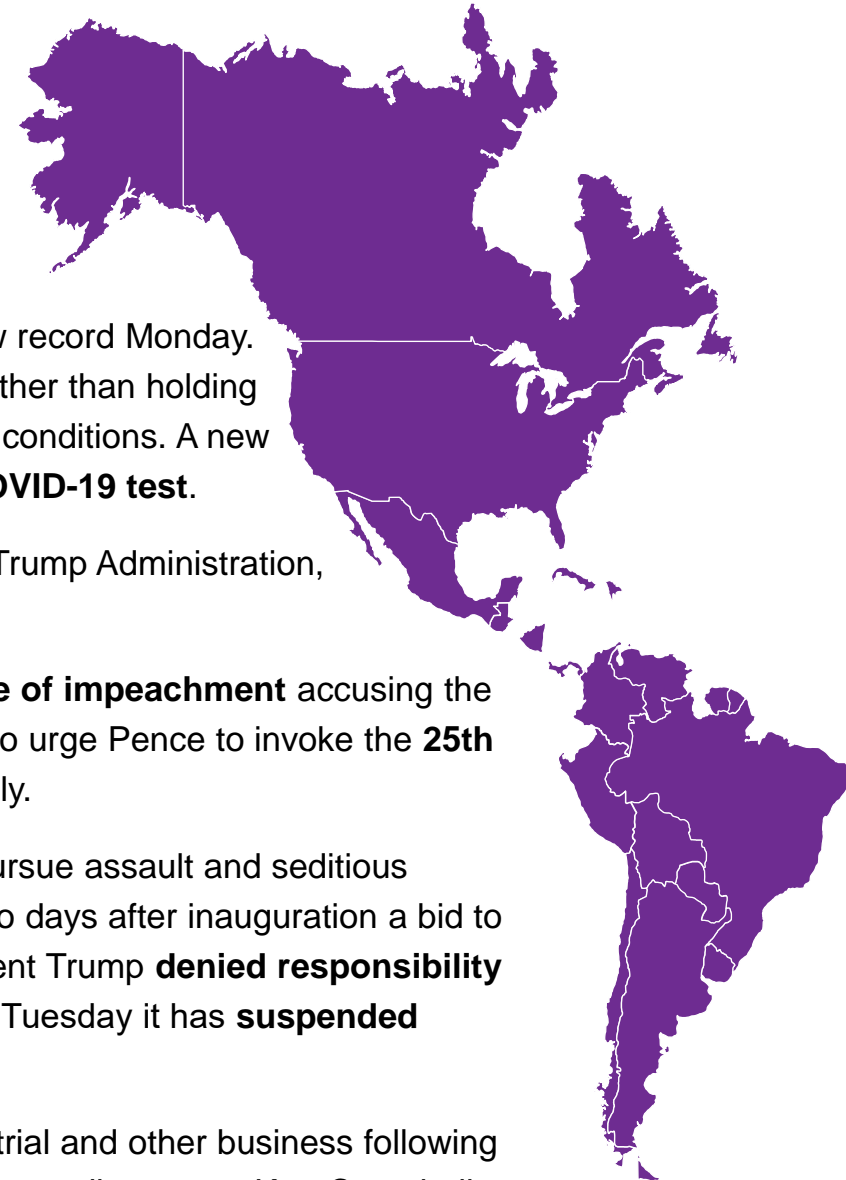
- A senior **Cuban** diplomat expressed hope the Biden Administration will “*recognize*” that Cuba is not a state sponsor of terrorism.
- **Mexico’s** government published medical marijuana regulations, three years after legalizing medical marijuana use; a vote on legalizing recreational marijuana could come as early as February. Mexico’s tourist destinations saw a holiday bump from traveling Americans, though levels remain below previous years. Mexico hit a new daily COVID-19 death record with 1,314 new fatalities confirmed on Tuesday.
- **Argentina** successfully passed clinical trials for a hyperimmune serum to combat COVID-19 developed with antibodies from horses, and its distribution will begin over the next few days.
- The **US and Canada** extended their border restrictions for another 30 days.

Americas: US

- Seven-day averages for new coronavirus **cases, hospitalizations, and deaths** each hit a new record Monday. The Trump Administration announced that it will begin administering all **vaccines available**, rather than holding back supplies for second doses, and expand rollout to adults over 65 or with underlying health conditions. A new rule from the CDC will require international air passengers to present a **pre-flight negative COVID-19 test**.
- The State Department abruptly **canceled overseas travel plans** in the final eight days of the Trump Administration, including UN Amb. Craft's contentious planned trip to Taiwan.
- With at least five Republicans joining Democrats in support, House will vote today on an **article of impeachment** accusing the Republican of inciting insurrection in a speech to his followers. After the House voted formally to urge Pence to invoke the **25th Amendment**, Pence sent a letter to House Speaker Nancy Pelosi that said he would not comply.
- Federal authorities have opened **criminal investigations** into over 170 people and plans to pursue assault and seditious conspiracy charges for some. The District of Columbia will keep **indoor dining closed** until two days after inauguration a bid to both curb transmission and decrease the risk of gatherings and violence at the Capitol. President Trump **denied responsibility** for his supporters' violent invasion of the US capitol last week. Alphabet Inc's YouTube said on Tuesday it has **suspended Donald Trump's channel** as it violated policies for inciting violence.
- **President-elect Biden** proposed that the Senate split days between the Trump impeachment trial and other business following his inauguration. Biden is expected to name Gary Gensler for SEC Chairman and veteran foreign policy expert Kurt Campbell to serve in the newly created role of Asia tsar.

China Bulletin: The Comprehensive Agreement on Investment and EU-China Relations

In the last days of 2020, the European Union and China finalized the Comprehensive Agreement on Investment (CAI), a deal seven years in the making that opens both markets to further investment, promises fairer competition for EU companies, and commits China to improving its labor standards and pursuing climate goals. But while the CAI delivers desired wins for both parties, it has also been the target of criticism throughout Europe and the US.

Following a year of growing international uneasiness with Beijing and concluding just weeks before a new, alliance-focused Biden Administration will take power in the US, the timing and substance of the CAI has prompted some analysts to look skeptically on China's dedication to its CAI commitments and motives to drive a wedge between the US and Europe.

As the EU market is already much more open to investment from China than is vice versa, many of the CAI's primary accomplishments focus on expanding EU access to China's market. The Agreement facilitates EU access to a cross-section of sectors, from removing joint venture requirements for new energy vehicles and private hospitals to matching the standard of US-China "Phase One" trade deal provisions on opening up financial services. While all EU member states, with the

exception of Ireland, already have bilateral investment treaties with China, they do not extend to the market access covered in the CAI. The agreement also addresses level playing field concerns, including provisions to prevent the forced transfer of technology or unauthorized disclosure of confidential business information as well as requirements for increased transparency on how China subsidized firms. Moreover, the CAI includes Chinese commitments to adhere to its Paris climate goals and international standards on labor rights.

For China, the CAI broadens access to some EU manufacturing sectors and energy industry and is expected to encourage further European investment in China. Top CCP economists may also consider more European competition as a positive for increasing the competitiveness of Chinese state-owned firms.

However, Beijing likely sees the CAI's most important benefit as one of politics, allowing Beijing to tout its commitment to openness and multilateralism after a year that has been bruising for international public opinion of China, particularly in the west. President Xi himself intervened to aid the deal, signaling its strategic importance to Chinese leadership. Many Washington observers also believe that the deal aids China by dividing the US and EU, pre-empting any Biden Administration efforts to coordinate policy with European allies – which incoming officials had indicated during CAI negotiations that they want to pursue.

Beyond broad concerns about the long-term implications of the EU becoming more economically intertwined with China, skeptical analysts have questioned how the CAI will be implemented and cast doubt on China's true commitment to labor, climate, and competition provisions. The deal does not include a new investor protection mechanism where EU firms can litigate disputes, though European officials say China's failure to implement the agreement could jeopardize Chinese access to parts of the European market. The most frequently criticized aspect of the deal, however, is how it addresses forced labor and other internationally condemned actions

from China. European Commission President Ursula von der Leyen declared that the agreement upholds European interests and values, while providing a “lever to eradicate forced labor” and encourage China's adherence to multilateralism and climate goals, with similar rhetoric echoed by other top officials. However, while the agreement includes a Chinese pledge to ratify outstanding International Labor Organization conventions, including two on forced labor, it does not include any specific timeline for this to happen, prompting many analysts to frame the EU's trust in Chinese concessions as naive.

The CAI has still yet to be signed by either party and must still be approved by the European Parliament, a process expected to take about one year and bring new calls for strengthening commitments on climate and labor rights. Even after that, the EU and China have agreed to a two-year deadline to negotiate a further investment protection agreement, ensuring that the topic will remain alive for years to come. Given its unfinished nature, the desire to ensure the CAI is signed could impact behavior from both the EU and China over coming months, possibly softening European criticism of Beijing and discouraging aggressive “Wolf Warrior” style diplomatic moves

from China. With a new Biden Administration taking office across the Atlantic, some analysts had already predicted that Chinese leadership would try to start 2021 on more positive footing, to curb international backlash against Beijing's 2020 decisions and potentially undercut Biden Administration alliance-building efforts through offering olive branches to US partners. Though last week's arrests of over 50 Hong Kong pro-democracy activists indicate that this trajectory is all but certain, efforts to lower the heat on other international disputes or sources of grievance remain possible.

Any discussion of EU-China relations is complicated by the fact that the EU's 27 member states are far from united on an approach China – or most other foreign policy issues. One of the reasons for the CAI's December announcement date was Germany's EU presidency in the second half of 2020, as Chancellor Merkel made concluding the investment deal a priority and German officials played a key role in getting other countries on board. But while other member states' interests and misgivings in relations with China range greatly, the bloc as whole continues to face a difficult balance: how to avoid being sucked into an unwanted binary of great power competition

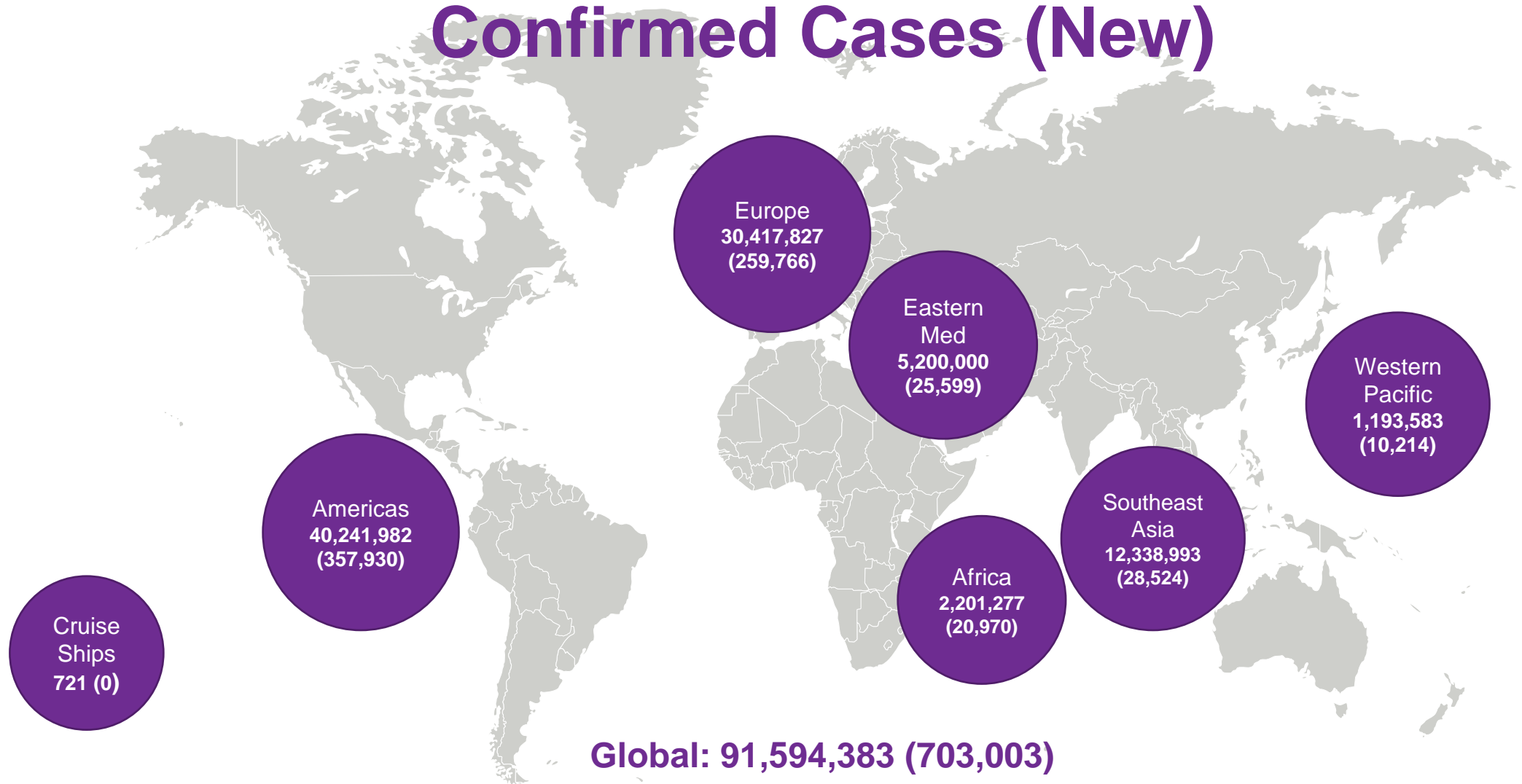
between Beijing and Washington while addressing many of the security, human rights, and economic concerns about China's rising power that are shared across the Atlantic.

As of 2100 hours US EDT on January 12, 2021

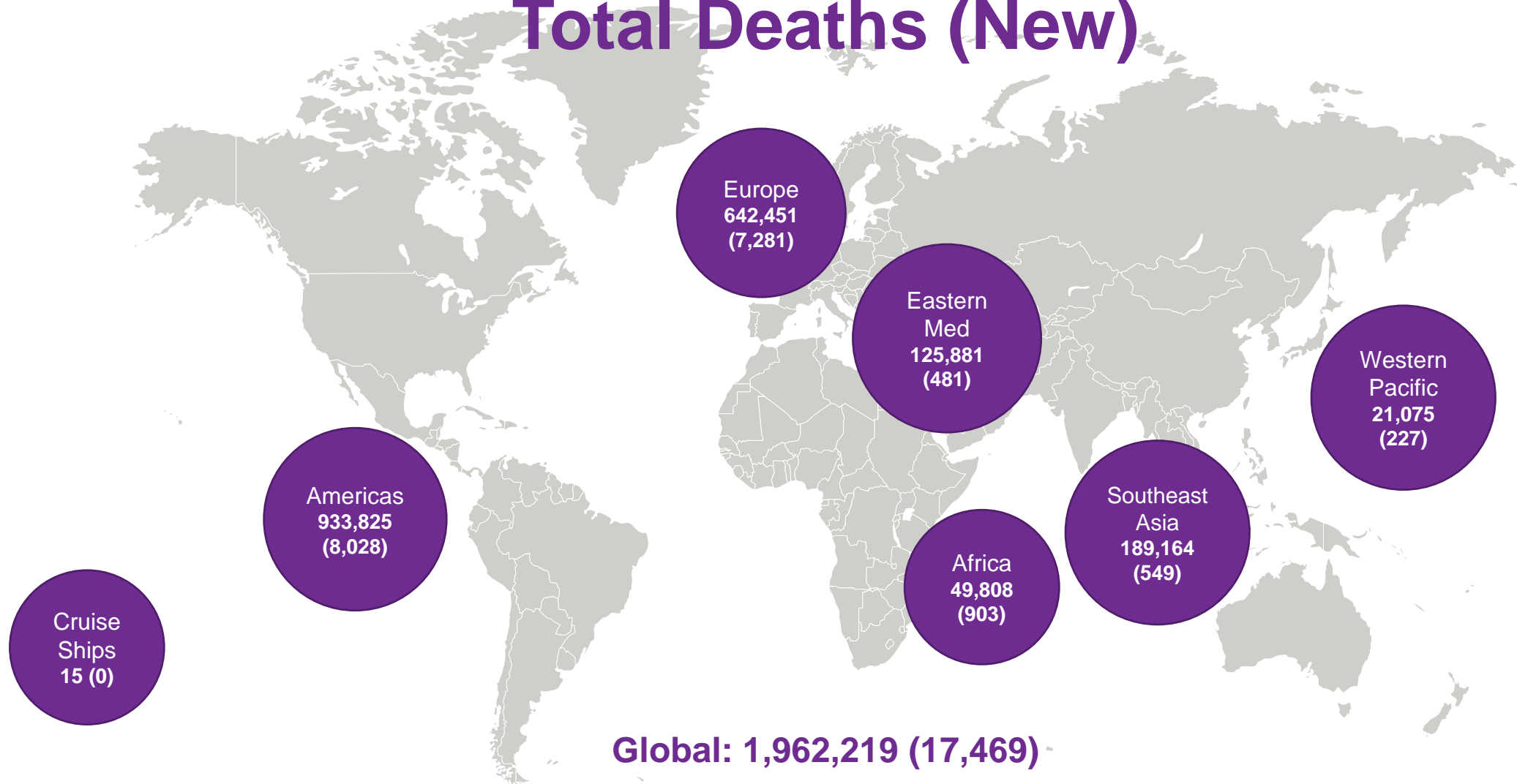
Confirmed Cases (New)

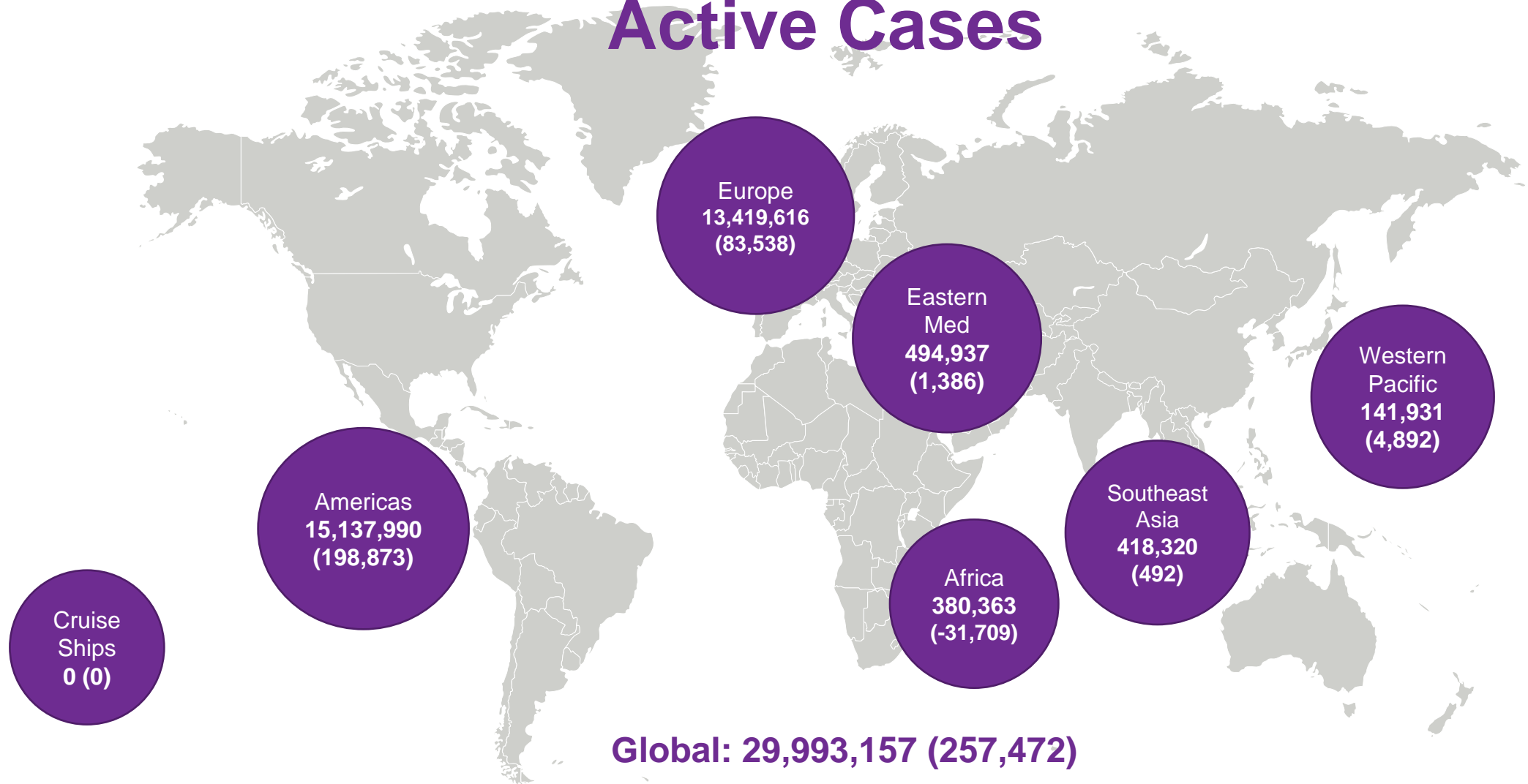
Total Deaths (New)
