AI Act

The European Commission published stakeholder feedback on Al definitions and prohibited practices. The report summarizes responses from two public consultations in connection with Al Office's draft guidelines complementing the Al Act. Many respondents call for clearer definitions to avoid misclassifying traditional software as Al and ask for practical examples of what falls under banned practices Read more

The European Commission published an FAQ and repository to support Al literacy. The FAQ explains how organizations can meet their duty to promote Al literacy under Al Act's Article 4 and how the obligation will be enforced. A new "living repository" also features real-world examples from companies sharing their experience with Al literacy initiatives. Read the FAQs, Access the repository

Data protection enforcement

The EDPB presented its 2024 Annual Report summarizing activities in the past year. The report provides a brief overview of the EDPB's key activities in the past year and introduces its 2024–2027 strategy. Read more

The Italian Data Protection Authority (Garante) fined Luka Inc. €5 million over its Al chatbot Replika. According to Garante, the provider of Replika—an Al virtual companion chatbot—failed to establish a valid legal basis for data processing, presented an insufficient privacy notice and had not implemented effective age verification mechanisms to prevent access by minors. The Belgian Market Court ruled on the use of personal data in online behavioral advertising. In an appeal against a €250,000 fine imposed on IAB Europe, the court confirmed that IAB Europe shares responsibility for the collection of user preferences for targeted advertising but annulled parts of the Belgian Data Protection Authority's (APD) earlier decision due to procedural shortcomings. The ruling follows a preliminary judgment by the Court of Justice of the EU (CJEU), which found that a cookie used to store users' privacy choices can qualify as personal data under the GDPR. German court decided not to block Meta's use of public user data for Al training. The Higher Regional Court of Cologne rejected a request from the German consumer rights group Verbraucherzentrale NRW to halt Meta's plan to use public Facebook and Instagram posts to train its Al models. <u>Read more</u>

Other GDPR updates

The European Commission has proposed more lenient GDPR record-keeping rules as part of its Fourth Simplification Omnibus Package. The draft legislation aims to amend Article 30(5) GDPR to exempt organizations with fewer than 750 employees from maintaining records of processing activities, unless they engage in "high risk" data processing. Read more

The French Data Protection Authority (CNIL) finalized its recommendations for better privacy protection in mobile applications. The guidance clarifies the responsibilities of app publishers, developers, SDK providers, and platform operators under the GDPR. Read more

IP & Al news

The European Union Intellectual Property Office (EUIPO) published a study examining generative AI and copyright under EU law. The highly anticipated study focuses on three areas: (i) the use of copyrighted works as training data and the opt-out mechanisms available; (ii) generation of content; and (iii) the wider implications of AI for the copyright ecosystem. The study provides both a technical and legal perspective. Read more

The U.S. Copyright Office published draft Part 3 of its Al report, focusing on training generative Al with copyrighted material. This released prepublication version examines whether Al training qualifies as fair use under U.S. law and highlights concerns around large-scale commercial use and market impact. It follows earlier reports on digital replicas (Part 1) and copyrightability of Al outputs (Part 2). Read more

Market updates

SoundCloud issued a statement to clarify its Al policy. In May 2025, SoundCloud revised its terms to state that it will not use user-uploaded content to train generative Al models for music creation. This update follows earlier concerns over ambiguous language in its February 2024 terms, which suggested broader Al usage rights. Read more

Microsoft announced five key commitments to support Europe's digital sovereignty and resilience. Over the next two years, Microsoft plans to increase data center capacity by 40% across 16 European countries. The company also pledges to strengthen legal protections against external government orders and to respect European cybersecurity and data protection laws. Read more
