AI Act

EU Commission has started a consultation on targeted adjustments of the AI Act. On 16 September, the Commission launched a call for evidence on the digital package: the Commission's digital simplification agenda. The initiative proposes inter alia targeted adjustments to the Artificial intelligence Act to ensure the optimal application of the rules. The initiative follows up on the comprehensive consultation on the Apply AI strategy which concluded in June. Stakeholders are invited to provide feedback by 14 October 2025. Read more

EU Commission has started a consultation on transparency rules under Article 50 of the Al Act. The process aims to create guidelines and a Code of Practice for labelling Al-generated or manipulated text, audio and video, as well as disclosure obligations for biometric categorization and emotion recognition. EU Commission has started a consultation on draft guidance and reporting template on serious Al incidents. Feedback can be provided by 7 November. Read more

Data protection news

CJEU issued a landmark decision on pseudonymization of personal data (C-413/23). The Court held that pseudonymisation can - depending on the circumstances - prevent entities other than the controller from identifying the data subject. The decision could have major practical impacts on how companies handle pseudonymized data. Read more

The EU General Court dismissed an action for annulment of the EU–U.S. Data Privacy Framework. The court dismissed a challenge by MEP Philippe Latombe, confirming that U.S. safeguards meet EU adequacy standards. This ruling secures the current transatlantic transfer mechanism, though a further appeal to the CJEU remains possible. Read more

The EDPB published draft guidelines on the interplay between the DSA and the GDPR. The guidelines aim to clarify how the GDPR applies to obligations under the Digital Services Act (DSA). The guidelines cover areas where platforms process personal data, such as notice-and-action mechanisms or recommender systems. It also calls for closer cooperation between Digital Services Coordinators and Data Protection Authorities. Guidelines are subject to public consultation which ends on 31 October 2025. Read more

France's CNIL issued multiple fines for cookie use. For example, CNIL fined fashion retailer SHEIN (€150 million) for placing cookies without user consent and Google (€325 million) over Gmail ads and invalid cookie consent. Read more

The Austrian DSB ordered YouTube to grant full access to personal data under Art. 15 GDPR. The decision requires disclosure of processing purposes, storage periods, data recipients and tracking cookies, making clear that generic tools or privacy policies do not meet access obligations. Read more

IP & Al news

Swedish rights society Stim launched AI music licensing framework. The license is based on voluntary collective management and covers only works by creators who have explicitly given their consent. This move aims to bridge the gap between copyright law and the growing demand for AI training data. Interestingly, STIM explained the license requires the use of independent attribution technology, allowing AI-generated music to be traced back to the human-created works to enable transparent and accurate revenue distribution. Read more

Anthropic agrees to settlement in class-action over the use of copyrighted books in Al training. The settlement, covering around 500,000 works, provides about \$3,000 per book and requires Anthropic to delete the LibGen and PiLiMi datasets once litigation holds expire. If approved, this would be one of the first major settlements in similar disputes. Read more

Market Updates

China unveiled its Global Al Governance Action Plan days after the U.S. announced its own Al strategy. The plan promotes international cooperation and proposes a global Al governance organization. While framed as collaborative, the move reflects China's strategic ambition to lead Al development by 2030. Read more

ETH Zurich and partners launched "Apertus," a fully open-source multilingual AI model released under a permissive license. The model comes in 8B and 70B parameter versions and is trained on 15 trillion tokens across 1,811 languages. It provides a legally sound tool for research and commercial use due to safeguards like opt-out compliance and non-memorization of training data. Read more
