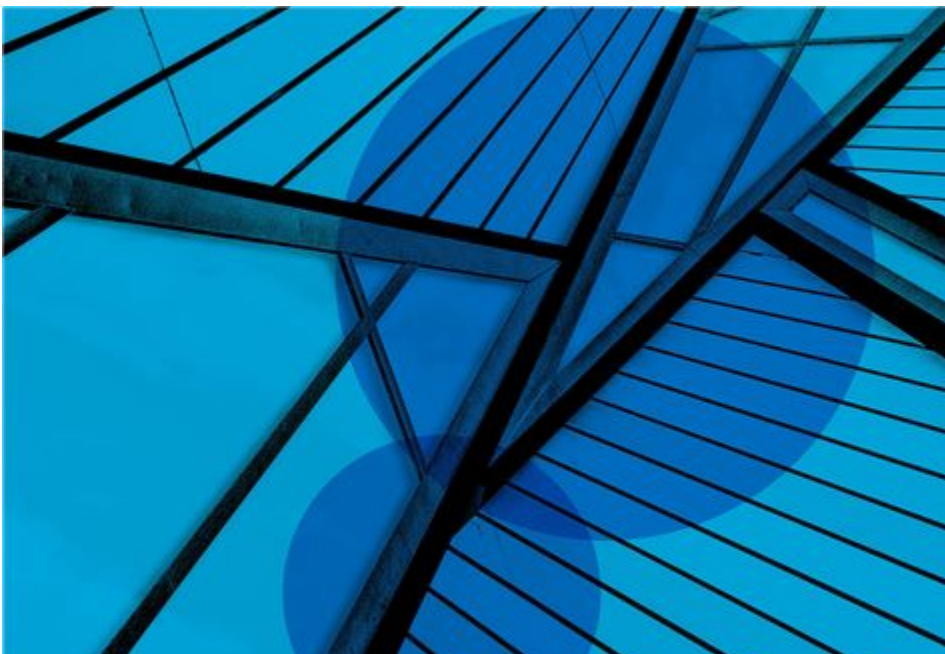

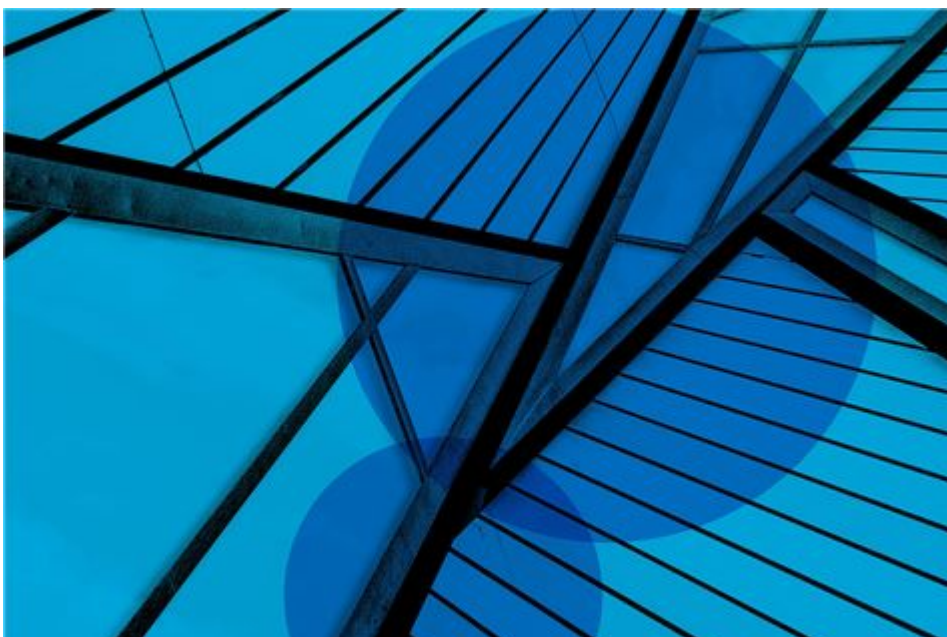


Episode 9: A conversation with Lynette Keyowski from REACH Canada

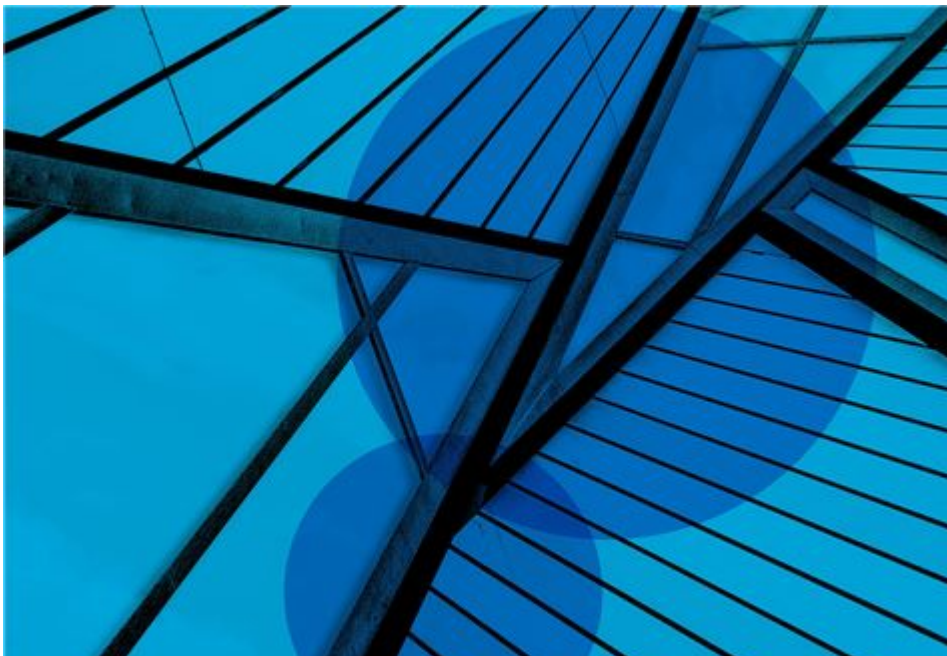


Episode 8: A conversation with Ashley Kielbratowski from Harbr

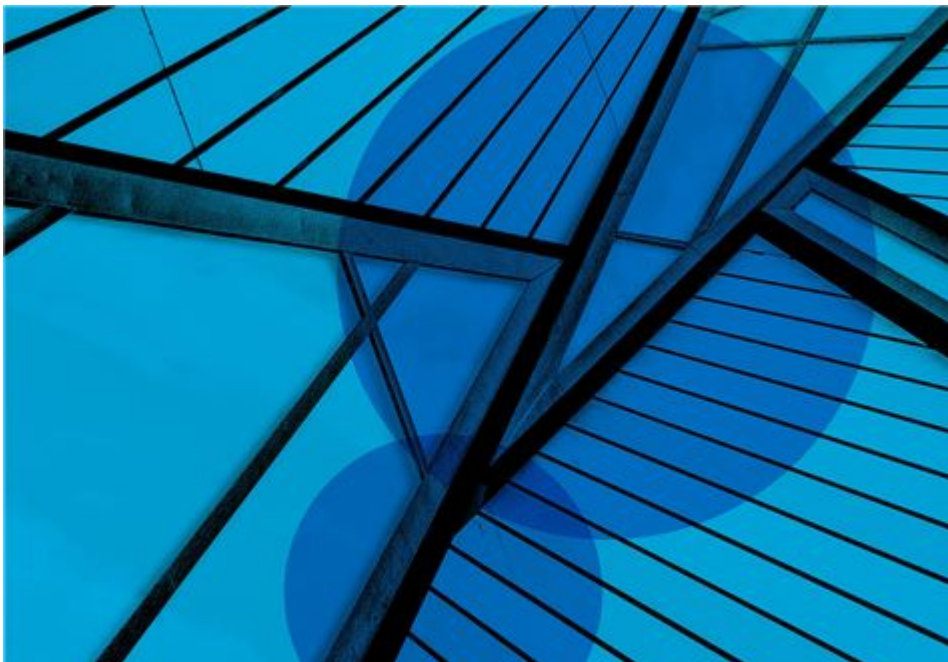


Episode 6: A conversation with Arnab Dastidar from SoulRooms

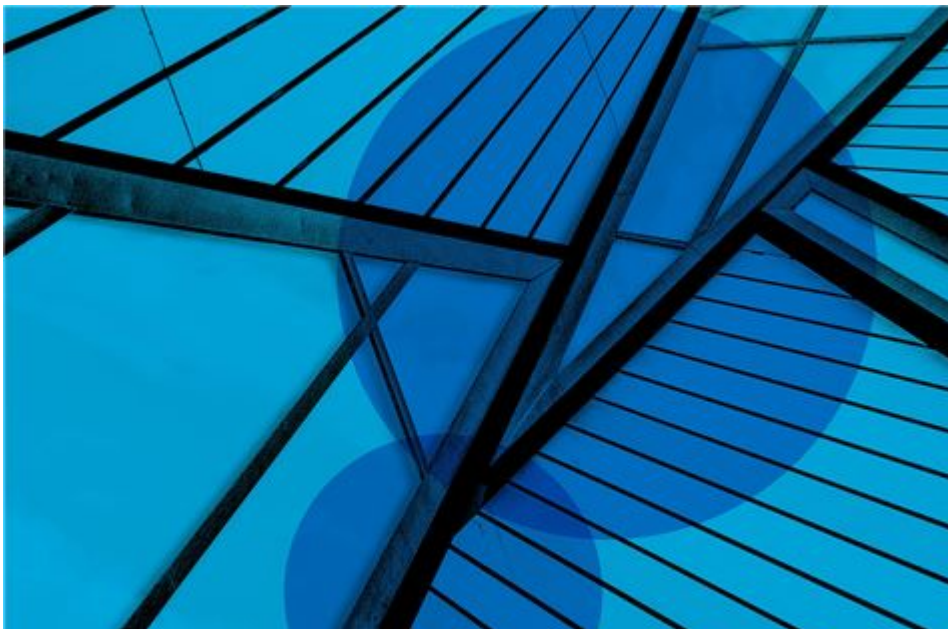


Episode 4: A conversation with Theresa Warnaar from KingSett Capital

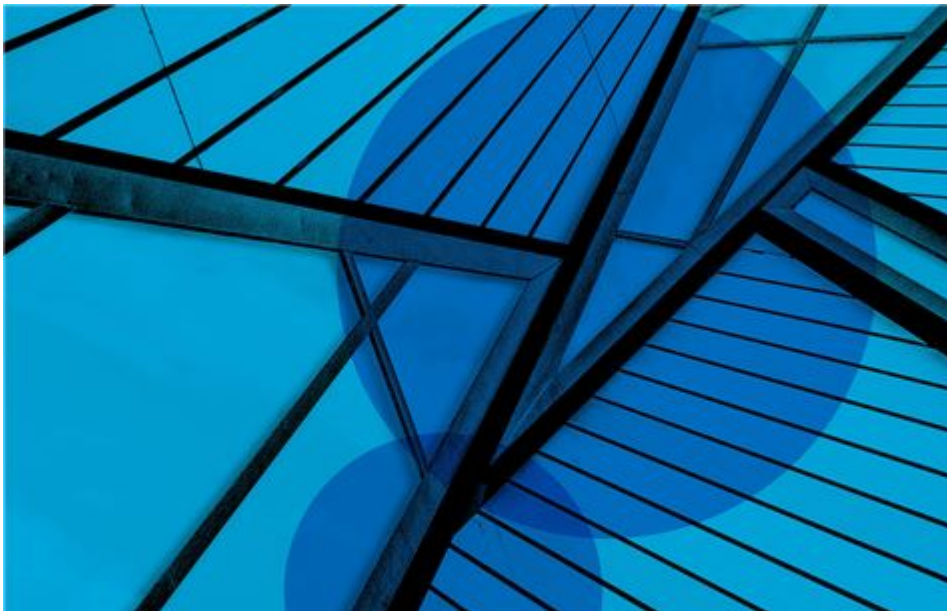


Episode 3: A conversation with Anita Ramdas from ShuffleSpace

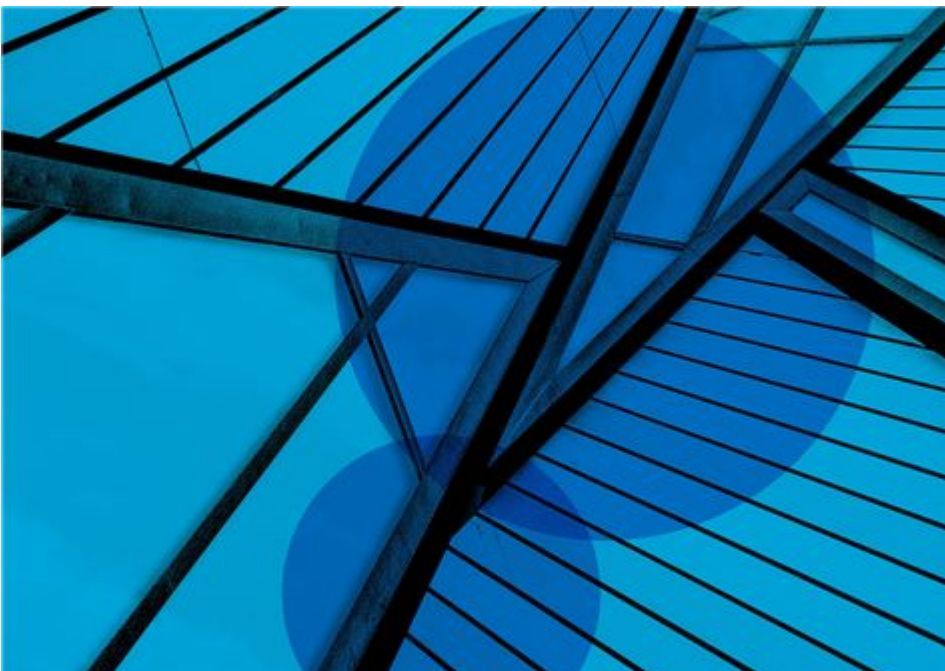
