Overview

Sean Cenawood, the former Chief of the Civil Frauds Unit in the United States Attorney's Office for the Southern District of New York, is a member of Dentons' Litigation, White Collar and Government Investigations, and Health Care practices. He focuses on government and internal investigations, as well as complex civil litigation. Sean has handled dozens of major investigations and litigations involving hospitals, pharmaceutical manufacturers, physicians, importers, medical device manufacturers, sports stadiums, recipients of federal stimulus monies and mortgage brokers, as well as a variety of other enforcement actions brought by the government.

Sean is well-versed in the government's anti-fraud efforts, having regularly directed the investigative activities of law enforcement agents from the Federal Bureau of Investigation, the Department of Health and Human Services, the Centers for Medicare and Medicaid Services, the National Institutes of Health, the Department of Defense, the National Science Foundation, the Drug Enforcement Administration, the National Endowment for the Arts, the National Endowment for the Humanities and various other agencies' offices of inspector general.

Sean has also coordinated investigations with the New York State Attorney General, various states' Medicaid fraud control units, the Special Inspector General for the Troubled Asset Relief Program (TARP) and President Obama's Financial Fraud Enforcement Task Force.

Prior and Present Employment

Prior to joining Dentons, Sean served 13 years as an Assistant United States Attorney in the Southern District of New York, including supervisory tenures as Affirmative Civil Enforcement Coordinator, Health Care Fraud Coordinator, Senior Litigation Counsel, and Chief of the Immigration Unit. His last position with the government was as Chief of the Civil Frauds Unit, where he oversaw investigations of large-scale and sophisticated financial frauds, including health care fraud, mortgage fraud, pharmaceutical fraud, bank fraud, procurement fraud, grant fraud, and fraud in connection with federal monies and spending allocated under various stimulus and economic recovery legislation such as the American Recovery and Reinvestment Act and TARP.

During the two and a half years in which he had responsibility for supervising the entire affirmative civil enforcement

practice of the US Attorney's Office, Sean oversaw the recovery of close to \$400 million. As such, Sean has considerable experience with the enforcement of federal anti-fraud laws and well understands the concerns that arise when the government pursues civil remedies in lieu of, or in addition to, sanctions under the criminal laws, including the government's ability to freeze assets, broad pre-complaint discovery by the government, the lower standard of proof compared with the standard for criminal fraud cases, and the wide range of relief available to the government, such as the ability to seek statutory penalties, treble damages, forfeitures, receiverships and other far-reaching injunctive relief.

During his government service, Sean tried almost two dozen cases, all but one of which ended in a government verdict or resolution on terms favorable to the government. Sean has also argued numerous appeals before the United States Court of Appeals. He was the lead or co-lead counsel in high-profile cases such as the ground-breaking housing settlement of whistleblower allegations that Westchester County falsely certified to the government that it had acted to "affirmatively further fair housing," the civil rights investigation that prompted the owners of the new Yankee Stadium to create one of the most accessible sporting venues in the nation for persons with disabilities, and the litigation that resulted in the owners and operators of the iconic Madison Square Garden agreeing to undertake extensive renovations to achieve similar accessibility.
