Overview

Seena Forouzan is a senior managing associate in Dentons' San Francisco/Oakland offices and a member of the firm's **Litigation and Dispute Resolution** practice group.

Prior to joining Dentons, Seena served as Of Counsel for a boutique litigation firm. There, Seena's legal practice focused on complex, high-value cases nationwide across a variety of subject matters, including but not limited to: cryptocurrency litigation, regulatory work in cutting-edge industries (digital assets, cannabis), complex frauds, breach of contract, fallout from mergers and acquisitions, adversarial proceedings in bankruptcy matters, federal civil RICO (and related State-equivalents), and issues of first impression in the high-end, luxury timeshare space and in the insurance sector.

He has extensive experience on both sides of the "v" and prides himself on crafting elegant solutions to seemingly intractable problems, with an emphasis on resolving issues before they deteriorate into expensive (and emotional) distractions.

Seena earned his undergraduate degree in 2014, *magna cum laude* from the University of California, Irvine. In 2017, he graduated Emory University School of Law with High Honors, ranked at the top of his class. At Emory, Seena served as the Executive Editor of Emory's Supreme Court Advocacy Program. In that role, he authored and edited several briefs submitted to the Supreme Court of the United States. Additionally, Seena was recognized as a member of the Order of the Coif, a distinction reserved for the top 10% of graduates, and received both the Paul Bryan Prize for Outstanding Achievement in Constitutional Law and the Myron Penn Laughlin Award for Best Student Comment. His article, *The Officer Has No Robes: A Formalist Solution to the Expansion of Quasi-Judicial Immunity*, was published in the Emory Law Journal, 66 Emory L.J. 123 (2016), and has been cited by a Michigan Appeals Court, appellate briefs, and various academic articles.

Seena has routinely devoted himself to public service and, in 2022, received the James Madison Freedom of Information Award by the Society of Professional Journalists for his work in public record act cases.

Additionally, in 2022, Seena earned his mediation certification from Pepperdine Law School's Straus Institute for Dispute Resolution, and is a member of the Association for Conflict Resolution.

Prior to joining Dentons in 2022, Seena represented a diverse array of clients, including

- Representation of a cryptocurrency exchange in various litigation concerning phishing, market manipulation, breach of fiduciary duty; and in a CFTC investigation into compliance with commodities and securities laws.
