### Sponsor Licence Compliance Self-Audit Tool

#### What is sponsor licence compliance?

To sponsor an overseas worker in the UK, a company must hold a valid sponsor licence. To maintain the licence, sponsors must ensure that they adhere to Home Office requirements and meet their sponsor duties. A Home Office audit can happen at any time and sponsor licence holders must ensure they have the right processes and policies in place to demonstrate compliance.

#### Why is this important?

Audit activity and enforcement action has increased rapidly since 2024 and the trend is likely to continue.

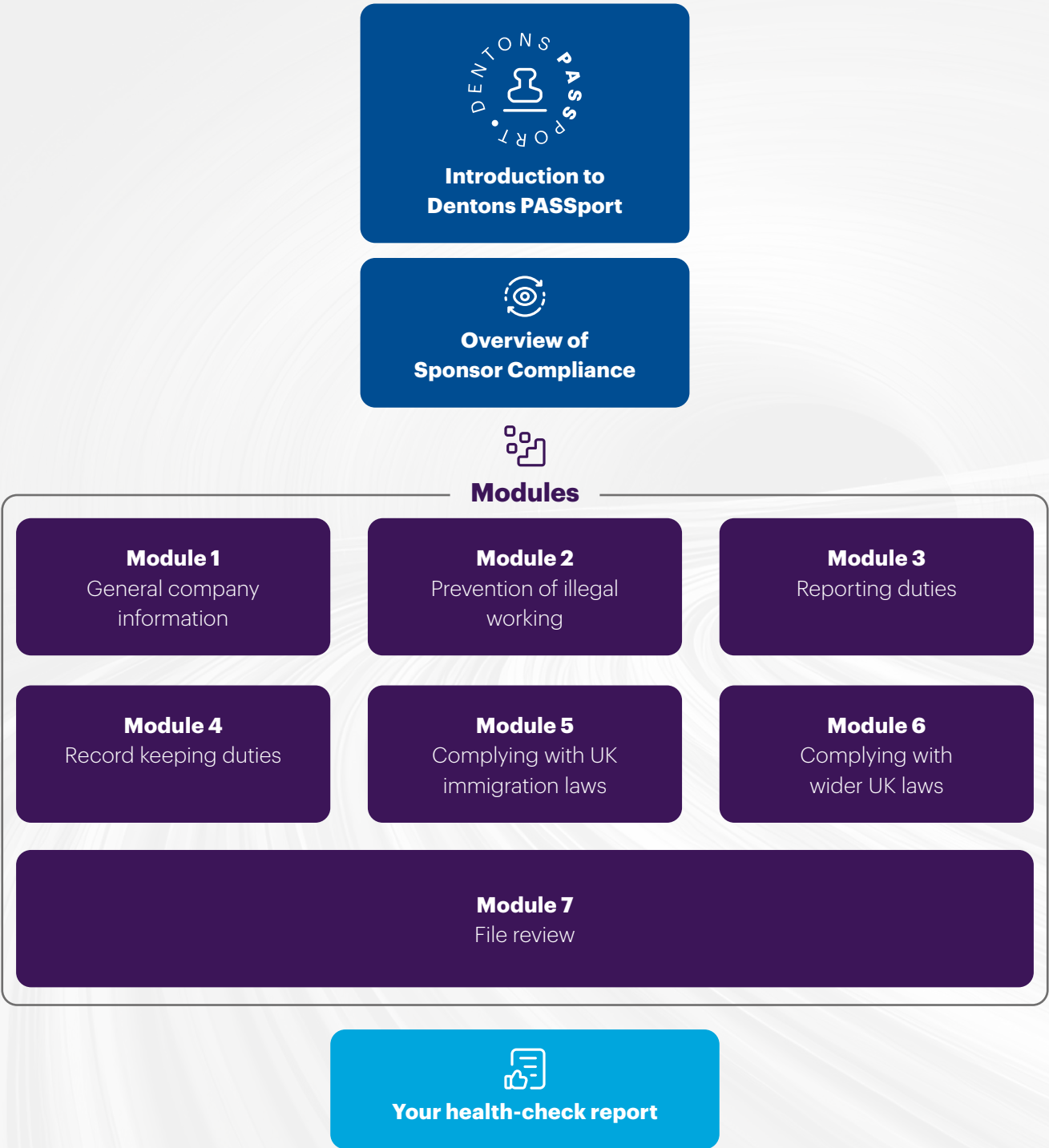
An unsuccessful audit can result in the revocation or suspension of your licence, restricting future sponsorships or cancelling the visas of existing employees. More severe personal sanctions can apply to those who deliberately breach immigration rules.

#### What does our new self-audit tool do?

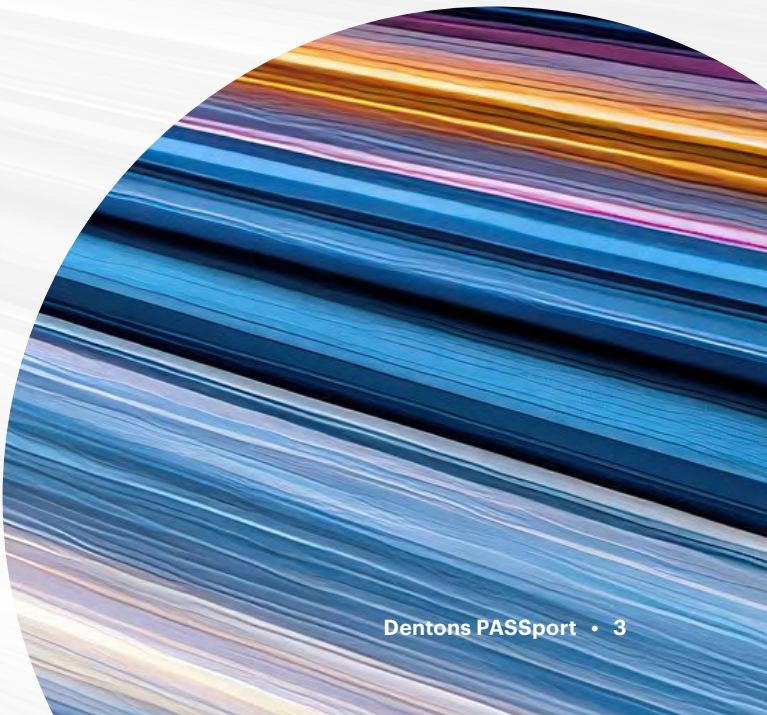
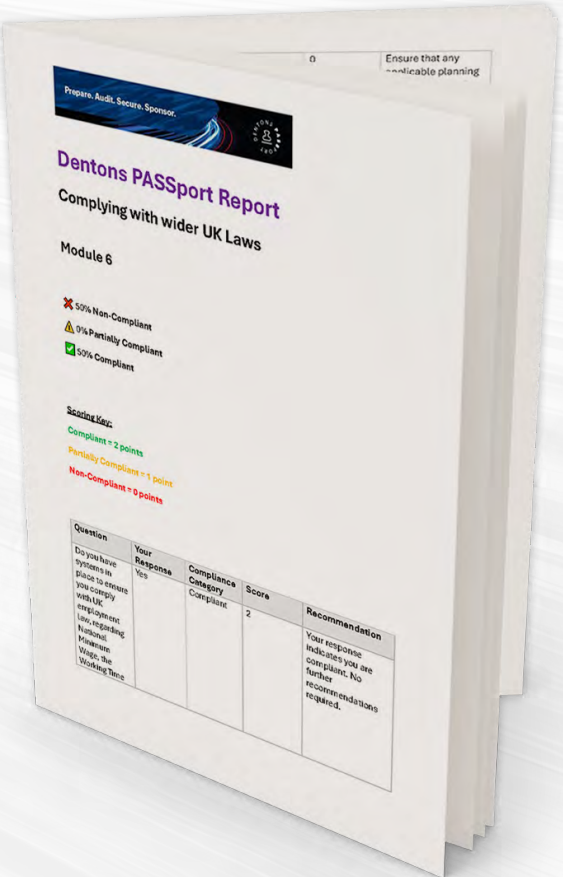
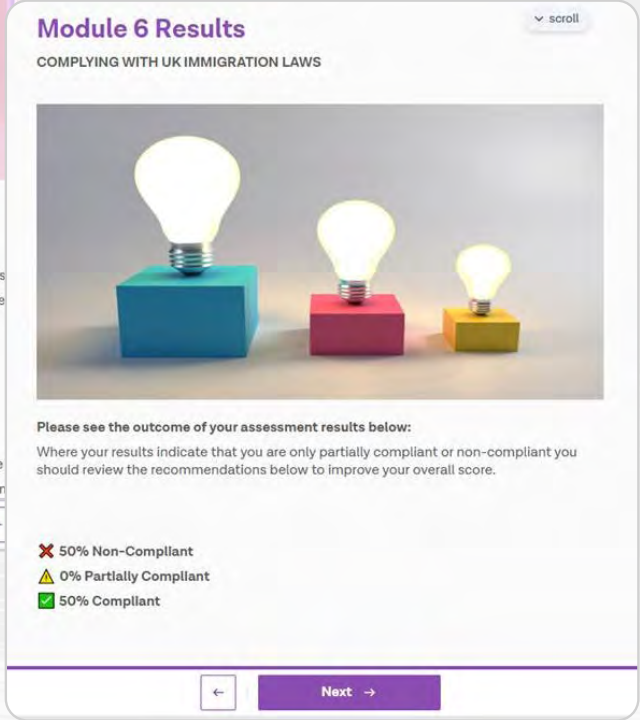
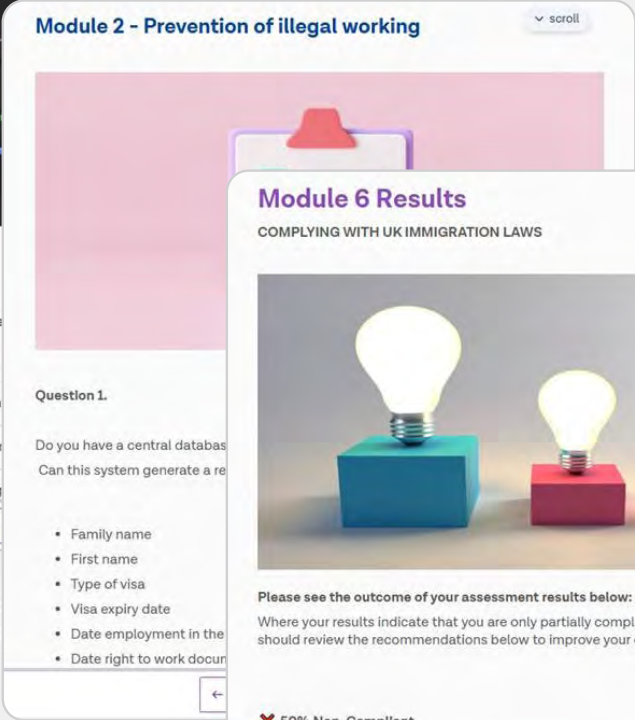
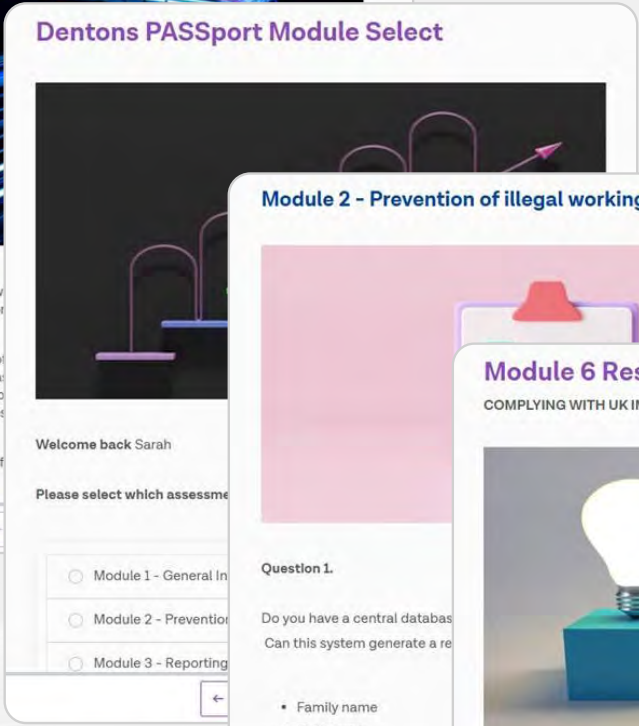
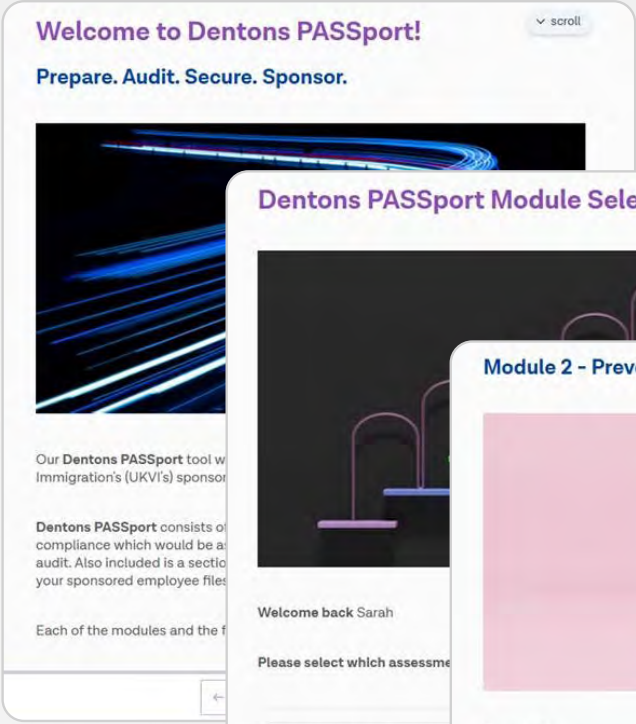
