# 25 Year Environment Plan



A comprehensive and long term approach to maintaining, enhancing and restoring the natural environment over the next 25 years

### **Key policy points**



A goal to eliminate avoidable plastic waste by the end of 2042



Extend the 5p carrier bag charge to all retailers in England



A new environmental watchdog to hold government to account



Focus on using resources efficiently – with a target to double resource productivity by 2050

### **Key policy points**



Focus on air quality – including ending the sale of new conventional petrol and diesel cars and vans by 2040



A plan for a new chemicals strategy



Increasing woodland in England with a target of 12 per cent cover by 2060 (planting 180,000 hectares by end of 2042)



Introducing a principle of "environmental net gain" into planning decisions

#### What has happened so far?

#### Chemicals

- EAC inquiry on the future of chemicals regulation (closed October 2017) - recommended convergence on chemical regulations between the EU and UK
- Government will develop:
  - an overarching strategy to address the safe use and management of chemicals
  - · an early warning system
- Defra is spending £5.8 million on IT to enable registration and regulation of chemicals placed on the UK market (a contingency plan for no deal)



#### Have your say

- Environmental Audit Committee Inquiry to examine key decisions around the Plan's overall ambition and approach (deadline 28 February 2018)
  - Ambition and Reporting
  - Implementation
  - Principles and oversight
- Further consultations on a new statutory environmental body, and on single use plastics are planned for 2018

### **Key criticisms**

Not backed by legislation

Delivery mechanisms are too vague and lack detail

25 year timescale is too long

Plans to tackle plastic waste don't go far enough

#### **Criticism**

"Whilst I'm glad the government have responded to my call to maintain environmental standards post-Brexit, today's plan lacks the commitments or the pace of action required to deliver its ambitions."
