






## Global VC deal activity

Q4 2019: global median deal sizes (in \$mn)





- 704 deals (+13% 2018)
- Significant transactions (FlixMobility, GetYourGuide, Frontier Car Group, N26, Celonis)
- E-commerce, Software & Analytics, Fintech and Mobility strongest sectors
- Larger financing rounds led by foreign investors




