# Illinois Supreme Court Rules and the ABA Model Rule

- Attorneys who are licensed in Illinois as in-house counsel under Illinois Supreme Court Rule 716 may perform Pro Bono service in Illinois without any additional registration or affiliation requirements.
- ► Illinois Supreme Court Rule 756(f) requires all attorneys licensed in Illinois to report, in connection with the attorney's annual ARDC registration, Pro Bono legal services provided and qualified monetary contributions made during the preceding 12 months.
- ➤ Under *ABA Model* Rule 6.1, every lawyer has a professional responsibility to provide legal services to those unable to pay. A lawyer should aspire to render at least (50) hours of Pro Bono publico legal services per year.

# What is Pro Bono? Who defines?

## **Pro Bono Institute Definition:**

- Pro bono refers to activities undertaken normally without expectation of fee and not in the course of ordinary commercial practice and consisting of
  - (i) the delivery of legal services to persons of limited means or to charitable, religious, civic, community, governmental, and educational organizations in matters which are designed primarily to address the needs of persons of limited means;
  - > (ii) the provision of legal assistance to individuals, groups, or organizations seeking to secure or protect civil rights, civil liberties or public rights; and
  - (iii) the provision of legal assistance to charitable, religious, civic, community, governmental or educational organizations in matters in furtherance of their organizational purposes, where the payment of standard legal fees would significantly deplete the organization's economic resources or would be otherwise inappropriate.

# What is Pro Bono? Who Defines?

## **American Bar Association Definition**

- ➤ (a) provide a substantial majority of the (50) hours of legal services without fee or
  expectation of fee to:
  - > (1) persons of limited means or
  - ➤ (2) charitable, religious, civic, community, governmental and educational organizations in matters that are designed primarily to address the needs of persons of limited means; and
- ➤ (b) provide any additional services through:
  - (1) delivery of legal services at no fee or substantially reduced fee to individuals, groups or organizations seeking to secure or protect civil rights, civil liberties or public rights, or charitable, religious, civic, community, governmental and educational organizations in matters in furtherance of their organizational purposes, where the payment of standard legal fees would significantly deplete the organization's economic resources or would be otherwise inappropriate;
  - $\succ$  (2) delivery of legal services at a substantially reduced fee to persons of limited means; or
  - $\succ$  (3) participation in activities for improving the law, the legal system or the legal profession.


# What are the keys to a successful corporate legal department Pro Bono program?

- ➤ Support from the top
- >Support from the enterprise
- ➤ Local v. National/National v. Local
- ➤ Matching interest to availability
- ➤ Variety of programs (intensive when available)
- ➤ Training and Partnering

# What are Potential Challenges to Developing Corporate legal department Pro Bono program? > Changes in leadership > Changes in corporate organization > Culture > Lack of Malpractice Insurance



## Lack of Malpractice Insurance Is NOT a Major Hurdle

- >Malpractice claims are VERY unusual in Pro Bono
- >Work with a legal service provider or non-profit legal services provider that provides coverage to those Pro Bono lawyers who work on sponsored programs
- ➤ Obtain coverage directly from insurer
  - >Endorsement to existing policy
  - ➤ Standalone policy
- >Obtain coverage from National Legal Aid and Defenders Association
- ➤ Self-insure

# Partnering with Law Firm and/or Legal Aid

## Formation and Implementation

- >Assume that the partnership will be long-term
  - >Assess project status form time to time
  - >Be open to evolution and mid-course corrections
  - ➤ Succession planning
- > Roles in Partnership
  - >Roles of each party proportional to its capacity, size, skills and interests
  - ➤ Open communications plan
  - ➤ Clearly defined expectations
  - ➤ Consider teams and whether peer-to-peer or "mentoring" relationships are appropriate
