

## VAT ID Number Checker - validation VAT numbers in EU cross border trade

# VAT number validation made easy

Meet new EU VAT obligations by continuously validating the VAT identification numbers of your business customers.

The VAT Information Exchange System (VIES) is the European portal used for the validation of VAT identification numbers. If either goods or services are sold cross-border, the supplier may use the zero VAT rate or the service provider will reverse charge the VAT to the customer reversibly due by the customer when certain requirements are met. One of those requirements is that the customer must be identified for VAT and should have a valid VAT identification number.



### The challenge

Since 2020, new stricter VAT regulations make the verification of VAT identification numbers of business customers vitally important when applying the zero VAT rate or reverse charge mechanism. As VAT identification numbers change from time to time because of activation and de-activation, it is important to continuously check and record the validity of VAT identification numbers of your business customers. Business customers may also share VAT identification numbers from various EU member states with your business, for supply chain optimization purposes or project-driven reasons.

To check the validity of these numbers, the EU offers the VIES portal. However, this system allows you only to check VAT numbers one-byone. This obviously means extra time, human resources and thus extra costs to verify the use of correct VAT identification numbers. At Dentons we believe that VIES checking should be part of your master data management or could even be applied at a transactional level. Dentons' VAT Information Exchange System Service is adaptable to every business internal control framework and can be linked to every organization's ERP system.

Issuing invoices to business customers with incorrect, incomplete or unverified VAT numbers will bring your business two potential issues:

- 1. As selling party, you will be assessed for local VAT
- 2. As selling entity, you risk a penalty and interest payments

In addition, each VAT registration ID will be connected to a unique confirmation code as evidence. The confirmation codes are stored and accessible in our database. Our solution does not only check the validity of the VAT identification numbers provided, but also confirms if the country code and EU member state mentioned in the master data are correct. We can check the business customer's name and address against the name and address recorded in your master data. Depending on your needs, Dentons also provides storage for the validation reports, so that evidence is secured.

Checking the VAT identification numbers via VIES not only fulfils the stricter VAT compliance duties, but also keeps your business customers' related master data up to date.


