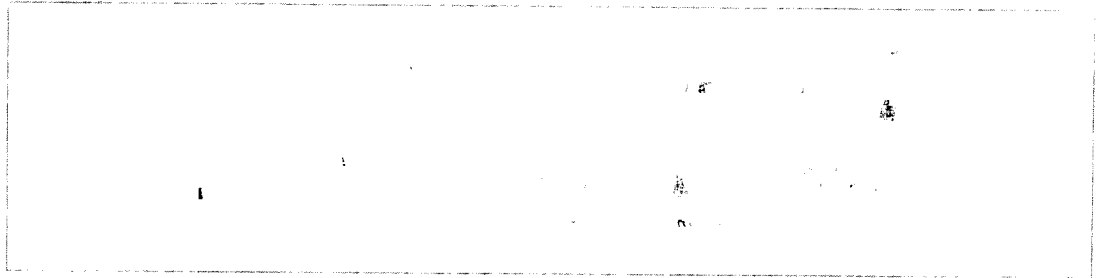

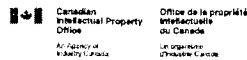

Think you received a fake notice concerning your patent or trademark registrations?

These scam mail-outs or emails are designed to closely resemble Canadian Intellectual Property Office (CIPO) notices.

## 5 quick facts about scam notices

- 1.** Often say that your patent or trademark protection is about to expire and ask you to renew registrations or pay fees (usually higher than CIPO fees).
- 2.** Can include details from public records to sound legitimate.
- 3.** Can offer to add you to directories which appear official, or offer services similar to those already provided by CIPO.
- 4.** Might say things like "patent cancellation notice" or "important notification regarding your federal trademark."
- 5.** Some use "Canada" or "Canadian" in the company name and letterhead, making them appear official.

Legitimate notices about Canadian patents or trademarks nearing expiry will only come from CIPO.
