



Locations in prown represent offices that are in the process of separating from Dentons.



Creating a legal entity and structuring your business

Although it is possible to start a business as an individual trader, we recommend to all of our SME partners the incorporation of a legal entity, generally a private company, for the protection of their personal assets and for their own protection from liability. In relation to the incorporation of a private company, we can assist you by:

- providing legal advice on how to create and structure a company;
- providing legal advice on the incorporation of the company with the Registrar of Companies;
- drafting or reviewing the constitutive and operational documents of your company;
- providing company secretary activities;

2. Protecting your intellectual property

Your ideas and creations, such as your brand name or the designs you invent, are unique and can be protected. In relation to your intellectual property, we can assist with:

- legal advice on taking the necessary steps to protect your intellectual property;

3. Commercial operations

5. Data protection

Data protection is the process to secure the privacy and integrity of the data you collect. It is imperative for any business, including SMEs, to ensure that it is compliant with the rules regarding data protection in Mauritius. We can provide legal assistance by:

- advising with respect to your data protection obligations;
- assisting you in registering as a Data Controller or Data Processor with the Data Protection Office (DPO), including liaising directly with the DPO;
- drafting or reviewing data privacy policies to ensure compliance with data protection laws.

6. Immigration

Should you wish to employ foreign workers, we can help you at every stage of the process. Our services include:

 advising you on immigration matters, including on the types of permits available in Mauritius and which would be most suitable for your organisation; assisting you with the application for the necessary permits with the relevant authorities, including liaising with the relevant authorities throughout the process.

7. Regulatory compliance

Compliance with anti-money laundering regulations and countering the financing of terrorism are some of the most important aspects to factor in while running a business, and these also apply to SMEs. It is apposite to note that you should not only be aware of these regulations, but you should also be constantly complying with them. You should also be mindful of the different types of permits that may be applicable to your business activities. We can provide the following compliance support services:
