WHAT WE'RE WATCHING

Anti-Lukashenko protests are expected to be held today to mark the unofficial Belarus Freedom Day holiday, which commemorate the declaration of independence by the short-lived Belarusian Democratic Republic in 1918.

Tensions in the country remain high as the exiled leader of Belarus' pro-democracy movement, Svetlana Tikhanovskaya, called this week for a "second wave" of protests and international mediation to end the crisis.





Global

Confirmed coronavirus cases globally surpassed 124.7 million, with deaths at 2.7 million. Daily new cases rose to 646,657, the highest since January 16.

- A UK study found that most people hospitalized for COVID-19 suffered from "*long COVID*," with only 29 percent of those discharged fully recovered.
- The US and EU announced that they would relaunch a **bilateral dialogue** to discuss challenges posed by Russia and China.
- A tanker remained wedged in the Suez Canal, like a "beached whale," blocking traffic for more than a day.
- Japan officially launched the **Olympic torch relay** on Thursday, four months before the Tokyo Summer Games are due to begin, in a ceremony at which spectators were banned and participants distanced from one another.

COVID-19 Vaccine


An EU inspection identified a stockpile of vaccine doses at an AstraZeneca factory in Italy, which may be barred from export unless they are destined for the bloc.

- The UK and the EU released a joint statement attempting to allay anxieties over vaccine supply after the EU passed a measure that would allow it to block vaccine exports.
- Janssen has filed in Brazil for emergency use authority for its COVID-19 vaccine developed by Johnson & Johnson.
- An updated company analysis of the coronavirus vaccine developed by AstraZeneca and the University of Oxford showed that the two-shot regimen was robustly effective — 76 percent at preventing symptomatic illness — according to a news release from the drugmaker.
- Finland will resume the use of the AstraZeneca vaccine.

COVID-19 Vaccine

Globally, 489.03 million have received vaccinations.

More than half of Israel's population has been fully vaccinated with two doses of the coronavirus vaccine, per the country's health minister. COVID-19 vaccine doses administered per 100 people, Mar 24, 2021 Total number of vaccination doses administered per 100 people in the total population. This is counted as a single dose, and may not equal the total number of people vaccinated, depending on the specific dose regime (e.g. people receive multiple doses).

Markets & Business

After cutting Xinjiang from its supply chain, fashion giant H&M has come under official attack in China, with state media outlets calling for consumers to boycott the brand, online shopping platforms pulling its products and Chinese celebrities canceling endorsement deals.

- The **Cruise Lines International Association** called on the US to scrap "*outdated*" cruise restrictions and permit sailings to begin in July.
- **Ryanair and WestJet** announced plans to increase summer flight schedules on the strength of vaccination campaigns.
- The business activity index of the **US oil and gas sector** hit a record high from Q4 2020 to Q1 2021.
- **Tencent Holdings** confirmed that it had met with antitrust regulators amid scrutiny on large tech companies and vowed to make its platform open to competitors.
- India's antitrust watchdog ordered a probe into WhatsApp.

- A Federal Reserve official predicted that the US may raise interest rates in 2023.
- Shares in dual-listed Chinese companies fell sharply on Thursday in Asia after the U.S. securities regulator adopted measures that would kick foreign companies off American stock exchanges if they do not comply with US auditing standards.
- Intel will increase spending on US plants by as much as \$20 billion to compete with Asian chip dominance. Concurrently, shares in Taiwan Semiconductor Manufacturing slipped 4 percent. GM extended production cuts in North America amid the chip shortage.

Africa

- South African President Ramaphosa confirmed that he will testify before a judicial commission investigating corruption during his predecessor's tenure.
- Ethiopia Human Rights Commission published a report finding that Eritrean troops killed at least 100 civilians during involvement in the Tigray conflict.
- The Kenyan government gave the UN High Commissioner for Human Rights two weeks to provide a roadmap for the closure of the Dadaab and Kukuma refugee camps. The two camps were established in 1992 and are two of the largest refugee camps in the world.
- In **Rwanda**, Paul Rusesabagina, the hero of the hit movie "Hotel Rwanda," refused Wednesday to participate in his trial, as an American citizen testified that he had financed rebel activities against his government.

Asia

- North Korea launched two suspected ballistic missiles into the sea near Japan on Thursday, underscoring steady progress in its weapons program.
- Myanmar's military junta freed hundreds detained protesters.
- India identified several "variants of concern" in the country, including overseas strains and a "new double mutant" strain. India reported 53,419 new cases yesterday.
- **Taiwanese** authorities will begin implementing water restrictions, including in science parks, where semiconductors are produced, amid a historic drought.
- Facebook said that it had blocked a group of Chinese hackers using the app to surveil Uyghurs abroad.
- The Hong Kong government told some foreign consulates to stop accepting British National Overseas (BNO) passport that many Hong Kongers use to apply for working holiday visas in Europe, North America and parts of Asia. Hong Kong also started to mirror mainland China by not recognizing dual nationality and preventing foreign diplomats from visiting locals with foreign passports in detention.

Europe

- Consumer confidence in the **eurozone** jumped to its highest levels since last year.
- Russian President Putin signed a bill lifting age limits for his civilian appointees.
- German Chancellor Angela Merkel reversed a decision to close stores and ban church services over the Easter holiday weekend as public criticism mounts, trigger calls for a no confidence vote. Vienna and two other eastern Austrian regions will reinstate lockdowns over Easter. Helsinki, Finland proposed a stay-at-home order for the first time during the pandemic. Germany is considering options to temporarily ban overseas trips. UK Prime Minister Johnson hinted at UK-France travel restrictions. Poland surpassed 50,000 coronavirus deaths.
- Former Sarkozy minister Xavier Bertrand said he would run for president of France in 2022.

Middle East

- Following Israel's fourth election two years, veteran Prime Minister Netanyahu has an uncertain path to power via right-wing coalition that could newly include an Islamist party. His rivals have even slimmer chances of forming a coalition.
- Saudi Arabia's Crown Prince Mohammed bin Salman met with the Chinese foreign minister in the Kingdom to discuss bilateral relations and China's support for the Saudi peace initiative in Yemen.
- Acting Lebanese Prime Minister Diab floated the idea of "*reactivating*" the Lebanese cabinet, which resigned amid corruption and mismanagement allegations following the August Beirut port explosion, amid a protracted stalemate over a new cabinet.
- Jordanian riot police on Wednesday broke up protests in Amman and other cities called to mark the 10th anniversary of Arab Spring pro-democracy demonstrations.
- The Biden administration wants to keep **US** troops in **Afghanistan** past a May 1 deadline and is seeking a deal in which the Taliban would allow a US counter-terrorism force to remain as they confront their Islamic State foes.

Americas

- Several **Caribbean island nations** called on the **US** to share vaccines with the "*third border*."
- **Argentina** withdrew from the "Lima Group," a multilateral group of 12 of Latin American countries established in 2017 to address the crisis in **Venezuela**, saying the policy of isolating Maduro has "achieved nothing."
- The Red Cross reported that violence against civilians in **Colombia** worsened in 2020.
- **Peru** is investigating new allegations of 'VIP' preferential access for COVID-19 vaccines in a hard-hit region of the Amazon, just weeks after prosecutors said hundreds of top officials elsewhere in the Andean nation had received shots before they were available to the public.
- **Canada** is expecting enough COVID-19 vaccine doses to double its supply by the end of next week to help ramp up a slow vaccination program.



Americas

Brazil surpassed 300,000 coronavirus deaths and reported a record high of 90,564 new cases yesterday; Brazil now has the highest rate of new infections and deaths in the world. Brazil's new health minister pledged to increase vaccinations to 1 million per day.

Americas: US

- Nationally, 85.5 million people have received one or more vaccine doses, 25.7 percent of the total population. The US has surpassed the milestone of 30 million virus infections. Cases rose by 4 percent nationwide over the past week with states such as Michigan, Colorado and Connecticut all reporting spikes of more than 30 percent, New York surpassed 1.8 million infection after reporting a backlog of cases.
- President Biden named Vice President Harris to oversee efforts to stem the flow of migrants at the southern border. Yesterday, 14 US states sued the Biden White House over his pause on new oil and gas leasing on federal lands and waters. Next week, Biden will unveil his multitrillion infrastructure plan in Pittsburgh.
- Attorneys general of 12 states called on Facebook and Twitter to do more to curb the spread of vaccine misinformation on the platforms.

Israeli Elections: Political Deadlock, Again

With 90 percent of the votes counted, it seems Israel's elections on March 23, the fourth round in less than two years, have not broken the deadlock between the "pro-Netanyahu" bloc and the "anti-Netanyahu" bloc. There are several possible scenarios for the formation of a governing coalition, yet the most probable option is a fifth election in the summer of 2021.

No clear winner

With 90 percent of the votes counted, it seems Israel's elections on March 23, the fourth round in less than two years, have not broken the deadlock between the "pro-Netanyahu" bloc and the "anti-Netanyahu" bloc. With a 67.2 percent voter turnout, the country is split down the middle, and while issues such as COVID-19, the economy, the religious-secular divide and the Jewish-Arab divide are a concern to voters, election cycle after election cycle have become referendums on Netanyahu's continued leadership.

Final official results are expected the morning of Friday March 26, and so far, no bloc has a clear path to a 61-seat majority in the Knesset, which is necessary for the formation of a coalition and government. There are several possible scenarios for the formation

of a governing coalition, yet the most probable option is a fifth election in the summer of 2021.

The "pro-Netanyahu" bloc

In the "pro-Netanyahu" bloc, the Prime Minister's party, Likud, won the most votes and is currently forecasted to win 30 seats (down from 36 in the outgoing Knesset). Its main allies, the Ultra-Orthodox parties Shas and UTJ, have 16 seats combined, and the radical Religious Zionist Party, which Netanyahu campaigned hard to push across the 3.25 percent threshold, won 6 seats. Together these parties have 52 seats. The Yamina Party, led by former Defense Minister Naftali Bennett, which received 7 seats, has been careful throughout the campaign not to side with either bloc, but there is a greater chance it

will support Netanyahu rather than those opposing the Prime Minister. Still, even with Yamina, Netanyahu is two short of the magic number of 61.

The "anti-Netanyahu" bloc

The bloc is made up of parties on the right, center and left, all with very different agendas, but united by their desire to bring an end to the Prme Minister's rule. The biggest party in the bloc, Yair Lapid's Yesh Atid Party, won 18 seats. Defense Minister Benny Gantz's Blue and White Party surprised with an unexpectedly high 8 seats. The Labor Party, led by MK Merav Michaeli, was resurrected, gaining 7 seats. Gideon Saar's New Hope Party disappointed with only 6 seats, and Avigdor Liberman's Israel Betenu Party reached 6 seats as well. The left-leaning Meretz Party won 5 seats, and the Arab Joint List received only 6 seats (down from 15 in the outgoing Knesset). Together, these parties have 56 seats, but it is certainly not a cohesive bloc.

MK Abbas the "kingmaker?"

Ahead of the elections, political analysts were in consensus that Naftali Bennett and his Yamina Party would be the "kingmakers," with the ability to hand the victory to one of the blocs. Tuesday's results, however, have somewhat marginalized Bennett's role. Surprisingly, the party which has emerged as a possible kingmaker is the Islamist Ra'am Party, led by MK Mansour Abbas, which broke away from the Arab Joint List, crossed the electoral threshold and reached 5 seats. MK Abbas left the Joint List earlier this year, presenting a new pragmatic Arab position of cooperation with Israeli government institutions and political parties for the sake of improving the daily lives of Israel's Arab citizens. During the campaign, Abbas did not rule out the possibility of supporting a Netanyahu-led coalition, in return for government budgets and appointments. At present, both Netanyahu and Lapid are courting Abbas, and are trying to convince him to align with their bloc or provide a "safety net" for a future coalition from the outside. On the other hand, a senior Ra'am official stated after the elections that Ra'am "will not sit [in a coalition] with racists who threaten us, who threaten al-Aqsa," referencing the Religious Zionist Party.

Netanyahu looks for defectors

Another option for Netanyahu and his bloc may be to try and draw defectors from parties in the "anti-Netanyahu" bloc. In a wink and a

nod to potential defectors, the Prime Minister spoke on March 24 about the issues and values which are important to all right-wing voters, sending a message to politicians in Gantz's, Liberman's and Saar's parties with a right-wing orientation that he would happily welcome them. At present, however, no politician in the anti-Netanyahu bloc has indicated they would cross over.

Fifth elections are the most likely option

The leaders of the parties in the "anti-Netanyahu" bloc will attempt in the coming days to keep the bloc united, as much as possible. While fifth elections being perhaps the bloc's best way out of the current deadlock, a majority in the Knesset will enable the bloc to elect a new Knesset Speaker and committee chairpersons and also pass legislation that prohibits a prime minister under criminal indictments, such as Netanyahu, to run for future elections. It is important to remember that Benny Gantz has a particular interest in going to fifth elections. The legislation passed in May 2020 creating the role of Alternate Prime Minister is still in place. The law states that Gantz will become a full-fledged prime minister in November 2021. As long as Gantz remains a Member of Knesset the law still applies to him, hence his interest in fifth elections.



As of 2100 hours US EDT on March 24, 2021




Confirmed Cases (New)




